Performance

Based on transaction prices, the fund's return was 0.02%.

In December, the Healthy Living Fund performed negatively. It underperformed versus the global market, but outperformed its internal benchmark. The Healthy Lifestyles cluster generated positive returns, while the three other clusters performed negatively. At the individual stock level, the biggest positive contributor in the quarter was pharma company AstraZeneca. The company reported solid and better-than-expected growth in the third quarter of 2025, driven by its oncology franchise. The second best-performing stock was Thermo Fisher Scientific. The company reported numbers slightly ahead of expectations in October, but predominantly benefited from positive market sentiment after the MFN deal between Pfizer and the Trump administration. The largest negative contribution came from the protein shake manufacturer Belling Brands. The company provided a disappointing growth outlook for next year and also reduced its long-term growth target.

Market development

In December, global markets generated positive returns (in USD), led by the financials and materials sectors. The industrials and consumer discretionary sectors also outperformed the market, while other sectors, including the information technology, healthcare, consumer staples and communication services sectors underperformed. The rotation toward defensives seen in November lost steam, and both healthcare and consumer staples generated negative returns. At the end of December, nine additional "Most Favored Nation" (MFN) agreements were announced between the Trump administration and leading biopharma firms, bringing the total to 14 deals out of 17 companies in scope. These agreements reflect a pragmatic strategy by manufacturers to meet policy requirements while preserving long-term profitability and securing exemptions from tariffs on imported pharmaceuticals. Consumer sentiment in the US remained subdued in December, despite the University of Michigan's Consumer Sentiment Survey showing a slight improvement among low income consumers.

Expectation of fund manager

The risks to economic growth have increased due to inflation, higher interest rates, geopolitical tensions and the economic imbalances in China. In addition, the tariff announcements by the new US president have created uncertainty in the business environment, which may reduce corporate investments and consumer confidence going forward. It will therefore be even more important to focus on solid business fundamentals, pricing power and quality. We remain constructive on the mid to long-term potential of the equity markets and are making use of current market conditions to further solidify our positions in companies that have very strong long-term business prospects. The pandemic has accelerated changes necessary to build more robust and sustainable economies. It has also made individuals more inclined to adopt a healthier lifestyle. The Healthy Living portfolio of sustainable companies is well positioned to benefit from these changes in the longer run.

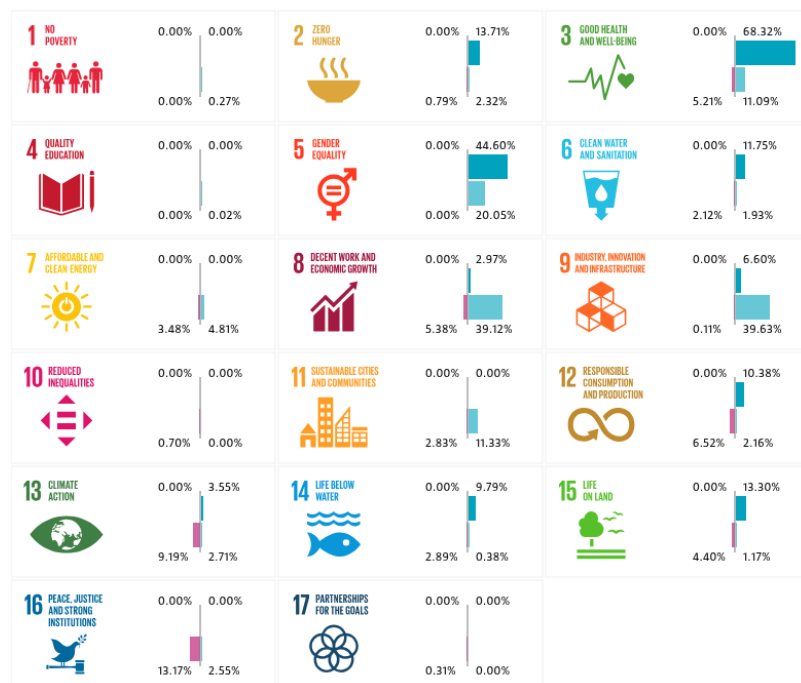
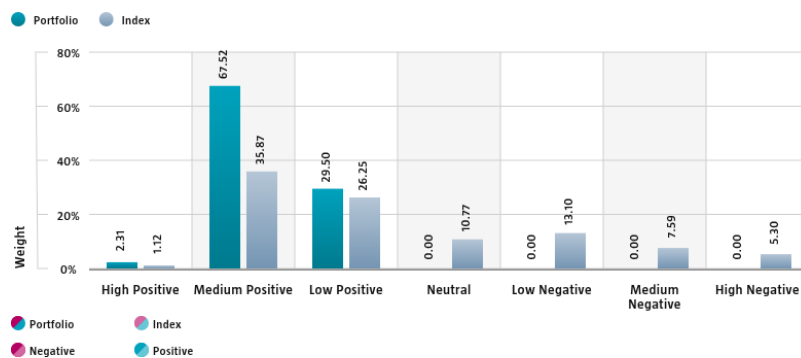
Sustainability

The fund's sustainable investment objective is to promote good health and well-being and contributing to an efficient healthcare system. Healthy living and sustainability considerations are incorporated in the investment process by the means of a target universe definition, exclusions, ESG integration, and voting. The fund only invests in companies that have a significant thematic fit as per Robeco's thematic universe methodology. Through screening on both Robeco's internally developed SDG Framework and Robeco's exclusion policy, the fund does not invest in issuers that have a negative impact on the SDGs, are in breach of international norms or where products have been deemed controversial. Financially material ESG factors are integrated in the bottom-up fundamental investment analysis to assess existing and potential ESG risks and opportunities. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. This results in a 7-step scale from -3 to +3. For comparison, index figures are provided alongside that of the portfolio. Only holdings mapped as corporates are included in the figures.

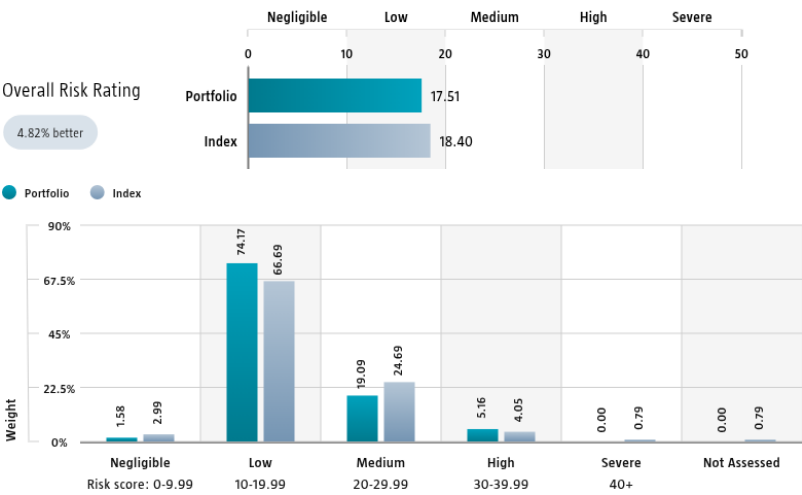

Sustainalytics ESG Risk Rating

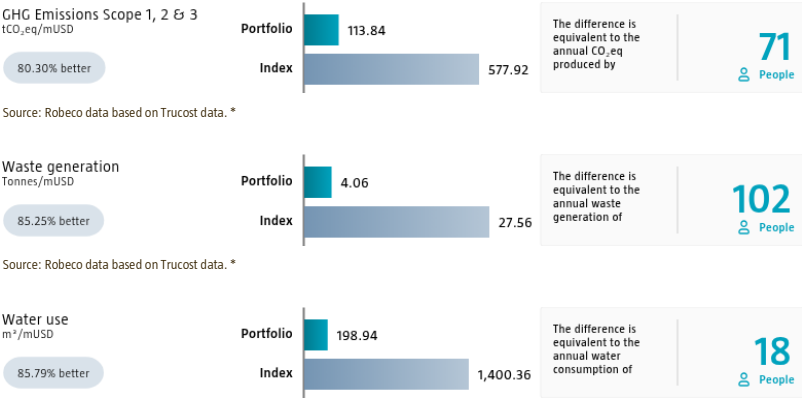

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. 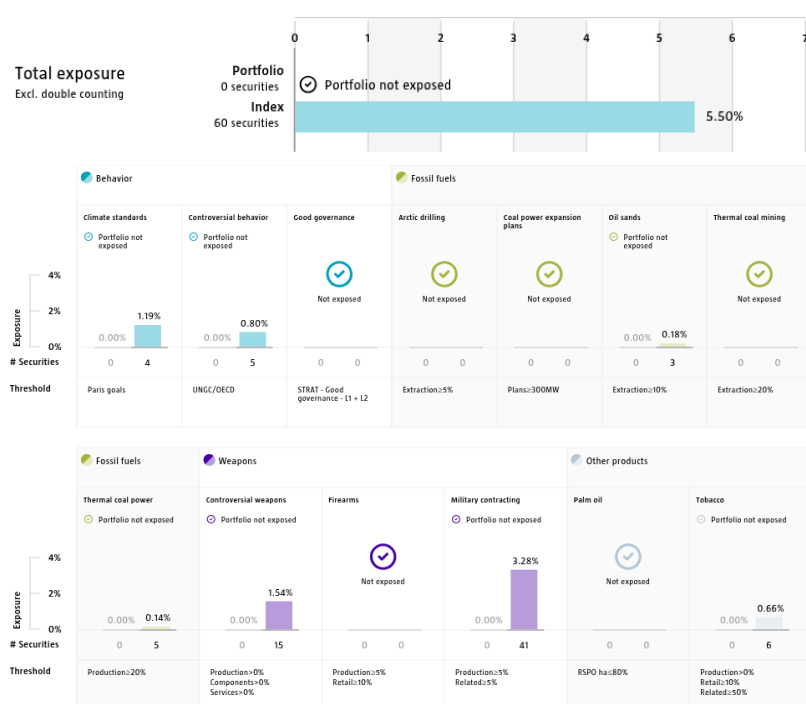

The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
