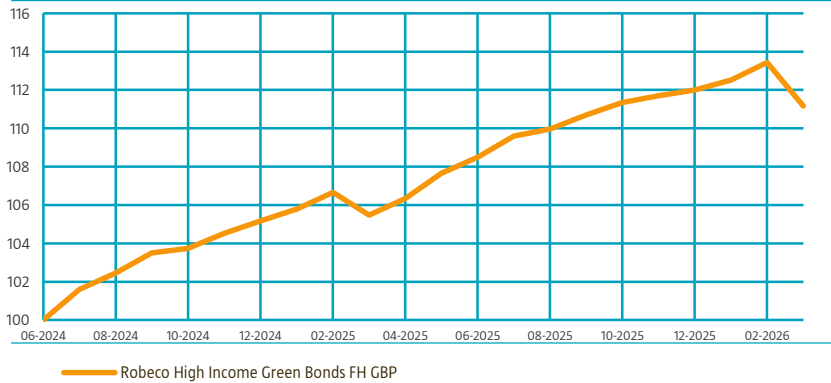

### Performance

Based on transaction prices, the fund's return was -2.00%.

The portfolio recorded a negative total monthly return, gross of fees, as market spreads were trending wider over the month. The rates impact was negative due to bear steepeners across different currencies. We have increased the liquidity of the portfolio and reduced risk slightly amid the geopolitical volatility. The largest negative contributions came from EUR-denominated paper, as EUR generally underperformed versus USD and EM risk. Large negative contributors were: Volkswagen hybrids, Heimstaden Bostad, and First Abu Dhabi Bank.

### Market development

March saw the sharpest cross-asset shock since 2022, as US and allied airstrikes on Iran triggered broad repricing across rates, commodities, and credit. Brent surged 63% to approximately USD 118/bbl, reigniting stagflation fears and forcing a reassessment of central bank paths. 10-year US Treasury yields rose 38 bps to 4.32%, their largest monthly move since December 2024, while German Bund yields climbed 36 bps to above 3% for the first time since 2011. Fed cuts were priced out for 2026 and ECB hikes increasingly priced in, creating a challenging duration backdrop. Credit spreads widened but remained resilient given the macro shock. Global IG ended 8 bps higher at 93 bps, while euro IG widened 14 bps to 97 bps, reflecting higher energy sensitivity. Dispersion increased, with energy and infrastructure outperforming, while software weakened and BDC-linked paper widened amid private credit stress. Primary markets remained open, though concessions increased, with heavy hyperscaler and M&A supply weighing on secondary technicals.

### Expectation of fund manager

The macro backdrop entering Q2 is shaped by a stagflationary impulse not fully priced in by markets. With Brent near USD 110/bbl, the inflation-growth trade-off has deteriorated sharply, particularly in Europe and Asia where energy dependence is highest. The Fed retains an easing bias but rate cuts are largely priced out for 2026, while the ECB faces a tougher trade-off, with hikes a tail risk if disruption proves persistent. Against this backdrop, credit spreads remain tight and offer limited compensation for a multi-month Hormuz disruption, rising private credit stress, and AI-driven business model pressure in software. We keep portfolio beta close to neutral and do not chase spreads. Alpha is driven by issuer selection: we favor HALO exposures in energy infrastructure, metals, and critical networks, and remain constructive on well-capitalized European banks. We avoid BDCs and private-credit-linked insurers, stay underweight in software in high yield, and prefer BB over B in EM as dispersion widens.

### Top 10 largest positions

The top ten of our positions consists of a combination of high-spread and longer-duration bonds with many being high-yield-rated or subordinated credits. Our subordinated positions are concentrated in corporate hybrids and Tier-2 financials.

### Sector allocation

The fund invests in investment grade credit, high yield and emerging markets. The core exposure is in the BBB and BB-rated part of the market. Asia. The fund invests in green, social, and sustainability bonds. All bonds must first pass our proprietary 5-step eligibility screening process. In this process we check for alignment with the green bond principles, and review the use of proceeds in relation to the EU taxonomy on green projects and activities. We check for reporting on the allocation of proceeds and environmental impact. In addition, we evaluate the issuer's strategy on sustainability, and check for social safeguards and any controversial behavior.

### Currency denomination allocation

### Duration allocation

We increased duration in March in the EUR 10-year bucket, as price hikes started to be priced into the market due to the Iran-US conflict and in extension a potential stagflation scenario. The shorter part of yield curves offers attractive yields. We remain cautious on the longer end of yield curves, due to inflation concerns and fiscal deficits. Overall duration is 3.95 years, with a mix across EUR and USD. All positions are spread across the positions in 1 to 3-year, 3 to 5-year, 5 to 7-year, and 7 to 10-year buckets.

### Rating allocation

The majority of the fund is invested in bonds with BBB and BB credit ratings. There is some investment in the single-A or higher category, reflecting our cautious views on credit markets currently. If spreads would widen significantly from here, investment in the BB category is likely to increase.

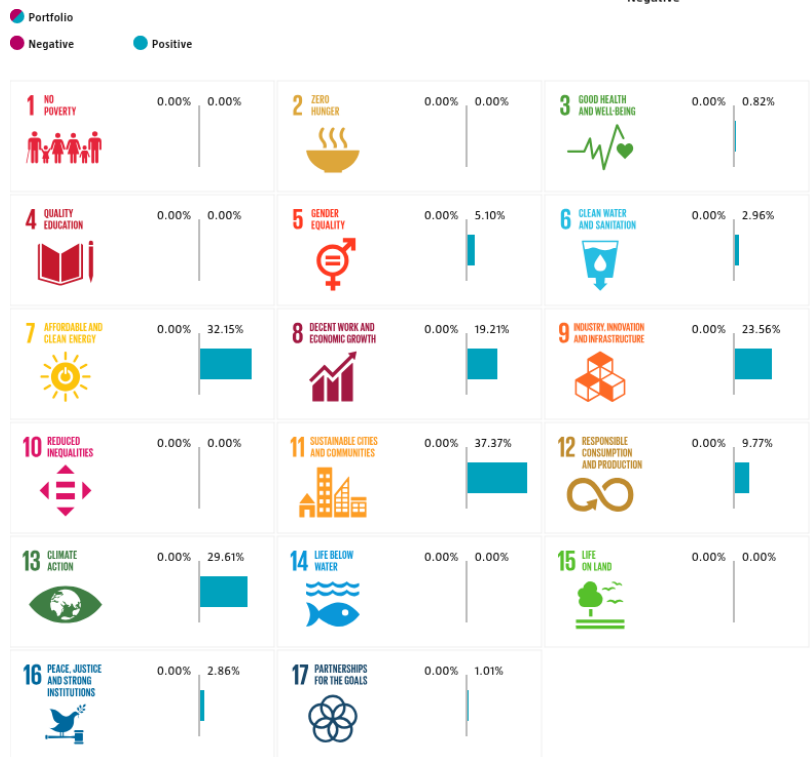
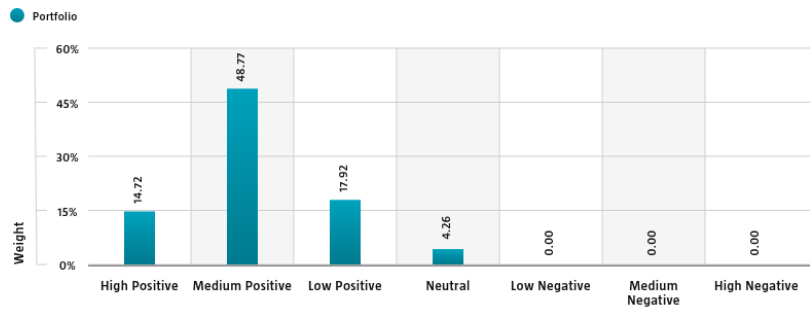
### Sustainability

The fund's sustainable investment objective is to invest in green bonds. Green bonds are bonds that are recognized as such by external sources and which proceeds are used to finance or refinance in part or in full new and/or existing environmentally-friendly projects. The green bond selection is based on external data or an internally developed five-step Green bond framework. The five-step framework states that the issuer's green bond framework must be aligned with market standards related to green bonds such as such as the ICMA Green Bond Principles. Next, the allocation of the investment proceeds must contribute to at least one of the six objectives of the EU Taxonomy nor do any significant harm to the other five. The six objectives of the EU Taxonomy Regulation are climate change mitigation and adaptation, sustainable use and protection of water and marine resources, the transition to a circular economy, pollution prevention and control, and the protection of healthy ecosystems. The third and fourth steps require that the bond issuer reports on the use of proceeds and that the issuance aligns with the wider sustainability strategy of the issuer. The fifth and last step states that the issuer must respect international norms related to conduct such as international labor rights, human rights and the UN Global Compact. In addition, the investment process also takes into account exclusions following Robeco's exclusion policy and integrates financially material ESG factors in the bottom-up issuer analysis to assess the impact on the issuer's fundamentals.

### SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. This results in a 7-step scale from -3 to +3. For comparison, index figures are provided alongside that of the portfolio. Only holdings mapped as corporates are included in the figures.

### Sustainalytics ESG Risk Rating

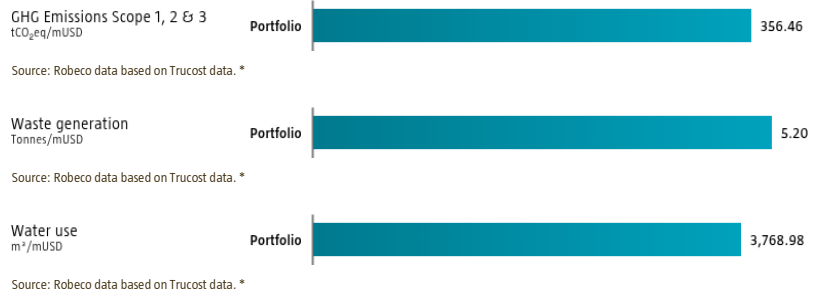

### Environmental Footprint

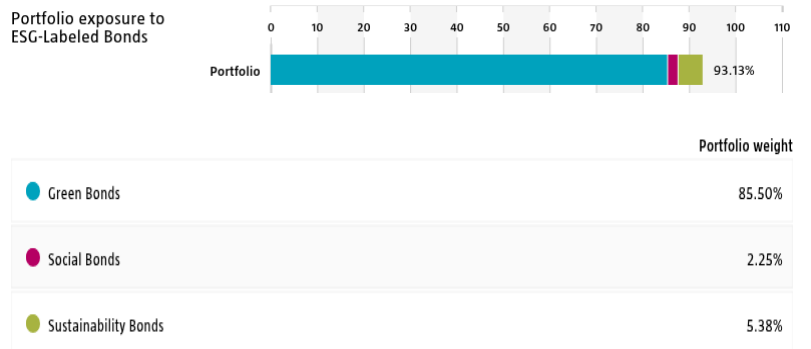
Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. ### Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
