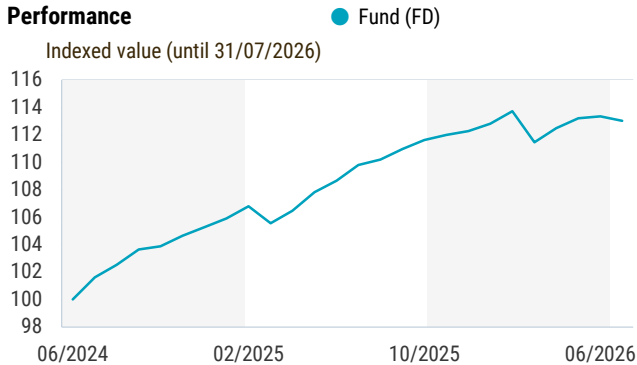

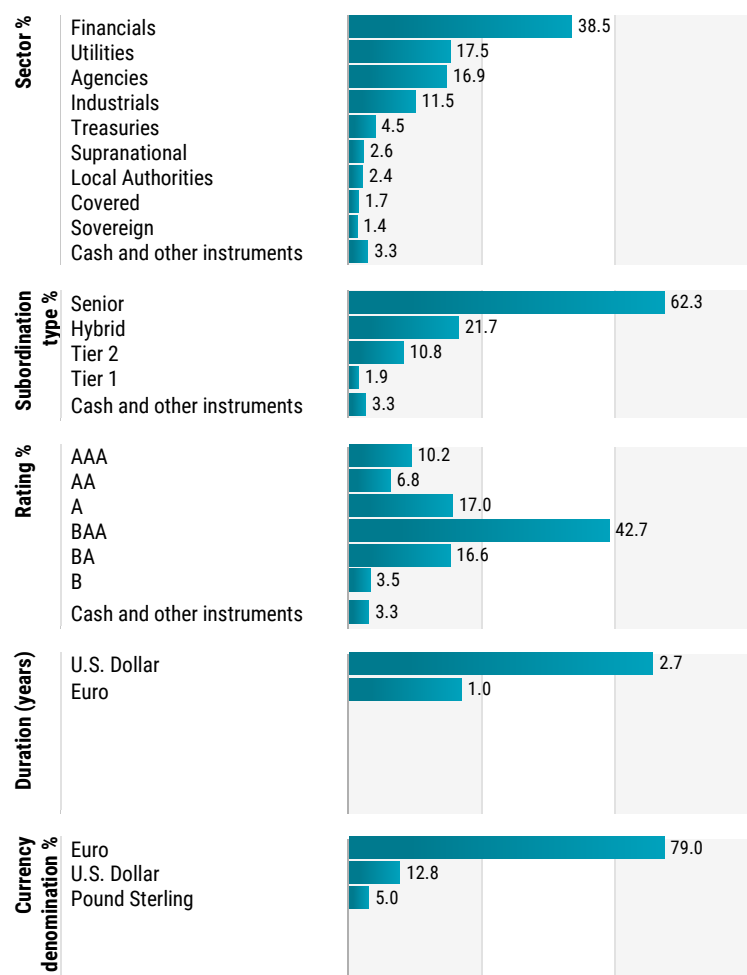

Performance commentary

Based on transaction prices, the fund's return was -0.29%.

The portfolio recorded a negative monthly return, gross of fees. The majority of the negative contribution came from duration, which was mainly driven by cash yields. US and EUR duration exposure contributed negatively. Contribution from credit was positive. Positions with the highest positive contributions were IHO Verwaltung, Alliander NV, and Adani Green. The biggest negative contributor were newly issued bonds of MTR Corp.

Market development

July reversed much of June's calm as the US-Iran truce broke down, with both sides resuming strikes and Brent crude rebounding from USD 71/bbl to above USD 100 mid-month before easing to around USD 90, up more than 20% over the month. The renewed energy shock revived inflationary concerns across markets. Equities were led lower by a sharp unwind in AI-related and chip stocks, with the Philadelphia Semiconductor Index posting its worst month since 2008 and South Korea's KOSPI slumping despite a late rebound. US large cap indices proved more resilient as investors rotated into non-tech areas, while European equities outperformed, helped by firmer Q2 growth. Government bonds sold off as inflation fears drove yields to multi-year highs, even as the Fed, ECB, BoE and BoJ all held rates steady. The Fed's decision offered little clarity and steepened the US curve, lifting the 30-year US Treasury yield to a post-2007 high, while 10-year Bund yields reached their highest level since 2011. Credit posted negative total returns, driven almost entirely by the rise in underlying government yields rather than spreads, which stayed broadly contained across both US and European markets.

Expectation of fund manager

The global economic outlook has improved following the US-Iran agreement and the expected reopening of the Strait of Hormuz, which has significantly reduced geopolitical risks. Economic growth remains resilient, supported by ongoing technology investment and fiscal stimulus measures, although inflation continues to pose a challenge for policymakers. In this environment, we expect higher-carry assets, such as subordinated debt and high yield bonds, to perform well. However, despite the more constructive backdrop, tight credit spreads call for a selective investment approach with a focus on shorter spread-duration instruments. While the inflationary impact of higher oil prices is likely to fade, inflation remains above central bank targets amid continued economic strength. As a result, we maintain a cautious duration stance, favoring intermediate maturities where valuations appear more balanced and exposure to interest-rate risk is less pronounced.

Top 10 largest holdings

The top ten of our positions consists of a combination of high-spread and longer-duration bonds with many being high-yield-rated or subordinated credits. Our subordinated positions are concentrated in corporate hybrids and Tier-2 financials.

Sector allocation

The fund invests in investment grade credit, high yield and emerging markets. The core exposure is in the BBB and BB-rated part of the market. The fund invests in green, social, and sustainability bonds. All bonds must first pass our proprietary 5-step eligibility screening process. In this process we check for alignment with the green bond principles, and review the use of proceeds in relation to the EU taxonomy on green projects and activities. We check for reporting on the allocation of proceeds and environmental impact. In addition, we evaluate the issuer's strategy on sustainability, and check for social safeguards and any controversial behavior.

Currency denomination allocation

The currency exposure is hedged back to the fund's base currency (EUR). The majority of the fund is invested in EUR and USD-denominated bonds. Positioning across currency is a reflection of bottom-up issuer selection and top-down views.

Duration allocation

In July, small changes were made to the duration position of the fund. The fund still has a relative short duration position.

Rating allocation

The majority of the fund is invested in bonds with BBB and BB credit ratings. There is some investment in the single-A or higher category, reflecting our cautious views on credit markets currently. If spreads would widen significantly from here, investment in the BB category is likely to increase.

Subordination allocation

The fund holds a significant allocation to subordinated credits: we aim for 30%, which consists of corporate hybrids and subordinated financials, including Tier-2 and additional Tier-1 instruments.

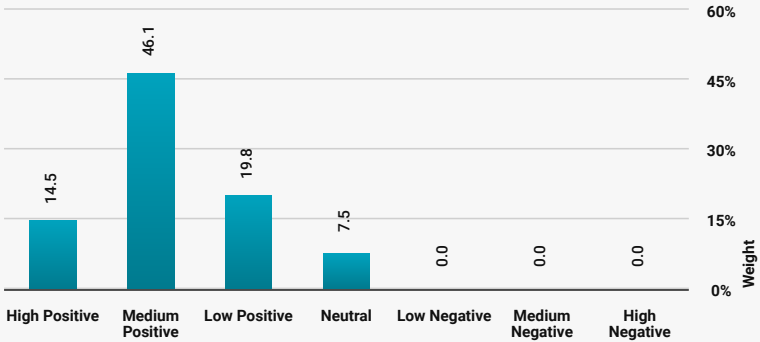

SDG Impact Alignment¹

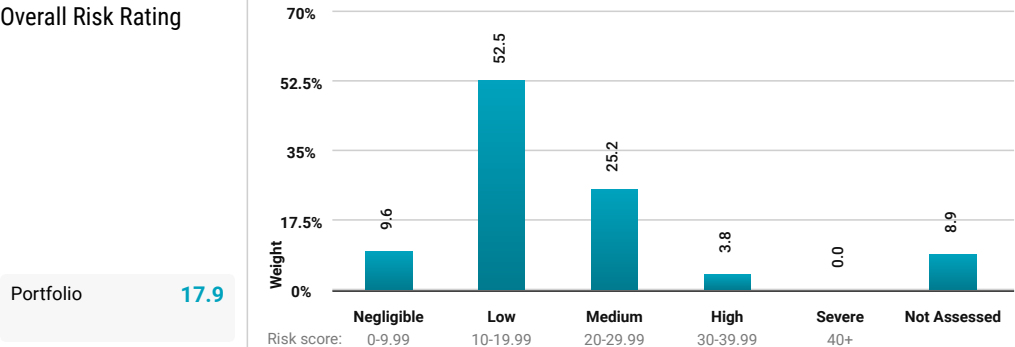

Sustainalytics ESG Risk Rating²

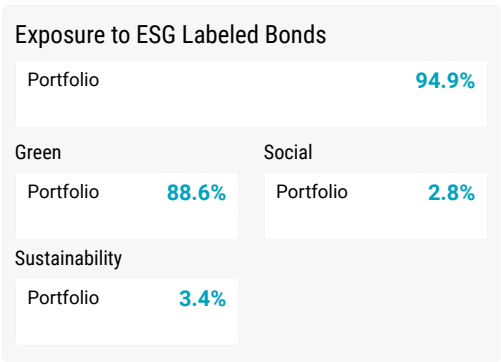

Overall Risk Rating



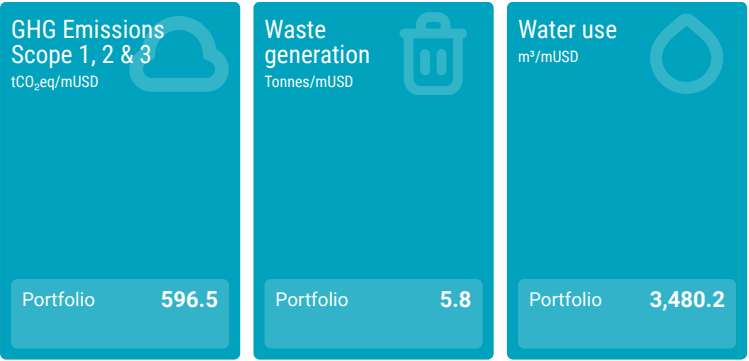
ESG Labeled Bonds³

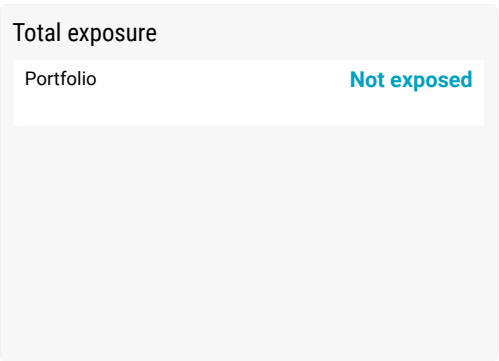

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Only holdings mapped as corporates are included in the figures.

3. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

4. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management is fully embedded in the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes.
