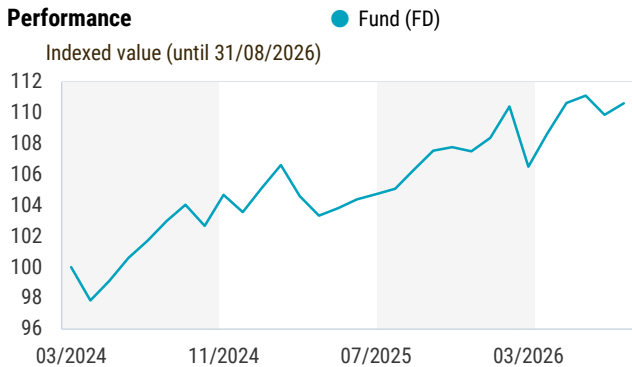

Robeco High Income Allocation is an actively managed fund that invests in a mix of asset classes across the world. The fund's objective is to achieve long term capital growth whilst maintaining a consistent level of income. The fund has a relatively low risk profile and uses asset allocation strategies mainly investing directly in bonds and taking exposure to other asset classes such as equities. The asset allocation strategy is subject to investments and volatility restrictions. The portfolio management team can also use other investment instruments to enhance the riskreturn profile of the fund. Changes

On 15/3/2024, the fund absorbed Robeco Multi Asset Income. Performance commentary

Based on transaction prices, the fund's return was 0.70%.

The High Income Allocation Fund gained 0.9% during the month, modestly outperforming its benchmark, with year-to-date results remaining broadly aligned. Performance was supported by the portfolio's diversified exposure across equities, currencies and commodities. Asset allocation decisions contributed positively, particularly the overweight positions in US and emerging market equities. In contrast, stock selection detracted in both the fundamental and quantitative equity strategies. Within fixed income, returns were negatively affected by long positions in UK 2-year and 10-year government bonds and German 2-year bonds. Credit positioning also weighed slightly on performance through an overweight in Europe versus the US, an underweight in energy and an overweight in insurance. These headwinds were more than offset by strong contributions from subordinated debt and lower-rated credit, especially BB and B bonds. Currency positioning added value, led by gains from the South Korean won, alongside positive contributions from the Swiss franc, Norwegian krone and Turkish lira. Gold also supported returns further.

Market development

Government bond yields remained a key market focus in August, with much of the debate centered on developments in the United States. Investors questioned whether higher yields reflected resilient growth and persistent inflation or growing concerns about fiscal sustainability and policy credibility. While discussion focused on the United States, rising yields were evident elsewhere, supported by firmer growth and sticky inflation across major economies. Economic activity and corporate earnings exceeded expectations, supporting risk assets globally. Equity markets responded to the growth backdrop. Emerging markets were among the performers, as concerns around semiconductors and artificial intelligence eased. European equities lagged, despite stronger data, due to their lower exposure to artificial intelligence beneficiaries and sensitivity to rising energy prices linked to the Middle East tensions. Brent oil climbed above ninety dollars during the month, reinforcing concerns. Despite questions around United States policy and debt dynamics, economic fundamentals remained supportive for risk assets and sentiment.

Expectation of fund manager

The economy is expected to remain hot, with productivity-led growth and inflation staying elevated but contained. This environment should support equities, because nominal earnings growth can outweigh pressure from higher discount rates, provided inflation does not move persistently above 4%. The Federal Reserve is expected to sound hawkish while remaining on hold, keeping concerns about currency debasement alive amid large deficits and Treasury intervention. This supports a softer dollar, gold, and pressure on long-term US government bonds. The portfolio favors equities, including emerging markets, and emerging-market debt, although US government bond yields could compete. Gold remains attractive as official-sector demand has resumed. Government bonds provide the clearest relative-value position: short US Treasuries and long UK Gilts, reflecting divergent fiscal settings. Tight credit spreads limit upside, making credit a funding source. Key risks are a hawkish Fed, weakening earnings revisions, broader inflation, equities and bonds selling together, and widening credit spreads.

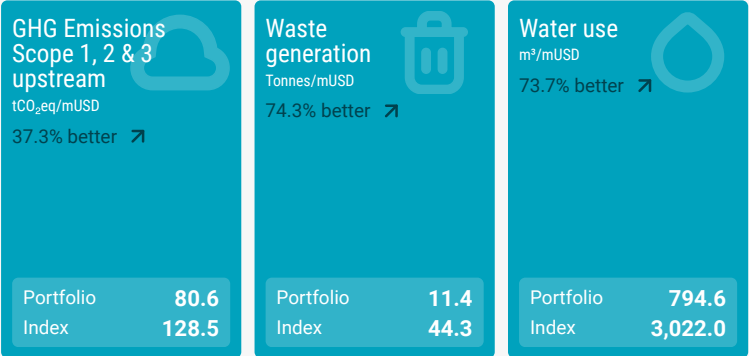

Environmental Footprint ²

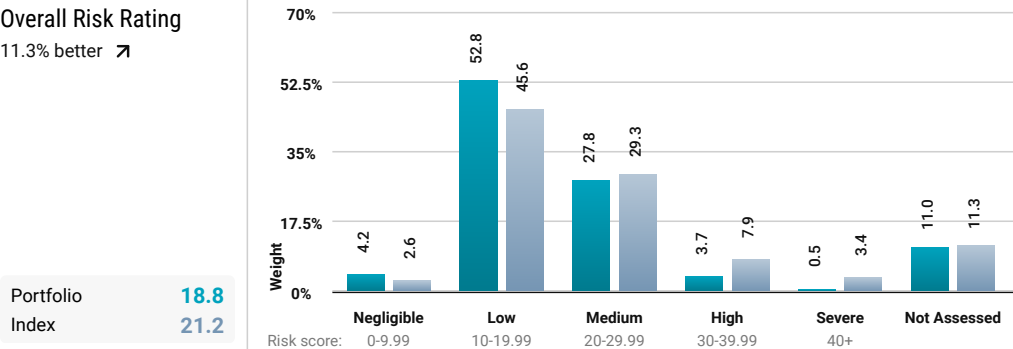

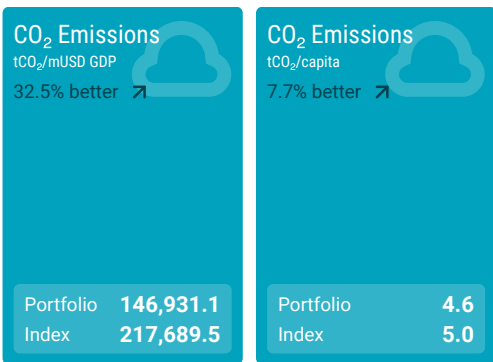

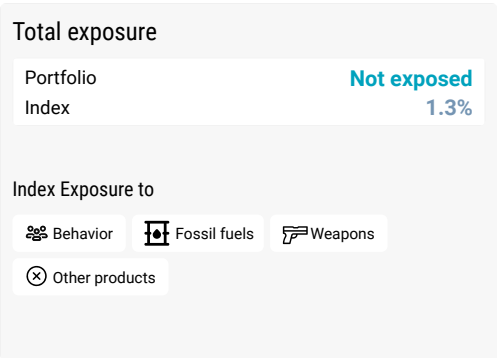

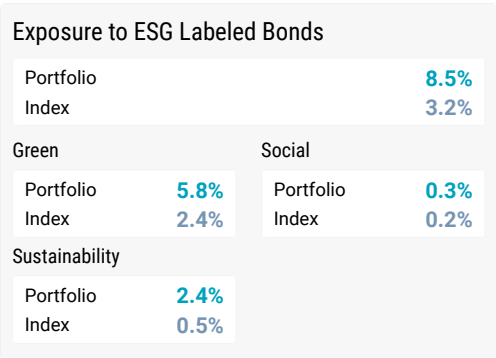

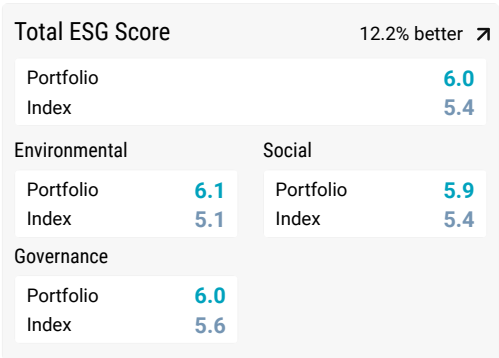
ESG Labeled Bonds ⁶

Reference

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

3. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Only holdings mapped as corporates are included in the figures.

4. Environmental Intensity

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Only holdings mapped as sovereign bonds are included in the figures.

5. Exclusions

6. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

7. Country Sustainability Ranking

The visual displays the portfolio's scores following Robeco's Country Sustainability Ranking methodology. These are calculated using the portfolio components' weights and respective country's scores. The scores includes considerations of more than 50 separate indicators, each capturing a unique sustainability feature across environmental, social and governance dimensions at the country level. Only holdings mapped as sovereign bonds are included in the figures.

8. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated into the investment process to ensure that positions meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes. Each year investors pay income tax on the value of their net assets as at 1 January if and inasmuch as such net assets exceed the investor's tax-free allowance.
