Performance commentary

Based on transaction prices, the fund's return was -1.08%.

Based on net asset value, the fund outperformed the benchmark by 1.3%. Portfolio performance during the month of August was primarily driven by better stock selection in consumer discretionary, financials, healthcare and staples, offsetting the weakness in other areas. Overweight in materials and lower allocation to industrials (mainly defense and power equipment manufacturers) detracted from performance during the month. At the stock level, the key contributors to performance were One 97 Communications (Paytm), Sundram Fasteners, KPR Mill, Kotak Mahindra Bank, PB Fintech, IPCA Laboratories and Divi's Laboratories, which positively contributed to the performance. Our overweight positions in HDFC Bank, Gujarat Energy, Balkrishna Industries and Hindustan Unilever were among the detractors during the month. We continue to be encouraged by earnings performance from our portfolio companies in FY27Q1 and expect the earnings-acceleration-led improvement to play out going forward.

Market development

The MSCI India (MXIN) declined 0.4% in August, underperforming versus MSCI Emerging Markets and MSCI Asia Pacific ex-Japan, although it continued to outperform both benchmarks over the trailing three-month period. The correction was driven by elevated crude oil prices, higher global yields and liquidity absorption from a record primary market fundraising calendar. Nevertheless, sentiment remained supported by a stronger-than-expected FY27Q1 earnings season, resilient domestic demand and improving foreign investor participation. FY27Q1 results highlighted broad-based earnings strength, with revenue and PAT growth of 19% and 16% YoY, while earnings beats outnumbered misses. Management commentary remained constructive despite a challenging global backdrop. India's growth momentum remained robust, supported by GDP growth, industrial production and inflation within the RBI's target range. Strong exports, healthy credit growth and consumer demand continued to underpin the domestic growth cycle. Industrials, materials and IT outperformed in August, while utilities lagged. FIIs remained net buyers, and the MSCI India trades below its 5-year average valuation multiple.

Expectation of fund manager

Global growth remains uneven, with investors continuing to monitor trade developments, geopolitical events and the path of monetary policy across major economies. Although policy and trade-related uncertainties persist, external conditions appear less challenging than earlier in the year. Against this backdrop, India's resilient macroeconomic fundamentals, improving domestic demand momentum and earnings visibility provide a supportive environment for equities despite periodic global volatility. On the domestic front, India's macroeconomic backdrop remained resilient during August 2026, supported by economic activity, tax collections and a stable external position. Gross GST collections increased 14.8% YoY to INR 2.0 trillion, marking the third consecutive month of double-digit growth, driven partly by higher import-related collections and stable domestic collections. Real GDP growth stood at 7.8% YoY in FY27Q1 versus 6.9% a year earlier, supported by investment activity and export growth. Corporate earnings trends were also encouraging, with recent results suggesting improving earnings momentum across several sectors, aided by stable demand conditions and ongoing investments.

Top 10 largest holdings

During the month, Hindustan Unilever was replaced by Tech Mahindra in the top ten portfolio holdings.

Sector allocation

Overall fund positioning remains largely unchanged, though we have selectively recycled capital and are increasing exposure to businesses with improving earnings visibility while trimming less compelling positions. We remain overweight in sectors benefiting from earnings acceleration and industry consolidation, while avoiding areas facing negative earnings revisions and valuation pressure. Improving demand conditions and solid execution have supported select holdings in cement and consumer staples, with Q1 earnings exceeding expectations. Key overweights remain materials, consumer discretionary and consumer staples, where earnings momentum and growth continue to outperform peers. We also favor structural growth opportunities within export manufacturing, supported by market share gains, competitiveness, trade agreements and strong execution. As more trade treaties take effect through FY27, we expect chemicals and textiles to strengthen further. We continue to identify opportunities where the market underappreciates long-term earnings potential, while remaining underweight in expensive industrials, defense, power equipment and state-owned oil companies.

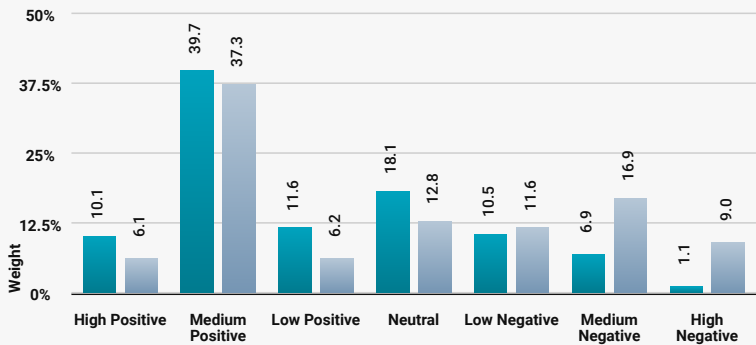

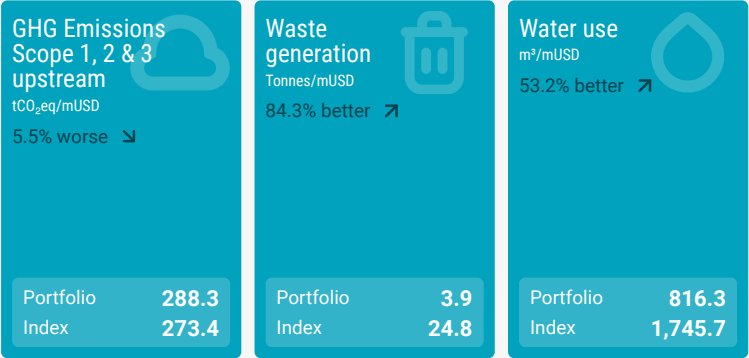
SDG Impact Alignment ¹

Environmental Footprint ²

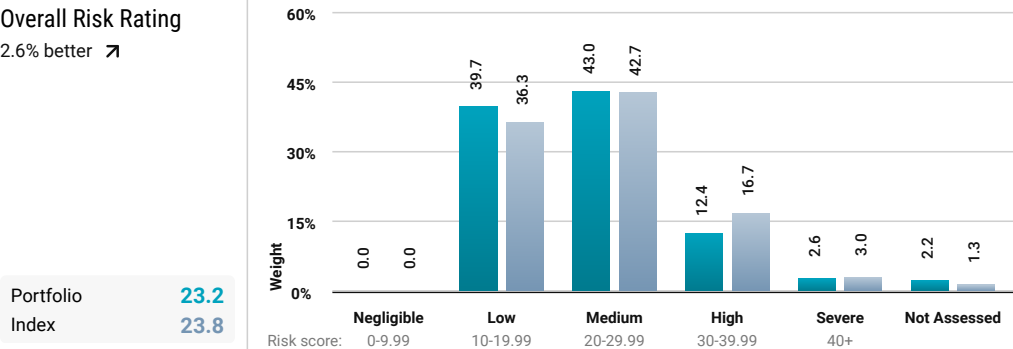

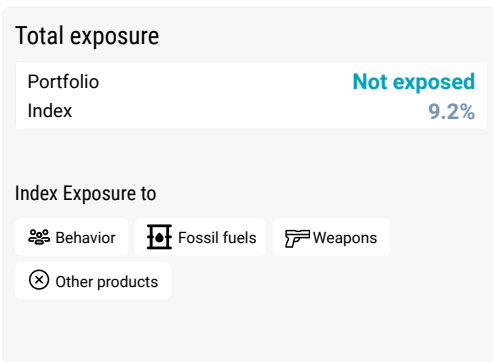

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
