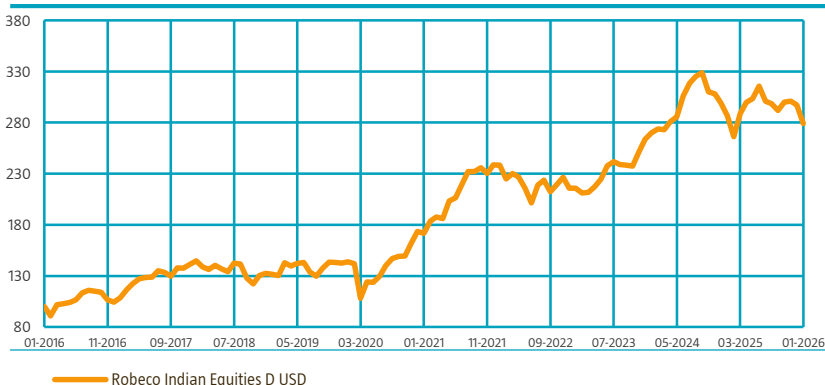

Performance

Based on transaction prices, the fund's return was -6.07%.

Based on net asset value, the fund outperformed the benchmark by 0.67%. Stock selection in IT & consumer staples impacted positively during the month, while stock selection in materials impacted negatively. Sector allocation in materials and energy impacted positively, while sector allocation in consumer discretionary and industrials impacted negatively during the month.

Market development

The MSCI India underperformed versus the MSCI EM Index and the MXAPJ by 13.6% and 12.8%, respectively, in January (USD). Following this underperformance, India's premium to the MXAPJ has compressed sharply to 46% (vs 60% 5-year average). At its peak, this premium was 92% in October 2022. Most high-frequency indicators across the automobile and rural sectors suggest powerful economic momentum heading into 2026, characterized by robust consumer demand and a structural recovery in rural India, led by rising real rural incomes. India's corporate cycle has reached a crucial inflection point, poised for a reversal. We see a high possibility of earnings upgrades in the December reporting season. The Indian rupee has appreciated following the trade deal announcement. The disconnect between equity prices and economic fundamentals offers investors a compelling narrative of long-term resilience. This is an opportunity to capture a durable earnings cycle at its inflection point.

Expectation of fund manager

The Indian economy is quietly reaccelerating, building a foundation for a powerful and durable corporate earnings cycle. Aggressive reflationary policy shifts and the recently concluded India-US trade deal have reignited business confidence which should buoy corporate earnings. The conclusion of the India-US trade deal effectively de-risks the India investment thesis for global investors. A year of consolidation has restored supportive valuations (in relative premium terms), offering the much-expected margin-of-safety entry point for investors seeking long-term growth. With record underpositioning leaving global funds sidelined, the combination of positive factors underlined earlier bode well for long-term investors looking for AI hedges and durable compounding returns.

Financially material ESG factors are integrated in the bottom-up investment analysis to assess existing and potential ESG risks and opportunities. In the stock selection the fund limits exposure to elevated sustainability risks. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

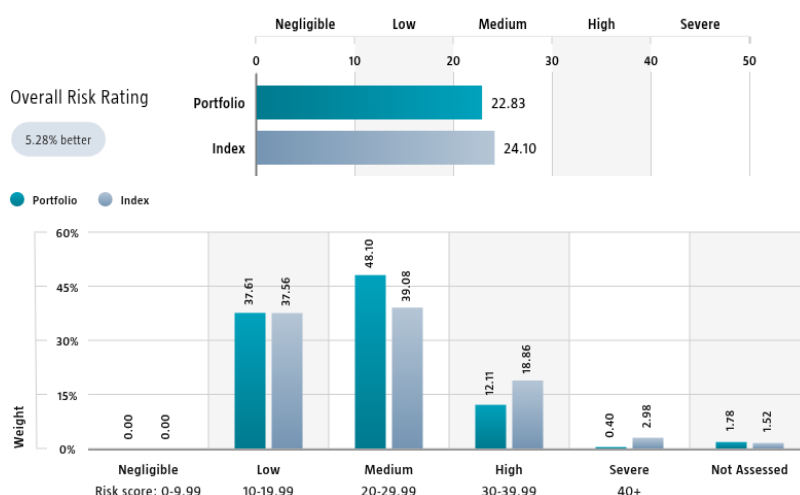

Sustainalytics ESG Risk Rating

The Portfolio Sustainalytics ESG Risk Rating chart displays the portfolio's ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. 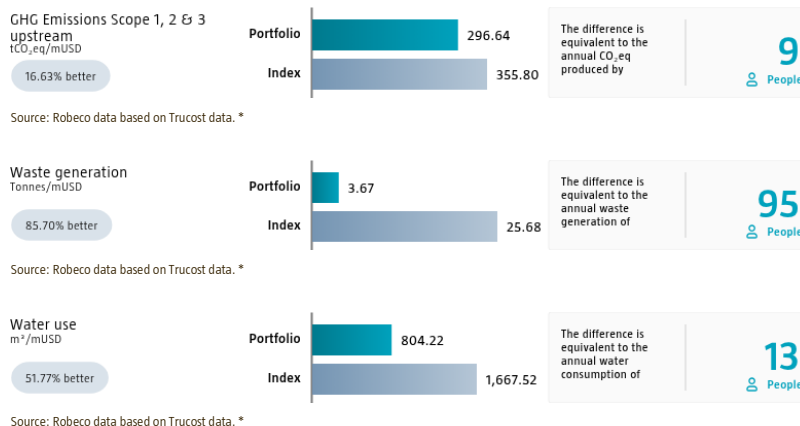

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

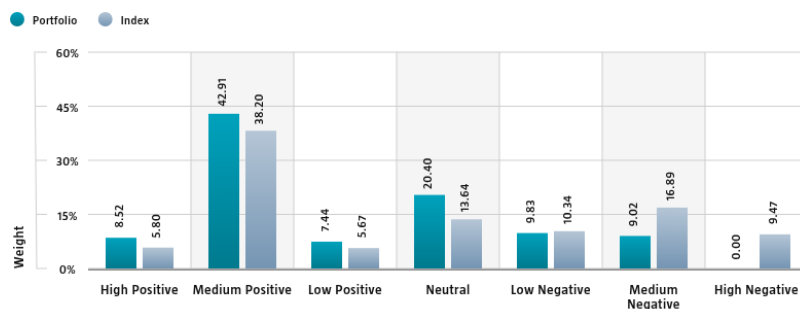

Engagement

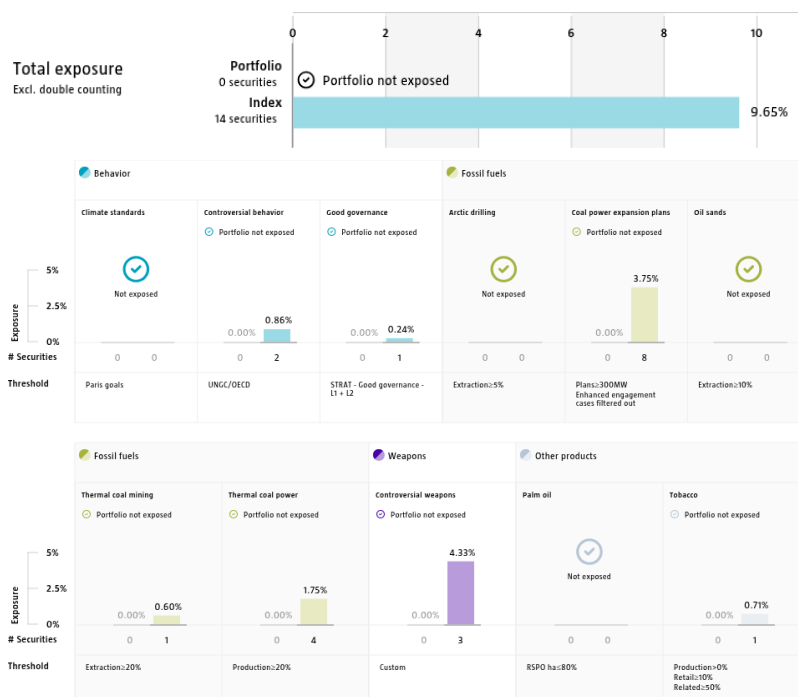
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The Asia-Pacific Equities investment team consists of five investment professionals with an average experience of 13 years, combining complementary skills and worldwide investment backgrounds. The team's portfolio managers place local insights into the context of a wider regional and global perspective. The experience of the Asia-Pacific Equities investment team is strengthened by the local expertise of the Indian Investment Advisor, Canara Robeco.

Fiscal product treatment
