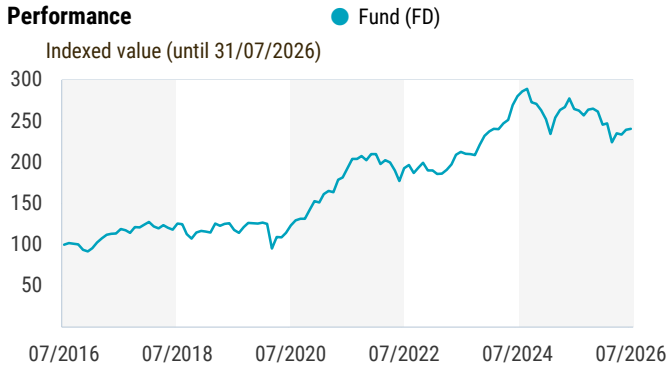

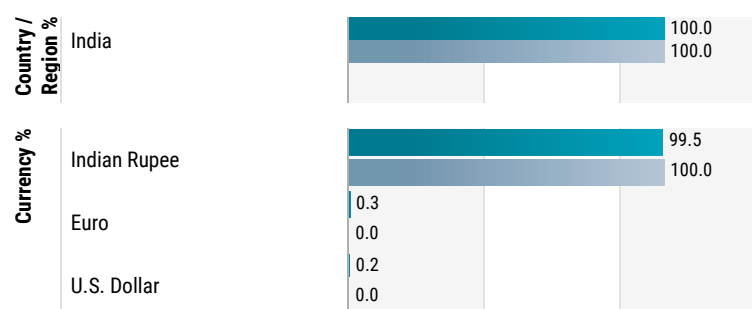
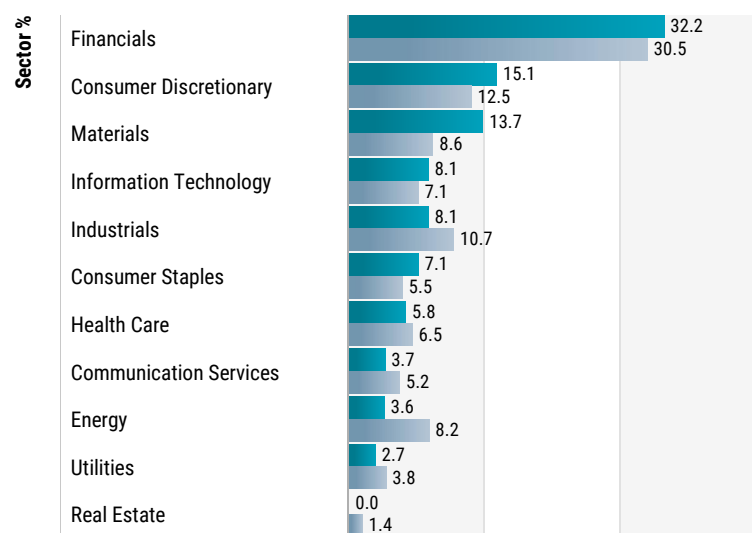

Performance commentary

Based on transaction prices, the fund's return was 0.37%.

Based on net asset value, the fund underperformed versus the benchmark by 3.15%. Portfolio performance was detracted by stock selection in consumer discretionary, financials and consumer staples. Lower allocation in industrials (mainly defense and power equipment manufacturers) and energy have contributed positively to performance. Key stock contributors were Tech Mahindra, Sona BLW, Ujjivan, PayTM, Balkrishna industries, which positively contributed to the performance. Not owning Bajaj finance, M&M and TCS detracted the performance over the month. While stock selection has impacted negatively in the month of July, we continue to be encouraged by strong earnings performance from our portfolio companies in FY27Q1 so far and expect the earnings acceleration-led improvement to play out going forward.

Market development

The MSCI India (MXIN) outperformed the MSCI Emerging Markets (MXEF) and the MSCI Asia Pacific ex-Japan (MXAPJ) by 4.7% and 3.9%, respectively, in the month of July (USD) and outperformed by 7.5% and 6.8%, respectively, in the last two-month period. This was the second consecutive month of outperformance. The positive trend in the equity market was driven by (a) the FY27Q1 earnings season is turning out to be better than expected (b) a coordinated effort from the government and RBI to improve foreign capital flows which is reflected in an improvement in capital flows and (c) crude prices settling at a lower level despite the recent flare-ups in the war. Despite heightened worries about India's current account during the Strait of Hormuz crisis, it has held up well. The April-June current account deficit (CAD) was just 0.8% of GDP (helped by much higher-than-expected remittances, and lower gold imports). While the worst of the West Asia crisis seems behind, even if one assumes a crude average of USD 90/barrel for the rest of the fiscal year, the full-year current account deficit would print at 1.4% of GDP (JP Morgan estimates) – wider than last year, but much lower than initially envisaged.

Expectation of fund manager

While the West Asia crisis continues, the worst seems to be behind, reflected in crude oil prices settling in a lower range versus the past few months. India has weathered the storm well, the fiscal impact on India has been limited to the reduction in fuel excise duties and the front-loaded increase in fertilizer and food subsidies, and we don't see a need for incremental intervention here. Most of the central banks have kept their interest rate unchanged in their respective scheduled announcements, providing continuity of the monetary policy versus fears of sharp hikes in response to the inflation spikes. On the domestic front, we are seeing the earnings trajectory to remain on improving trajectory. Lower trending commodity prices, a revival in exports and sustained government capex should continue to support the earnings in the medium term.

Top 10 largest holdings

During the month, there was no change in the top ten portfolio holdings.

Sector allocation

Overall fund positioning has not changed: overweight sectors with earnings acceleration or consolidation benefits, avoiding pockets with twin risks of negative earnings revisions and valuation derating. Faster normalization of the energy price environment post-war will aid investments in cement and consumer staples. We increased weight in financials, based on improved earnings visibility and favorable risk-reward on valuations. Key overweights remain unchanged i.e. materials, consumer discretionary and consumer staples, where we see earnings acceleration and growth outperformance versus peers. We like structural growth stories within export manufacturing, which benefit from currency depreciation, trade deals and better execution. As trade treaties take effect through FY27, momentum in chemicals and textiles should pick up; we find new opportunities where the market underappreciates longer-term prospects. We remain underweight in expensive industrials i.e. defense and power equipment, while remaining positive on wider manufacturing in India. Also, we remain underweight in state-owned oil companies, as energy price decline benefits will not accrue to them but will boost economic growth.

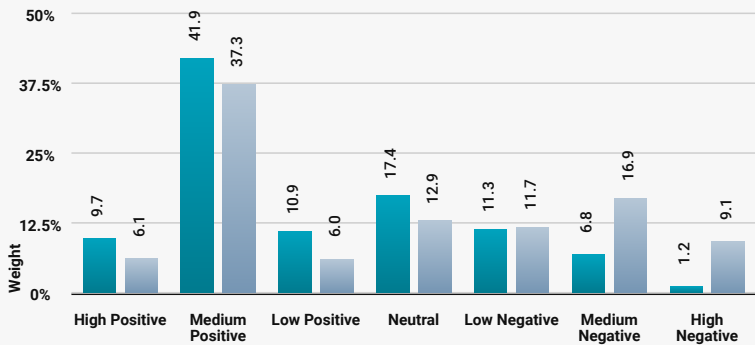

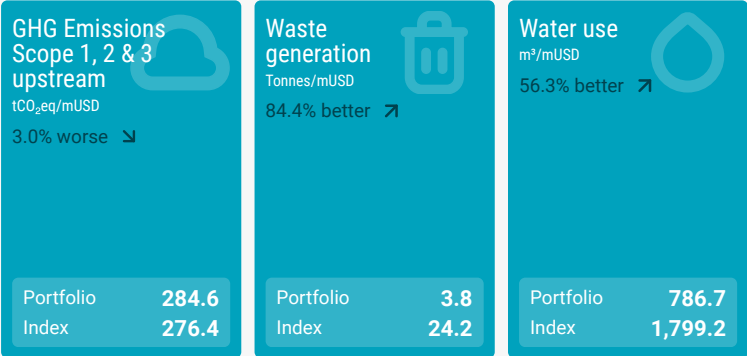
SDG Impact Alignment ¹

Environmental Footprint ²

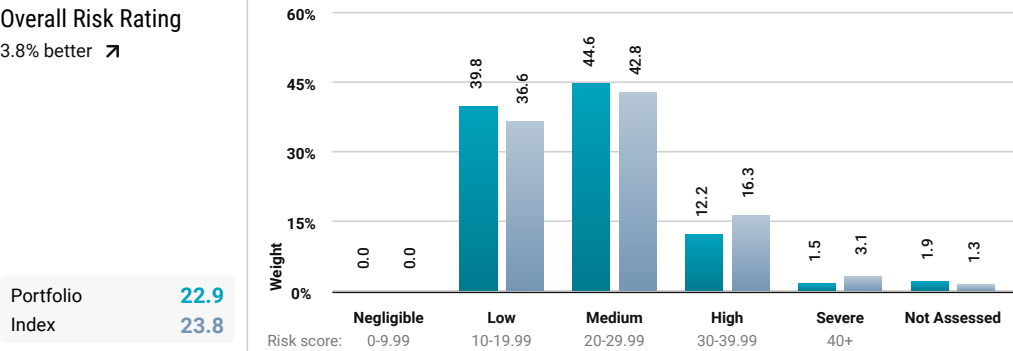

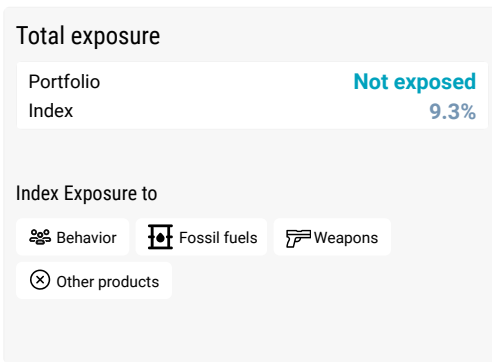

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
