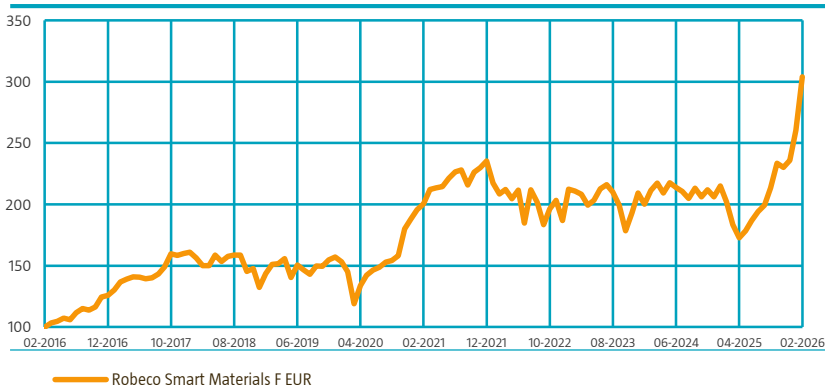

Performance

Based on transaction prices, the fund's return was 16.77%.

In February, Smart Materials were driven by firmer critical-mineral pricing and a powerful mix of AI infrastructure capex and policy-led supply chain localization: lithium continued to stabilize amid Western restocking and steady storage demand, copper stayed fundamentally tight on sustained grid/EV/renewables build-out despite consolidating LME prices, rare earths (especially magnet-grade NdPr) broke above the informal US floor as buyers secured non-Chinese supply and inventories tightened, and gold strengthened on macro/geopolitical uncertainty – supporting miners and recyclers. At the same time, AI 'picks and shovels' demand remained strong across advanced packaging, power device testing, and high-speed photonics, while the EU's CBAM reinforced incentives for lower-carbon European production and compliant processing capacity, underscoring the convergence of resource security, electrification intensity, and AI-driven industrial investment across advanced materials value chains.

Market development

Global equities advanced modestly in February, supported by further evidence of cooling inflation and stabilizing manufacturing activity across the US, Europe and parts of Asia. Global stock markets increased, as bond yields drifted lower on expectations that central banks remain on a gradual easing path through mid-year. US economic data showed resilient consumer demand and improving industrial orders, while Europe benefited from firmer export momentum and energy price stability. Market leadership broadened slightly beyond mega-cap technology, with materials and select industrial automation names gaining traction.

Expectation of fund manager

2026 offers a supportive environment for smart materials, defined by the combination of a gradually improving industrial cycle and powerful, persistent structural investment trends. Companies positioned at the intersection of electrification, automation, resource efficiency, and circularity are likely to see durable demand, while valuation dispersion and macro uncertainty will require disciplined, bottom-up portfolio construction. Momentum for critical minerals has been strong and continues to look very attractive.

Hudbay Minerals – copper miner geared to EV grids; Onto Innovation – metrology tools boosting yields in advanced and AI chip packaging; Teradyne – testers for AI and auto semiconductors; Corning – specialty glass and optical ceramics; Aura Minerals – gold-copper producer supplying conductive metals for electrified transport and renewables; Aperam – scrap-based stainless and specialty steels; Lumentum – photonics enabler for AI/data center connectivity (lasers + coherent optics) powering faster, more efficient networks. Neo Performance Materials – critical materials for electrification (rare-earth magnet inputs + specialty metals) supporting EV motors and electronics. Umicore - leading metals recycler. Samsung Electro-Mechanics – high-end electronic components (MLCCs, substrates, camera modules) leveraged to smartphones, autos, and AI/compute hardware.

Sustainability

The fund's sustainable investment objective is to help mitigate the resource scarcity challenge within industries while supporting economic growth. Resource scarcity and sustainability considerations are incorporated in the investment process by the means of a target universe definition, exclusions, ESG integration, a carbon footprint target and voting. The fund only invests in companies that have a significant thematic fit as per Robeco's thematic universe methodology. Through screening on both Robeco's internally developed SDG Framework and Robeco's exclusion policy, the fund does not invest in issuers that have a negative impact on the SDGs, are in breach of international norms or where products have been deemed controversial.

Financially material ESG factors are integrated in the bottom-up fundamental investment analysis to assess existing and potential ESG risks and opportunities. The fund's weighted carbon footprint will be equal to or better than that of its Climate Transition Benchmark. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

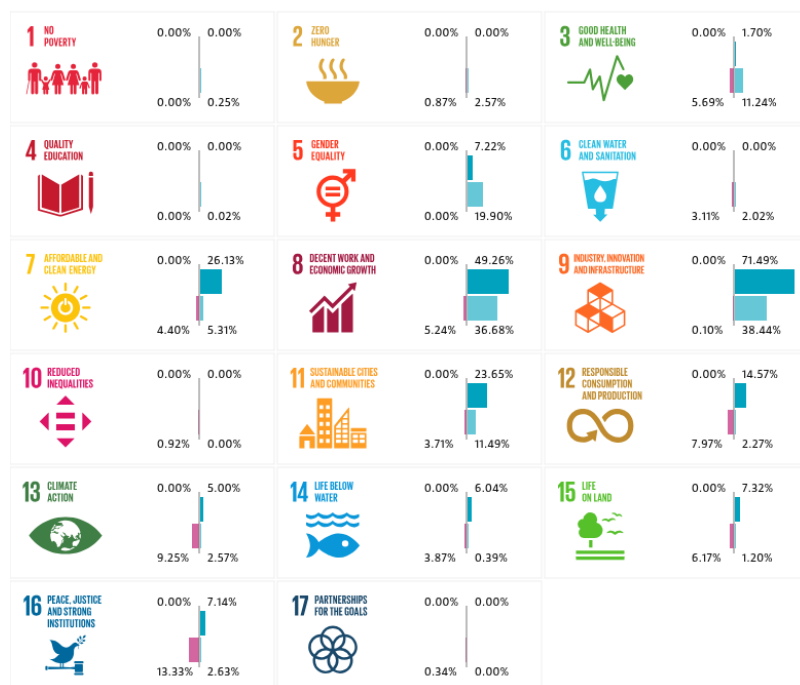

Sustainalytics ESG Risk Rating

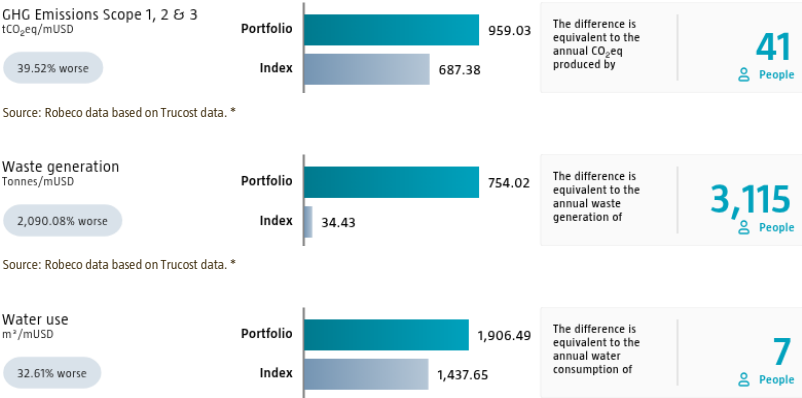

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months.
