## Performance commentary

Based on transaction prices, the fund's return was 21.66%.

The portfolio outperformed very strongly in April, with gains broad-based across both clusters. Within Advanced Materials, Samsung Electro-Mechanics more than doubled on a sustained MLCC cycle upswing driven by AI server demand, while Corning advanced on hyperscale connectivity. JX Advanced Metals and Aperam led Transition Metals on improved value-added metals sentiment, and Neo Performance Materials gained on Western rare-earth supply chain focus. Umicore contributed through recycling exposure, CATL advanced on dual EV/storage positioning, and Rockwool was the sole detractor on weak European construction. In Smart Manufacturing, the AI capex cycle drove broad strength: Viavi rallied on optical test demand for high-speed transceivers, Chroma ATE surged on record results from AI power testers and system-level testing, Delta Electronics hit record margins on AI server power and cooling, and Yaskawa rebounded on semiconductor-driven automation orders. Arm Holdings rallied on rising CPU-to-GPU ratios in AI clusters, and Cadence gained on broad EDA demand.

## Market development

April's Smart Materials landscape was shaped by three reinforcing forces: the energy shock accelerating mineral demand, AI infrastructure broadening into physical materials, and resource nationalism constraining supply. Lithium surged approximately 50% year-to-date to approximately USD 24,500/t, as rising oil reinforced the EV cost advantage, Beijing committed to doubling EV charging capacity by 2027, and data center operators emerged as new lithium buyers for grid-scale storage. Copper held firm near USD 12,000/t on mine supply constraints and rare earths remained in deficit for magnet-grade materials. The AI picks-and-shovels theme intensified as Q1 earnings confirmed that power, thermal and testing technologies serving EVs are now equally critical to AI infrastructure – with testing equipment makers surging on demand for tools qualifying high-speed optical and 800V architectures used in both data centers and EVs. Western governments continued tightening their critical minerals policy, with the US calling on allies to accept a "national security premium" for non-Chinese sourcing – underscoring how these three forces are converging to tighten mineral markets across Smart Materials value chains.

## Expectation of fund manager

2026 offers a supportive environment for smart materials, defined by the combination of a gradually improving industrial cycle and powerful, persistent structural investment trends. Companies positioned at the intersection of electrification, automation, resource efficiency, and circularity are likely to see durable demand, while valuation dispersion and macro uncertainty will require disciplined, bottom-up portfolio construction. Momentum for critical minerals has been strong and continues to look very attractive.

## Top 10 largest holdings

Samsung Electro-Mechanics – high-end electronic components (MLCCs, substrates) leveraged to autos and AI hardware; Onto Innovation – metrology tools for advanced and AI chip packaging; Viavi Solutions – optical test instruments for fiber and AI data center networks; Corning – specialty glass and optical ceramics; Chroma ATE – test equipment for power electronics, batteries, and EV drivetrains; Teradyne – testers for AI and auto semiconductors; Aura Minerals – gold-copper producer supplying conductive metals for electrification; Aperam – specialty stainless and electrical steel for EV motors and renewable energy; SQM – lithium producer for EV batteries and energy storage; Arm Holdings – energy-efficient chip IP underpinning AI compute, automotive electronics, and the IoT.

## Sector allocation

The strategy is based on bottom-up stock selection. The sectors that make up the majority of the investable universe are information technology, industrials and materials.

## Regional allocation

The weight of Europe has declined to include more North America recently, but the strategy is based on bottom-up stock selection.

## Currency allocation

The strategy is based on bottom-up stock selection.

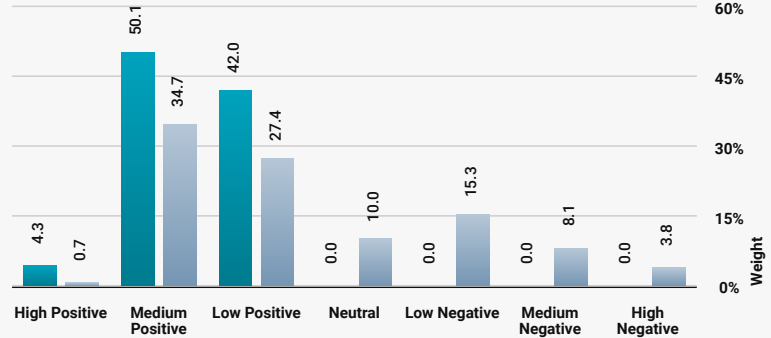

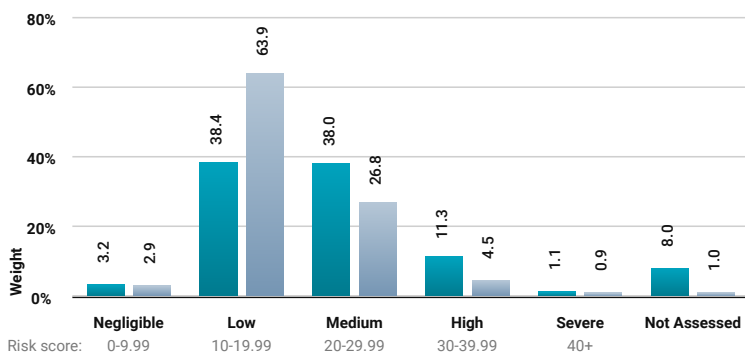

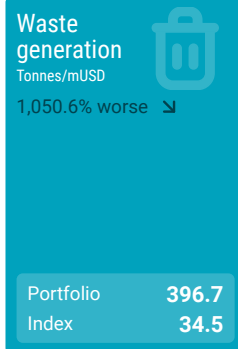

### 1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. ### 4. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards.
