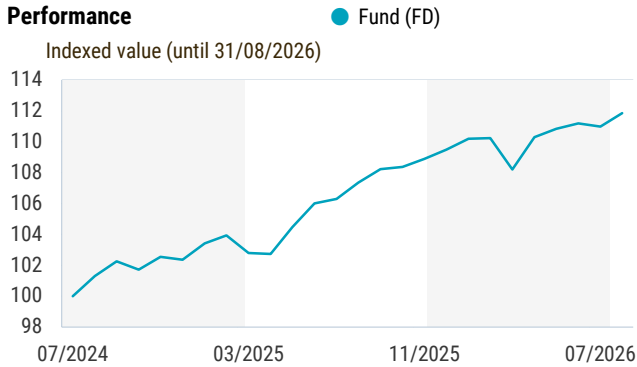

About the fund

Robeco QI Global Multi-Factor High Yield is an actively managed fund that invests in high yield bonds. The selection of these bonds is based on a quantitative model. The fund's objective is to provide long-term capital growth. The fund offers balanced exposure to a number of proven factors by focusing on bonds with a low level of expected risk (low risk factor), an attractive valuation (value), a strong performance trend (momentum) and a small market value of debt (size). The investment universe includes bonds with a BB+ rating (or equivalent) or lower by at least one of the recognized rating agencies, or with no rating.

Performance commentary

Based on transaction prices, the fund's return was 0.78%.

Based on closing prices, the fund posted a relative return of -0.01% versus the benchmark. Issue(r) selection made a strong positive contribution. The value factor delivered the largest positive contribution, followed by smaller positive contributions from size, momentum and low-risk/quality. Sector allocation delivered a small positive contribution, primarily due to the underweight in the communications sector; the underweight in the capital goods sector slightly detracted. Currency allocation slightly detracted, mainly due to the underweight in USD-denominated paper. Country allocation delivered a positive contribution, due to the underweights in EM and Japan. The allocation to subordination groups slightly detracted, mainly due to the underweight in senior corporates. Rating allocation delivered a large positive contribution, especially coming from the underweight in CAA and additionally from the overweight in BA-rated paper. SDG score and ESG Risk Rating allocations both contributed slightly positively. Beta allocation detracted strongly: the beta position of the bond portfolio detracted strongly, while the CDS index beta hedge delivered a smaller positive contribution.

Market development

The Bloomberg Global High Yield Corporates ex-Financials Index posted a positive credit return of 0.73% as credit spreads tightened from 293 to 274 bps. The euro-hedged total return was 0.78%, as underlying government bond yields decreased slightly. During August 2026, corporate bonds advanced, with high yield outperforming investment grade in US and European markets. Equity markets generally trended higher as well, with US markets outperforming European markets. The 10-year US Treasury yield was broadly stable, while Germany's 10-year Bund yield rose 12 bps reaching the highest level since 2011. Neither the Federal Reserve nor the European Central Bank held a policy meeting in August, leaving rates unchanged. Hawkish Federal Reserve messaging focused on persistent inflation risks. New US tariffs took effect on 1 August, increasing trade uncertainty. US-Iran tensions persisted but oil remained broadly range-bound, while gold rose sharply.

Expectation of fund manager

Robeco QI Global Multi-Factor High Yield invests systematically in high yield corporate bonds. It offers balanced exposure to a number of quantitative factors. In the long term, we expect the portfolio to outperform the market by systematically harvesting factor premiums with a risk profile that is similar to the reference index.

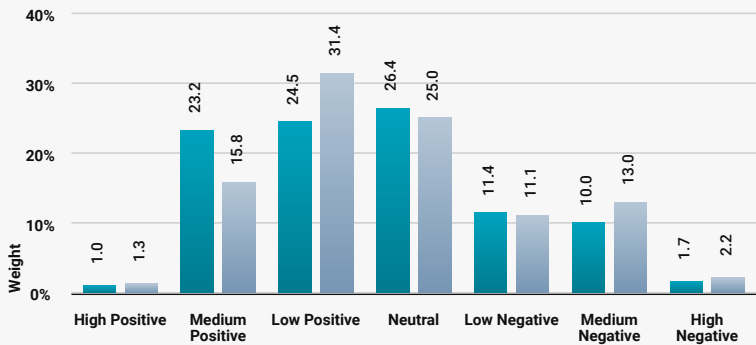

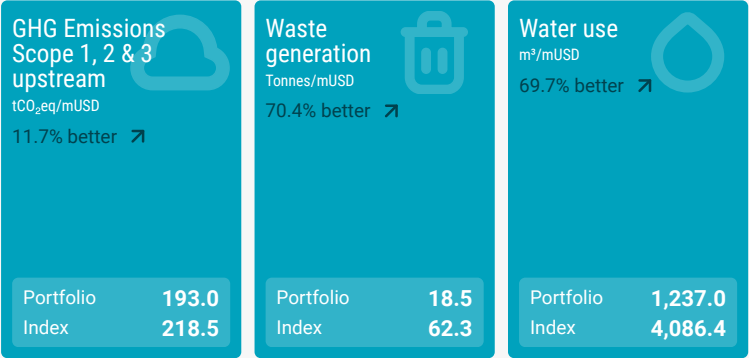
SDG Impact Alignment ¹

Environmental Footprint ²

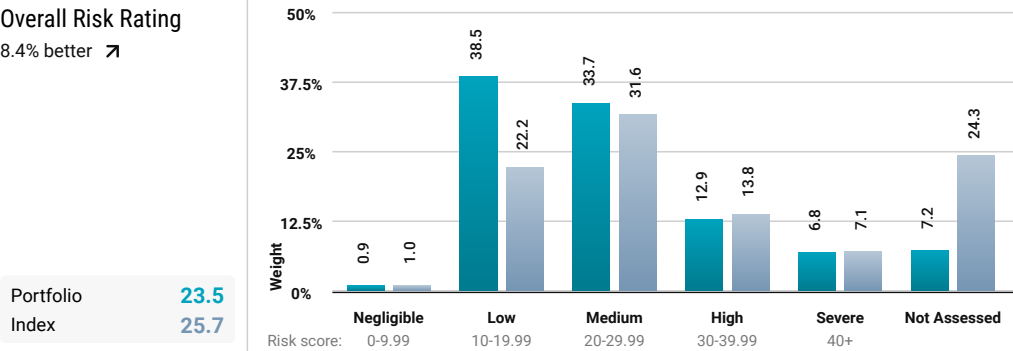

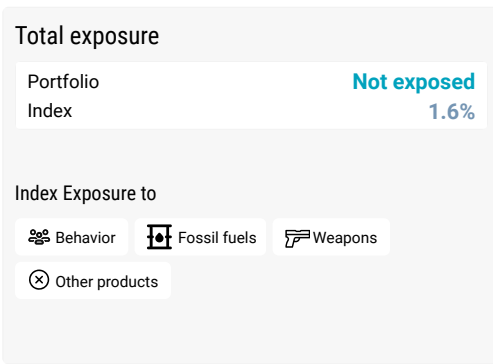

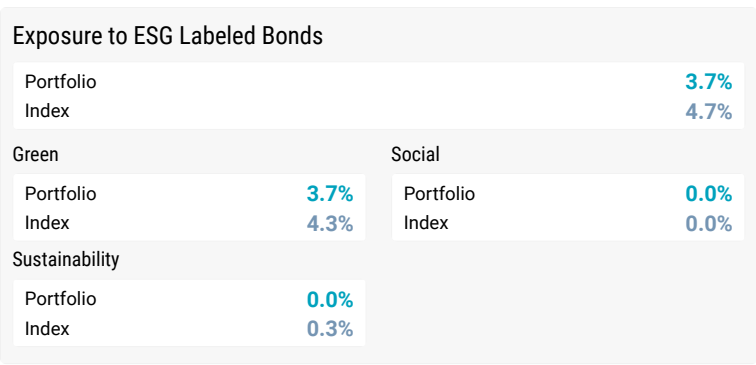

Reference

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

3. Sustainalytics ESG Risk Rating

5. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

6. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg.
