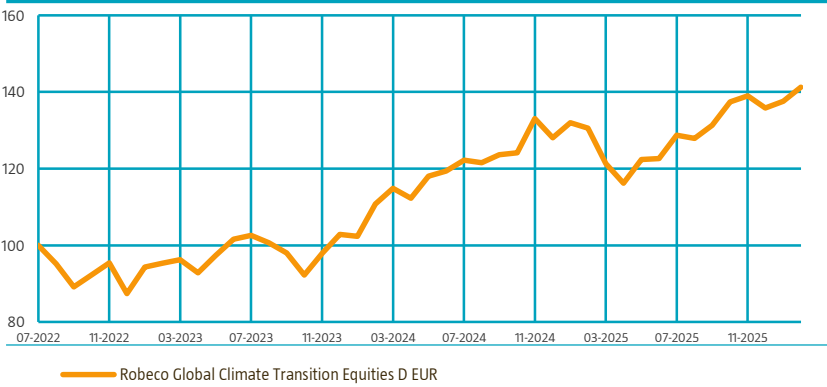

Performance

Based on transaction prices, the fund's return was 2.65%. In February, our strategy had a strong absolute return, also keeping ahead of the benchmark (+2.8% versus +2.1%, respectively). Sector-wise, the main positive contributors were industrials and technology, whereas financials and utilities lagged. In terms of stock selection, Vertiv moved up significantly, following a strong earnings report. The data center infrastructure provider continues to benefit from the massive AI-driven buildout of compute capacity. Komatsu also continued its ascent, driven by a combination of an earnings beat and a broader re-rating of Japanese industrials amid a weaker yen. Finally, TSMC also moved higher as the world's dominant advanced chipmaker benefits from insatiable AI-related demand for leading-edge semiconductors. On the flip side, Resona's share price lagged in February, mainly because investors rotated out of Japanese banks after a very strong run-up. Alphabet notably detracted as well, despite beating earnings expectations. However, its massive capex program of USD 175-185 billion, almost double that of 2025 levels, was far above expectations and causes concern about the return on this enormous AI infrastructure spend.

Expectation of fund manager

Looking ahead, the big picture is simple: demand for electricity is set to jump, and most of that incremental supply has to be clean. Analysts expect US power demand growth to at least quadruple this year as AI, EVs and heat pumps scale, turning power, networks and flexibility into front row trades rather than sustainability side shows. Global capex plans still lean heavily toward renewables, storage and grids, which gives the sector a long runway even if quarterly data get noisy. For climate stocks, the catch is that this is still a rate and policy-sensitive space. If bond yields stay relatively calm and governments avoid major U-turns on transition support, investors are likely to keep rotating into higher quality renewables; the names with scale, contracts and actual profits. If yields back up or policy gets messy, the air probably comes out first from the racier end of clean tech, while the more boring grid, utility and efficiency stories hold up better. Interestingly, climate transition is no longer being sold just as 'saving the planet', but as keeping the lights on for AI, industry and national security, which makes the growth likely more durable to a wider pool of capital.

Top 10 largest positions

Our number one active position is Siemens Energy, which is a metaphorical Swiss army knife when it comes to energy solutions including gas turbines, grid networks and wind turbines. Its order book has grown materially across all divisions, leading to a much better sustainable-growth and return profile. Our second-largest active position is Komatsu, a Japanese heavy-machinery maker, specializing in construction and mining equipment. Its operational performance improved a great deal over the years, running a more service-driven model, thereby improving resilience and cash flow generation. Vertiv rounds off our top three and is a manufacturer of thermal management equipment. Vertiv benefits greatly from the AI buildout as it's the preferred partner for many hyperscalers that install Vertiv's liquid cooling and power control equipment, deemed essential in running data centers efficiently.

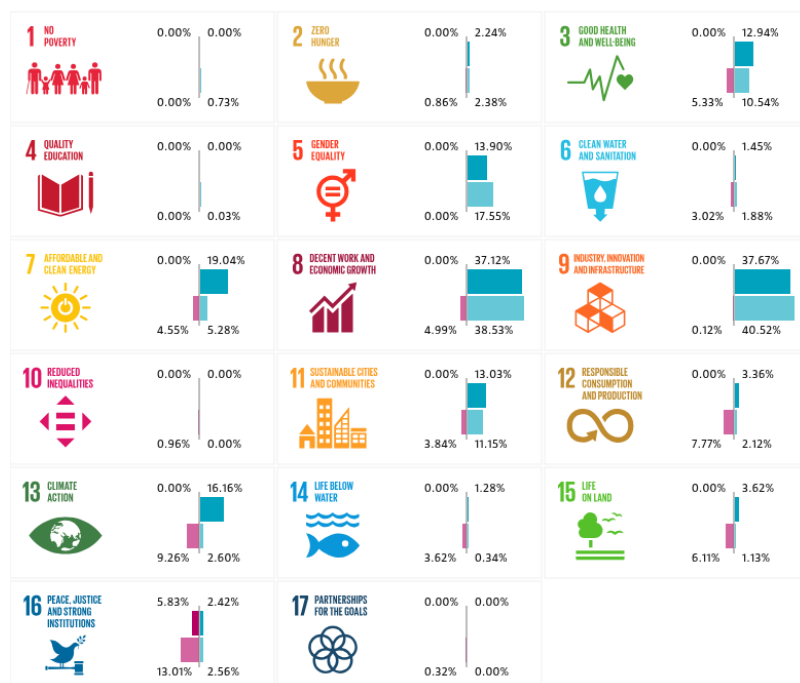
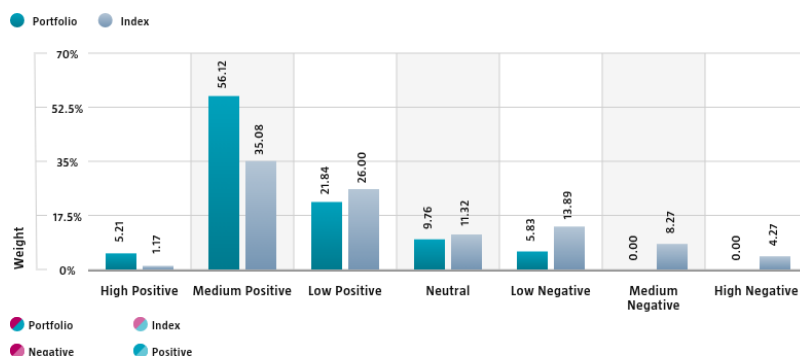
The fund aims to invest at least 80% of its assets in companies that are making or enabling the climate transition in line with the Paris agreement. Furthermore, the fund incorporates sustainability in the investment process through exclusions, ESG integration, engagement, and voting. Financially material ESG factors are integrated in the bottom-up investment analysis to assess existing and potential ESG risks and opportunities. The fund limits exposure to issuers OR companies with an elevated sustainability risk profile to 5%. Elevated sustainability risk is defined by Robeco as companies with an ESG Risk Rating of 40 and higher. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement.

SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. 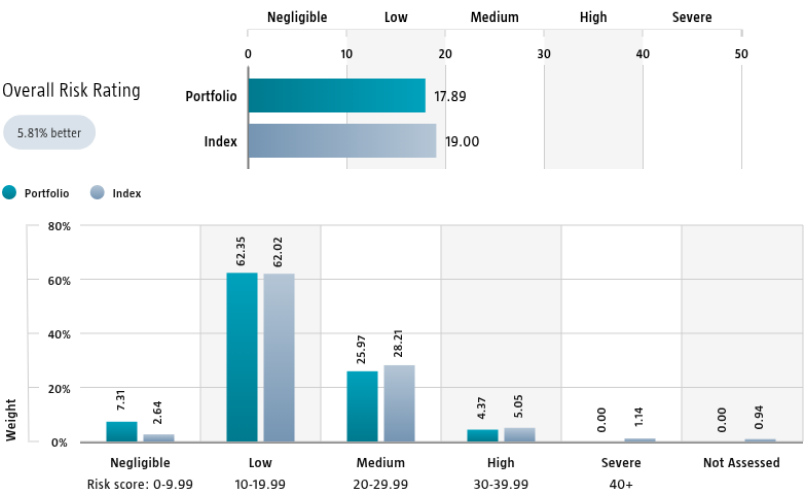

Sustainalytics ESG Risk Rating

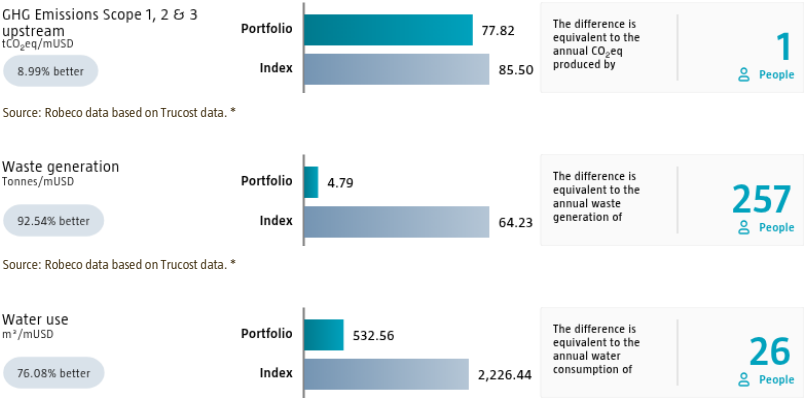

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. Engagement

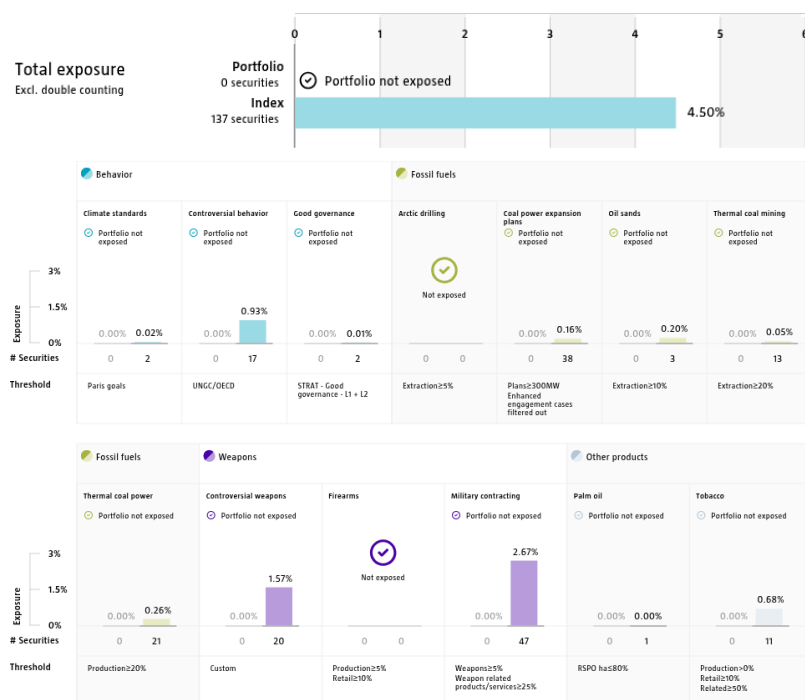
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

This is achieved by investing in companies that are making the transition and companies are enabling the transition, as described in the Prospectus.

Chris holds a Master's in Business Administration and International Public Management from the Erasmus University Rotterdam and is a CFA® Charterholder. Yanxin Liu is Portfolio Manager and member of the Global Equity team. She is also Deputy Lead Portfolio Manager Global Stars Equities. She has a focus on information technology. She is responsible for fundamental global equities as well as portfolio construction. Yanxin spent 11 years with our Emerging Markets Equity team, prior to joining the Global Equity team in 2022. Within the Emerging Markets team her focus was on all sectors in Greater China. Prior to that, Yanxin worked for DSM Pension Services in the Netherlands as an analyst focusing on US large-cap equities. Yanxin has a Master's in Finance from the Erasmus University Rotterdam and a Bachelor's in Financial Accounting from Nankai University in Tianjin, China. She became a CFA® Charterholder in 2015 and is a native Mandarin speaker.
