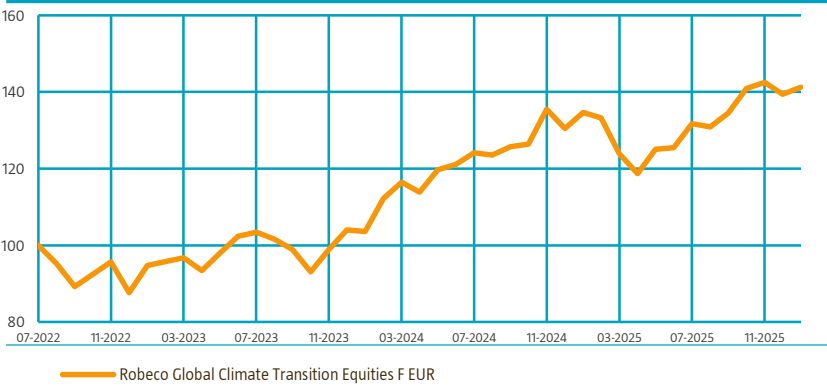

Performance

Based on transaction prices, the fund's return was 1.32%. In January, our strategy had a positive absolute return, though modestly trailing the benchmark (+1.6% versus +1.7%, respectively). Sector-wise, the main positive contributors were financials and consumer discretionary, whereas technology and consumer staples lagged. In terms of stock selection, Siemens Energy contributed most in January, continuing the path they were on in 2025. The company is active in the most important bottleneck for AI services: Power. Resona Holdings contributed nicely to performance. Resona is Japan's fourth largest bank but with the largest regional presence, enjoying strong loan growth with SME's in particular. On the flip side, First Solar was the largest detractor in January. After some initial profit-taking after a strong 2025, the stock got a real hit after Tesla announced it wants to significantly grow its solar business in the coming years, potentially threatening First Solar in the process. Infrastructure software play Trimble also underperformed. The company had very little news to report, but investors fear AI is going to kill software.

Expectation of fund manager

Policy remains a key support, especially in Europe. The upcoming EU Industrial Accelerator Act, with proposed clean product quotas of up to 60-80% and faster permitting, underpinned sentiment in EU centric equipment suppliers such as wind OEMs and inverter manufacturers. Germany's step up in onshore wind auction volumes to 11 GW for 2026, alongside a strong 2025 permitting pipeline, reinforced the structural onshore story even as offshore wind remained fragile. Near-term, the sector faces a tug of war between accelerating structural demand and persistent execution and policy risks. On the positive side, hyperscaler capex pipelines and rising data center load growth should continue to support utility scale solar, storage, smart grid, and geothermal names, as utilities prioritize scalable, grid stabilizing solutions. Against this backdrop, investors may favor diversified clean energy platforms that can pivot toward storage, flexible thermal, and grid solutions, and those positioned as indirect 'transition hedges' on AI infrastructure rather than pure play volume growth stories in wind/solar.

Top 10 largest positions

Our number one active position is Alphabet, as we believe that with its leading positions in search, cloud and the investments into its AI platform, it has a long runway for growth with attractive returns. First Solar is our second-largest weight and is the largest US domestic solar panel manufacturer, focusing exclusively on utility-scale solar. Given its domestic US focus and having no reliance on Chinese supply chains, First Solar can continue to grow significantly in US utility-scale solar. The company is sold out well into 2028 with very favorable contract pricing, which cushions it from any major headwinds. German industrial company Siemens Energy rounds off our top-three active positions and is a metaphorical Swiss army knife when it comes to energy solutions, including gas turbines, grid networks and wind turbines.

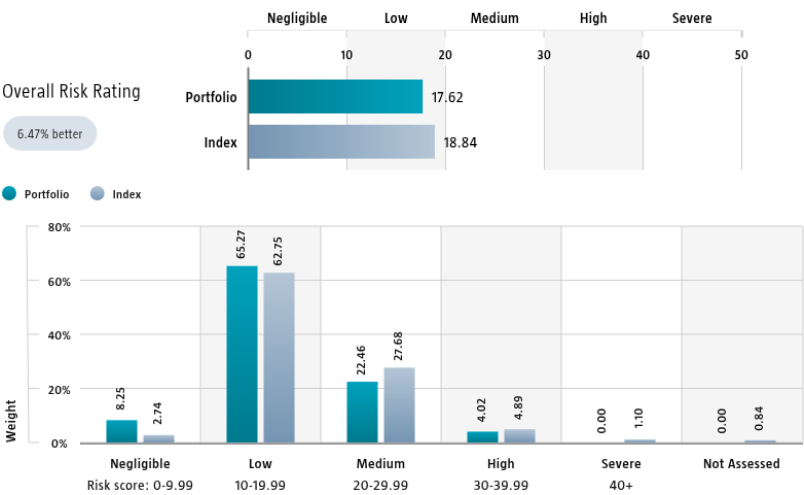

Sustainability

The fund aims to invest at least 80% of its assets in companies that are making or enabling the climate transition in line with the Paris agreement. Furthermore, the fund incorporates sustainability in the investment process through exclusions, ESG integration, engagement, and voting. Financially material ESG factors are integrated in the bottom-up investment analysis to assess existing and potential ESG risks and opportunities. The fund limits exposure to issuers OR companies? with an elevated sustainability risk profile to 5%. Elevated sustainability risk is defined by Robeco as companies with an ESG Risk Rating of 40 and higher. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement. Sustainalytics ESG Risk Rating

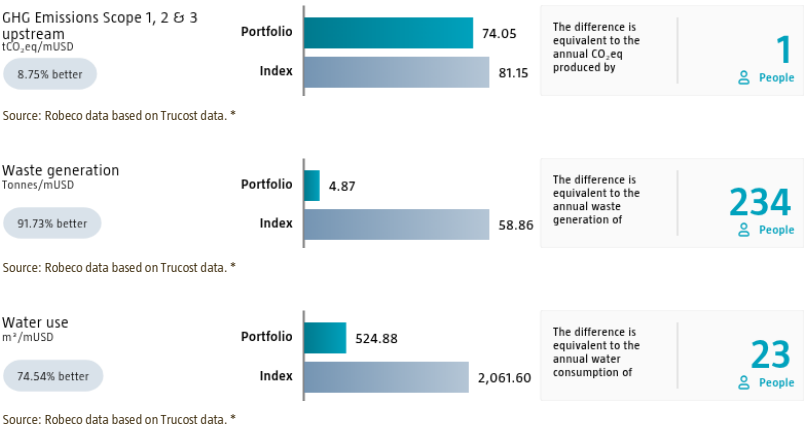

Environmental Footprint

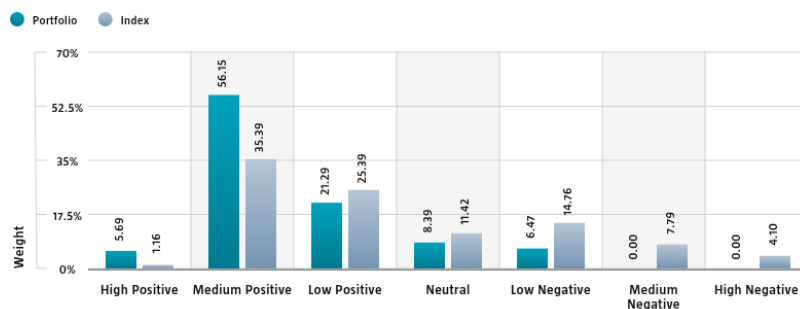

Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. Engagement

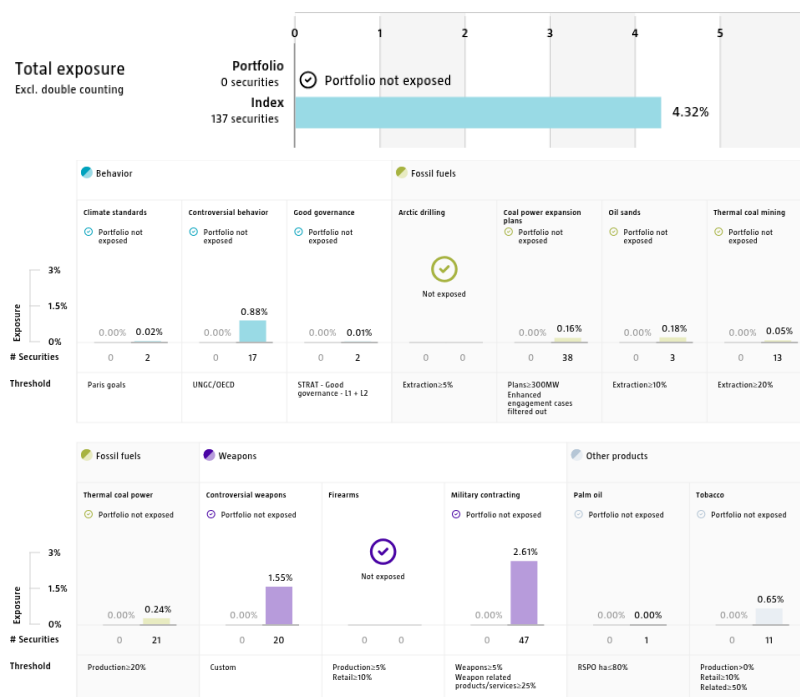
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

He is also Deputy Lead Portfolio Manager Global Stars Equities. He is responsible for fundamental global equities, as well as portfolio construction. Prior to joining Robeco in 2010, he worked as an analyst for The Hague Centre for Strategic Studies. He conducted country, industry and company research for various equity teams before joining the Global Equity team. Chris holds a Master's in Business Administration and International Public Management from the Erasmus University Rotterdam and is a CFA® Charterholder. Yanxin Liu is Portfolio Manager and member of the Global Equity team. She is also Deputy Lead Portfolio Manager Global Stars Equities. She has a focus on information technology. She is responsible for fundamental global equities as well as portfolio construction. Yanxin spent 11 years with our Emerging Markets Equity team, prior to joining the Global Equity team in 2022. Within the Emerging Markets team her focus was on all sectors in Greater China. Prior to that, Yanxin worked for DSM Pension Services in the Netherlands as an analyst focusing on US large-cap equities. Yanxin has a Master's in Finance from the Erasmus University Rotterdam and a Bachelor's in Financial Accounting from Nankai University in Tianjin, China. She became a CFA® Charterholder in 2015 and is a native Mandarin speaker.

Fiscal product treatment

Fiscal treatment of investor
