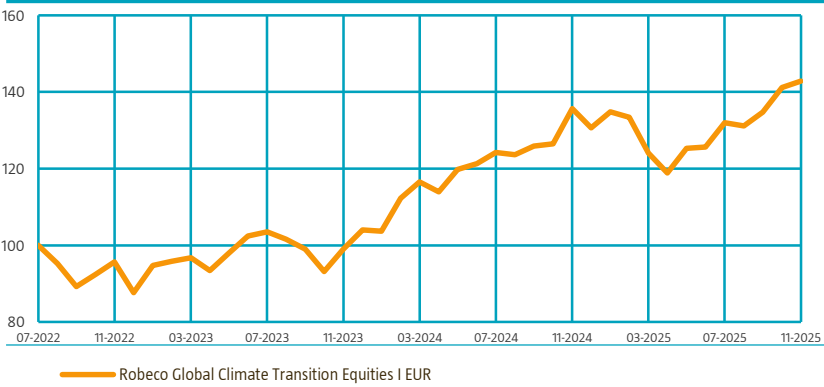

Performance

Based on transaction prices, the fund's return was 1.17%. In November, our strategy had a positive absolute return, also strongly outperforming the benchmark (+1.3% versus -0.6%, respectively). Sector-wise, the main positive contributors were communication services, healthcare and technology, whereas energy lagged. In terms of stock selection, Eli Lilly contributed most, driven by the announced GLP-1 pricing and patient access agreements between the Trump administration and key pharma players. Alphabet also contributed strongly to performance, as investors reacted very positively to its newly released Gemini 3 AI model, which has been trained on Google's own AI chips (called TPUs). Furthermore, clean energy capital provider Hannon Armstrong continued its strong run as well. Results exceeded expectations, delivering strong portfolio yields and stable spreads despite the still high interest rate environment. On the flip side, NVIDIA detracted from performance, despite a very strong earnings set and ditto outlook. Stock weakness was, therefore, more related to broader market dynamics. Macquarie Group also lagged, as results disappointed. There were weaker revenues from the commodity segment, in combination with impairments on its green energy portfolio.

Expectation of fund manager

Climate pledges at the UN COP30 in Belém, Brazil, mainly centered around adaptation finance and mechanisms to ensure a just transition, in particular for the most vulnerable nations. The COP, however, did not immediately lead to new large stimulus packages that could further support a broad package of climate solutions. Meanwhile, rising concerns on the AI 'bubble' have been gripping markets as of late. We do feel it's probably too early to already start fading an AI capex cycle which has just started to accelerate at incredible speed. So far, many 2026 forecasts paint rosy pictures for the year to come, again thanks to AI and expected rate cuts. To a large extent, that should benefit our more climate-oriented universe too, given the large amount of clean tech mid-cap companies that are well positioned to pick the fruits from higher energy demand, whether this is climate or purely AI-related. In general, when looking at equity basket performance year-to-date, we've seen worrying market dynamics from time to time. This actually supports the case for a revival of diversification and quality all the stronger, as we move into the new year.

## Top 10 largest positions

Our number one active position is First Solar, the largest US domestic solar panel manufacturer, focusing exclusively on utility-scale solar. Given its domestic US focus and having no reliance on Chinese supply chains, First Solar can continue to grow significantly in US utility-scale solar. The company is sold out well into 2028 with very favorable contract pricing, which cushions it from any major headwinds. Electronic manufacturing service company Celestica is our second-largest weight. Celestica is a higher beta AI infrastructure play serving the hyperscaler highspeed switch market, which is fast growing and generates higher margins. German industrial company Siemens Energy rounds off our top-three active positions and is a metaphorical Swiss army knife when it comes to energy solutions, including gas turbines, grid networks and wind turbines. Its order book has grown materially across all divisions, leading to a much better sustainable growth and return profile.

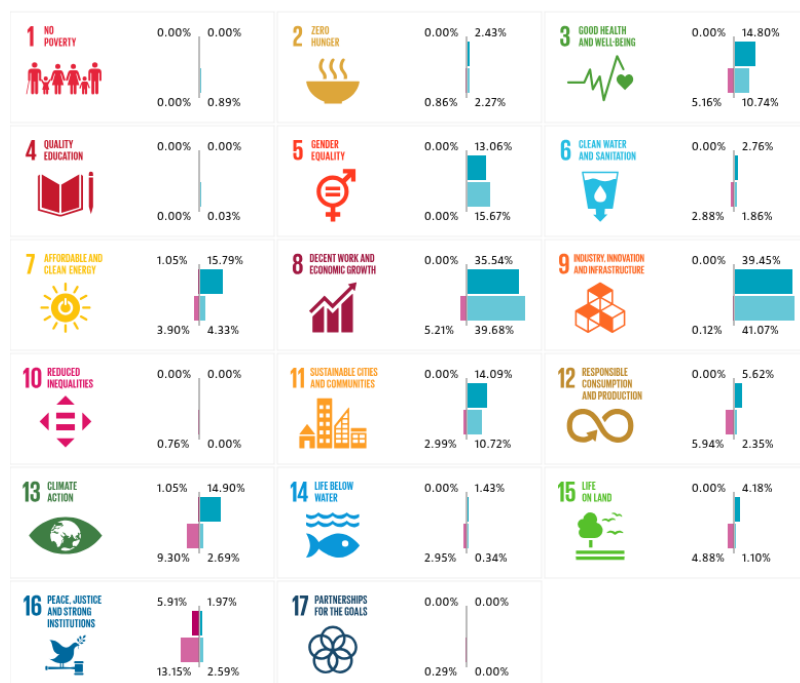
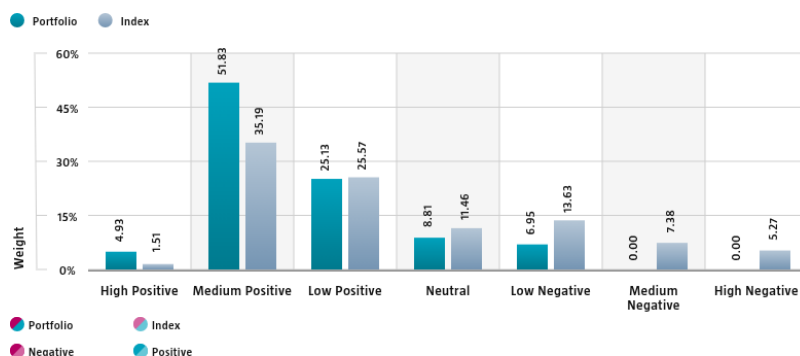
The fund aims to invest at least 80% of its assets in companies that are making or enabling the climate transition in line with the Paris agreement. Furthermore, the fund incorporates sustainability in the investment process through exclusions, ESG integration, engagement, and voting. Financially material ESG factors are integrated in the bottom-up investment analysis to assess existing and potential ESG risks and opportunities. The fund limits exposure to issuers OR companies? with an elevated sustainability risk profile to 5%. Elevated sustainability risk is defined by Robeco as companies with an ESG Risk Rating of 40 and higher. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement.

### SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. This results in a 7-step scale from -3 to +3. 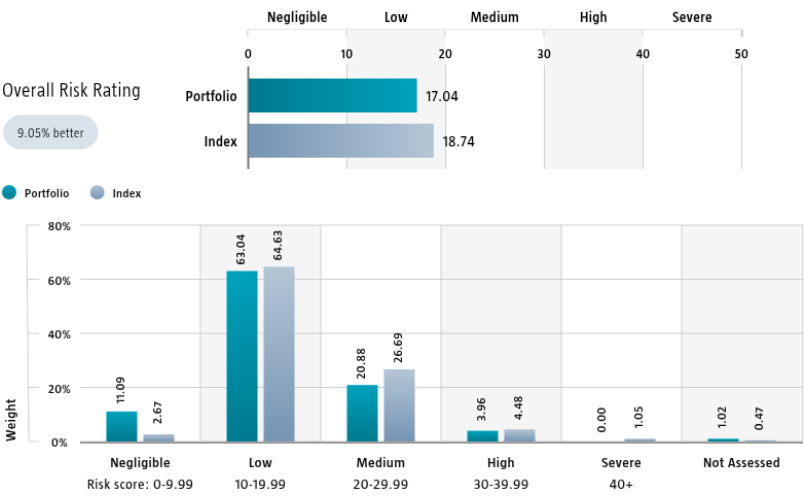

Sustainalytics ESG Risk Rating

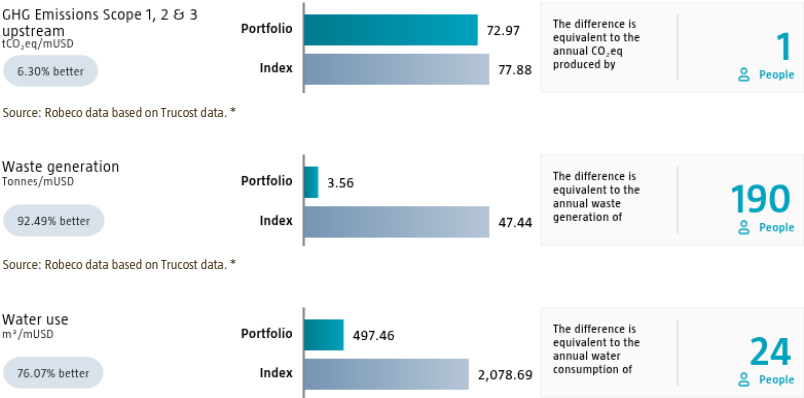

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. ### Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Within the Emerging Markets team her focus was on all sectors in Greater China. Prior to that, Yanxin worked for DSM Pension Services in the Netherlands as an analyst focusing on US large-cap equities. Yanxin has a Master's in Finance from the Erasmus University Rotterdam and a Bachelor's in Financial Accounting from Nankai University in Tianjin, China. She became a CFA® Charterholder in 2015 and is a native Mandarin speaker.
