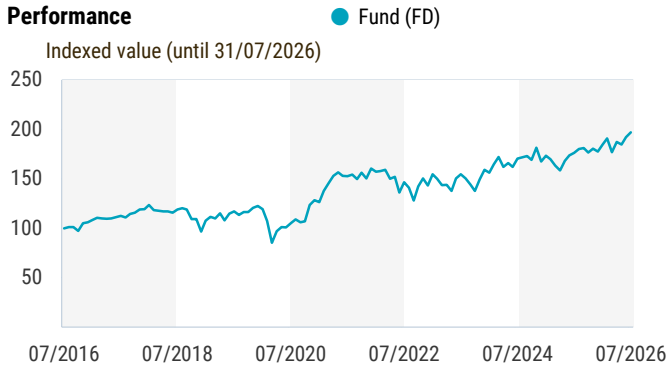

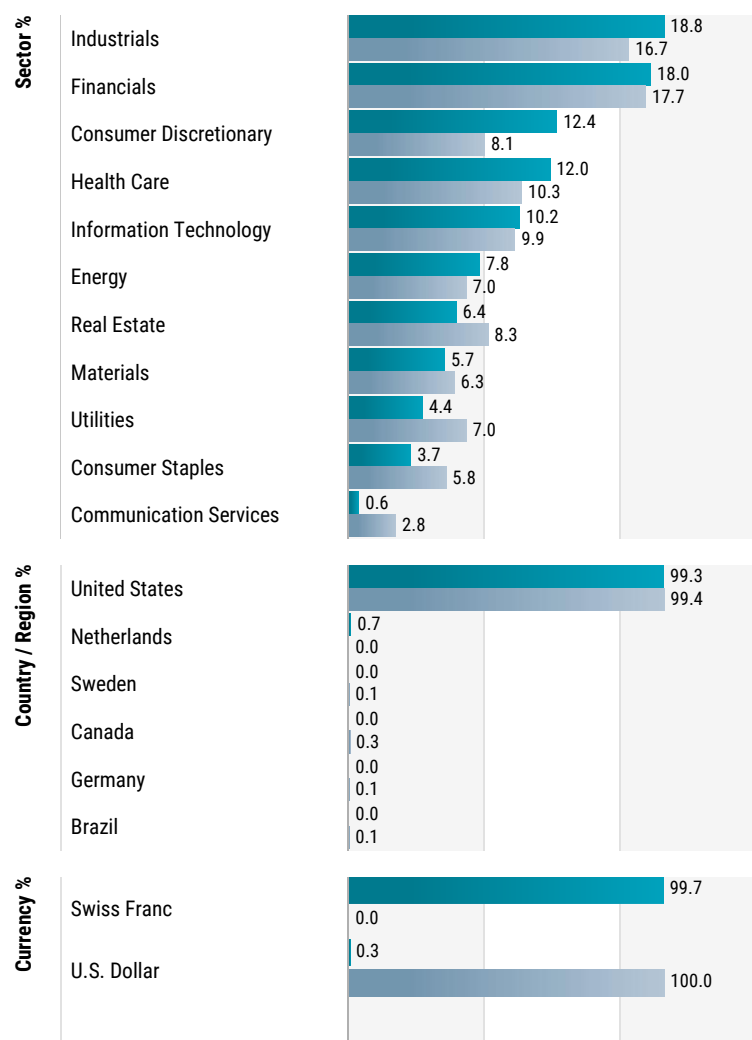

Performance commentary

Based on transaction prices, the fund's return was 2.61%.

Robeco BP US Select Opportunities Equities outperformed the Russell Mid Cap Value Index in July. Stock selection added most value in the month in the healthcare and information technology sectors. In healthcare, Tenet Health Care led the way with the hospital operator rallying as managed-care margins stabilized and utilization trends improved across the sector. Within information technology, avoiding electrical equipment company Coherent aided relative results, as did fund holding NetApp supported by expanding enterprise data demand for artificial intelligence infrastructure and strategic tech-sector momentum following major cloud earnings. Strong selection also came across the materials and energy sectors in the month. Sector allocation was more mixed with an underweight in utilities and an overweight in energy, partially offset by the fund's overweight exposure to consumer durables and industrials.

Market development

US equities delivered mixed results in July, with the S&P 500 modestly higher as renewed AI concerns, higher oil prices and rising bond yields outweighed strong late-month technology earnings. Market volatility prompted a rotation away from expensive growth stocks, helping value outperform growth, led by energy and financials.

Expectation of fund manager

Three themes are shaping markets: the AI trade, the Iran conflict and uncertainty under Fed Chair Kevin Warsh. July's AI weakness appears to be a reassessment rather than a structural reversal, with investors focused on returns from hyperscalers' capital spending. Oil remains sensitive to developments in Iran and could fall if tensions ease. Inflation data and Warsh's Jackson Hole speech will be key to the interest rate outlook. We remain constructive over the long term while alert to downside risks and opportunities created by market pullbacks. As always, we remain focused on selecting companies from the bottom-up that reflect the Boston Partners' three circle characteristics – attractive valuations, solid business fundamentals, and identifiable catalysts.

Top 10 largest holdings

Tenet Healthcare enters the top ten, replacing Old Dominion Freight Line.

Sector allocation

The fund was more active in July opening eight new positions and liquidating nine holdings. New positions came across five sectors – information technology (x2), financials, industrials (x3), utilities and healthcare. Liquidated stocks came across the sectors of consumer discretionary (x3), information technology (x3), industrials (x2) and utilities.

The fund invests only in stocks that are quoted on a US stock exchange.
