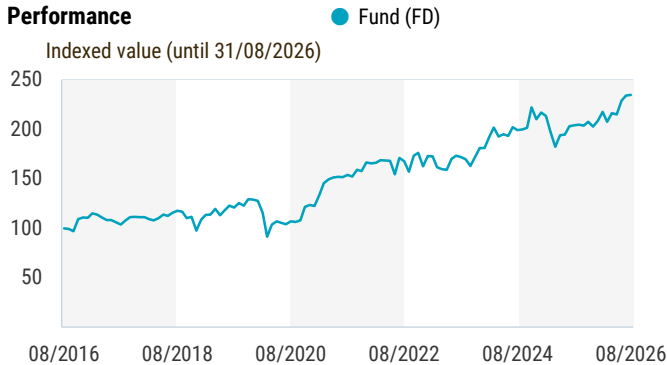

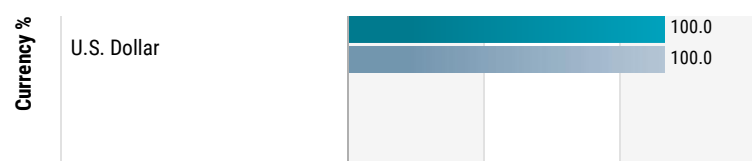
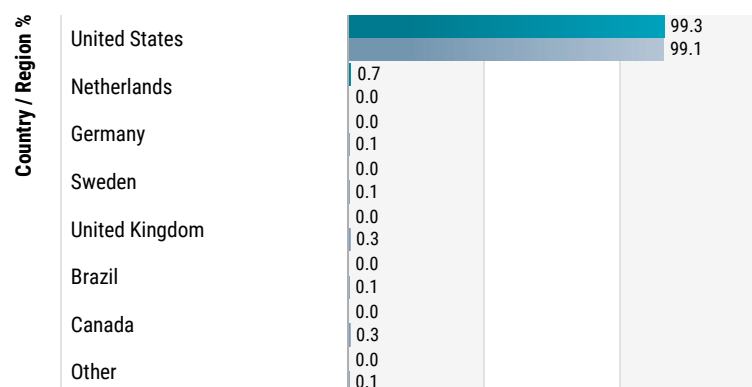

Performance commentary

Based on transaction prices, the fund's return was 0.34%.

Robeco BP US Select Opportunities slightly trailed the Russell Mid-Cap Value Index in August, with stock selection detracting from relative returns. From a stock selection perspective, healthcare and materials were the largest detractors from relative performance, while stock selection in industrials and consumer discretionary added the most value. In healthcare, relative results were largely affected by stocks the fund did not own. Not owning Moderna, which soared 156% during the month, while avoiding Veeva Systems, a provider of cloud-based software and data solutions to the global life sciences industry, also detracted as the stock rose sharply following better-than-expected fiscal second-quarter results. Within materials, metals service center company Reliance and packaging companies Ball Corporation and Packaging Corporation of America all had a lackluster month. On a positive note, within industrials, CACI International and Expeditors International of Washington added value. Within consumer discretionary, Frontdoor and Expedia were the leading contributors, rising 11% and 8%, respectively. Sector allocation was mixed but contributed positively to relative performance.

Market development

US equities advanced in August, with value stocks benefiting from strength in sectors such as energy, while resilient corporate earnings and continued enthusiasm around artificial intelligence supported broader investor sentiment. Market leadership broadened during the month, although performance varied meaningfully across sectors, with industrials, utilities and real estate lagging. Despite periodic volatility and rising treasury yields, the underlying economic backdrop remained supportive and helped equities finish the month in positive territory.

Expectation of fund manager

The outlook for US equities remains cautiously constructive. Strong corporate earnings, resilient economic activity and the broadening adoption of artificial intelligence should continue to support the market. With further multiple expansion likely to be constrained, returns should increasingly depend on earnings delivery and broader participation across sectors, creating a potentially favorable environment for disciplined stock selection and value-oriented opportunities. As always, we remain focused on selecting companies from the bottom-up that reflect the Boston Partners' three circle characteristics – attractive valuations, solid business fundamentals, and identifiable catalysts.

Top 10 largest holdings

Zebra Technologies and Expeditors International of Washington enter the top ten, replacing eBay and NetApp.

Sector allocation

During the month, the fund opened four positions while liquidating two holdings. New positions came across consumer discretionary, industrials (x2) and utilities, while liquidations came in consumer discretionary and information technology, one from each sector.
