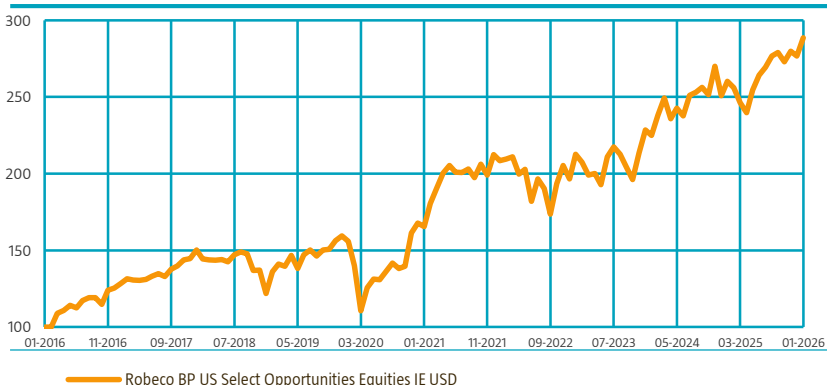

Performance

Based on transaction prices, the fund's return was 4.31%.

Robeco BP US Select Opportunities Equities outperformed the Russell Mid Cap Value Index in the first month of the year, with stock selection driving relative returns. From a stock selection perspective, the fund added most value in the sectors of financials and materials. In financials, not owning FinTech platform companies Robinhood Markets and Coinbase Global and financial services business Fidelity National Information Services added to relative returns, while capital market holdings Affiliated Managers Group and Ameriprise Financial shares climbed higher by over 7% each. Within materials, CF Industries led the way, soaring 21% due to strong momentum in the fertilizer sector, driven by a tight global supply-demand balance. Staying in the sector, metals & mining holdings Reliance and Commercial Metals Company also performed well, rising 14% and 11% respectively. Sector allocation was mixed, with no exposure to communication services adding value to relative results, only to be offset by overweight exposure to consumer discretionary and healthcare.

Market development

US stocks finished January with a modest gain, despite headline-related volatility and a 2.59% intra-month drawdown. Energy was the standout sector, driven by the threat of supply disruption in the Middle East. Value outperformed growth across the capitalization spectrum, marking its third consecutive month of outperformance. The Federal Reserve held interest rates steady at their January 28 meeting, noting that economic activity had been expanding at a solid pace.

Expectation of fund manager

While geopolitical risk remains elevated, investors seem to be focusing on the strength of the US economy, moderating inflation, and earnings results and forecasts, all of which remain encouraging. We believe the growing divergence in performance between growth and value stocks could be a healthy development that could lead to a broader range of outcomes among sectors and individual securities – fertile ground for active, value-focused managers like us.

The portfolio is primarily comprised of stocks with a market capitalization between \$2 billion and \$53 billion. The fund's objective is to outperform the Russell Mid Cap Value index over a full market cycle.

Mr. Pollack is a Portfolio Manager of the Boston Partners Mid Cap Value Equity strategy. He joined Boston Partners in May 2000 from Hughes Investments where he spent 12 years as an equity portfolio manager, managing value equity across the market-cap spectrum. He also oversaw the outside investment managers who managed assets for Hughes' pension plan. Prior to assuming this role, he served as an investment analyst covering a variety of industries and sectors. Before that, he was with Remington, Inc., and Arthur Andersen & Co. Mr. Pollack is a graduate of Georgia Institute of Technology and earned an M.B.A. from The Anderson School of Management at the University of California at Los Angeles. He holds the Chartered Financial Analyst® designation. Mr. Pollack began his career in the investment industry in 1984. Mr. Collard is a Portfolio Manager of the Boston Partners Mid Cap Value strategy. Prior to this, he was an equity analyst with Boston Partners, specializing in the aerospace & defense, transportation, housing, and automobile sectors of the equity market. Mr. Collard joined the firm in April 2018 from Shellback Capital where he was a founding partner and equity analyst. Prior to that, he worked as a research analyst at Vinik Asset Management and Diamondback Capital Management. He began his career as an associate at the investment bank America's Growth Capital. Mr. Collard holds a B.A. in American Studies from Middlebury College. He began his career in the investment industry in 2005.
