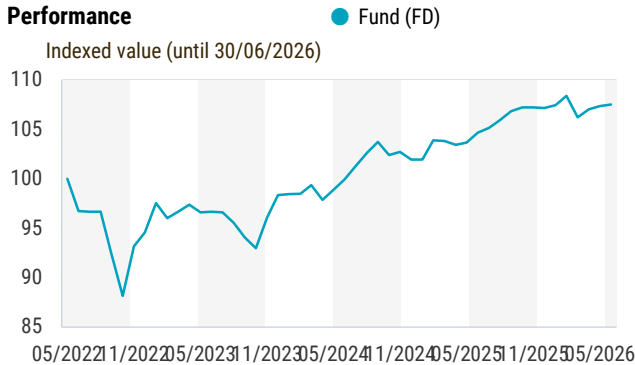

This is achieved by investing in entities that have credible emission reduction targets, entities that provide solutions to enable climate change mitigation and bonds to finance sustainability transformation or refinancing, in part or in full, new and/or existing projects with an environmental and/or social objective. The selection of these bonds is based on fundamental analysis. The fund's objective is to provide long-term capital growth.

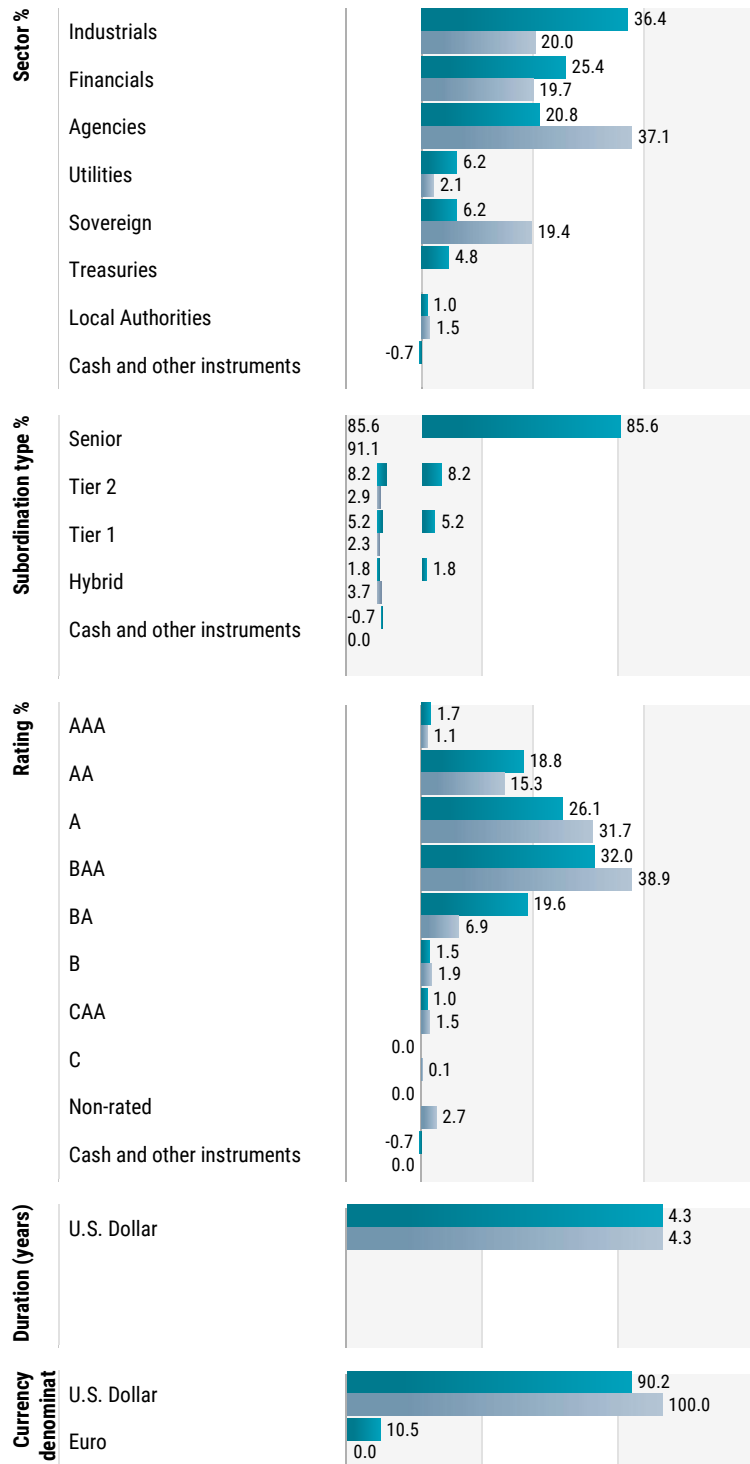

Performance commentary

Based on transaction prices, the fund's return was 0.16%.

Overweights in banking and utilities contributed to performance, while the overweight in consumer cyclicals and the underweight in property detracted. Underweights in Indonesia Sovereign, Tencent, and Petronas contributed positively, while overweights in MTR and Alibaba detracted from performance.

Market development

The dominant macro theme in June was a hawkish Fed pivot under new Chair Kevin Warsh. The June FOMC held rates at 3.50-3.75%, but nine of 19 officials penciled in at least one hike in 2026, while BofA forecast 75 basis points of cumulative tightening. Strong May payrolls reinforced rate-hike expectations and pushed 2-year US Treasury yields higher. Asia IG spreads briefly fell below 50 basis points for the first time on record, supported by compressed supply, strong Chinese demand and elevated all-in yields, before the Fed signal slowed primary activity. Bond supply was notable, led by Japan. NTT raised USD 10.4 billion in the largest Asian bond sale of the year, while Mizuho and SMFG lifted Japanese foreign-currency issuance to a record second-quarter level. Tencent also tapped the market through a sizeable dual-currency offering, adding to technology-sector supply following US issuance. China's NDRC move to discourage offshore high yield issuance above 4% should restrict supply from China, while India removed taxes on foreign bond investment, attracting record yen inflows. Asian corporate high yield default rates remain at cyclical lows.

Expectation of fund manager

We expect returns to remain primarily carry-driven, but with a wider range of outcomes as markets weigh persistent US inflation against lower oil prices following the US-Iran MOU. Warsh's hawkish tone and the June dot plot, which showed nine officials penciling in at least one hike in 2026, should keep Fed policy uncertainty elevated. Valuations are tight, with Asian IG spreads briefly trading through 50 basis points before primary activity improved. Technicals remain supportive, underpinned by compressed supply, strong Chinese demand and attractive all-in yields, although issuance is likely to stay selective after sizeable supply from NTT, Japanese financials and Tencent. China's NDRC restrictions on offshore issuance above 4% point to tighter financing for weaker LGFV-related borrowers. India's removal of taxes on foreign bond investment should support inflows and Indian credit, while Indonesia remains more vulnerable to softer demand, rupiah pressure and declining FX reserves. Fundamentals remain resilient, but we continue to favor BBB-BB credit, prefer financials, and remain cautious on cyclicals exposed to growth, energy costs or margin pressure.

Top 10 largest holdings

The top largest absolute positions in the sovereign bonds include Korea Housing Finance, MTR Corp and Biocon, an Indian Biosimilar pharmaceutical company.

Sector allocation

In our portfolio management, we not only factor in weights, but also spreads and durations (DTS). On that basis, the largest underweights are in sovereigns and state-owned enterprises. These issuers have experienced significant spread tightening and fiscal risks are on the rise. Largest overweights are in banking, utilities, and communications. We have an overweight in South Korea and an underweight risk position in China, the Philippines and Malaysia driven by tight valuations. The property sector is underweighted, and we only have selective exposure to the sector as issuers remain exposed to idiosyncratic risks, especially in Mainland China and Hong Kong.

Currency denomination allocation

Our exposure by currency of denomination may be driven by relative value between the markets on an aggregate level but is more typically the result of sector themes and issuer selection. All non-base currency exposure is hedged back to the benchmark by default.

Duration allocation

We steer the fund's duration within a bandwidth of 0.25 years versus the reference index.

Rating allocation

Our positioning across the different rating buckets is the result of beta positioning, sector themes, and issuer selection.

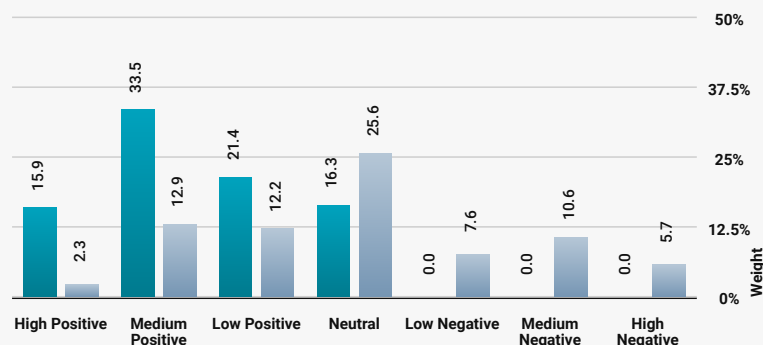
Subordination allocation

In the allocation to the capital structure, we favor the bonds with solid risk-adjusted performance potential while taking into account the beta, sector themes, and the credit cycle. We prefer shorter-dated senior bonds. Within subordinated bonds, we favor Tier-2 over Tier-1 bonds.

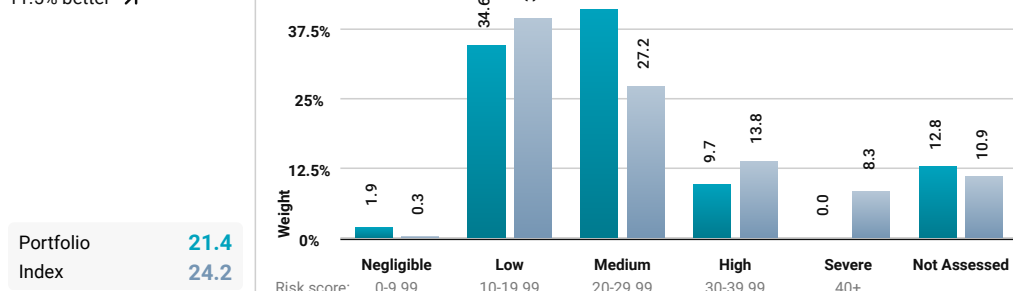

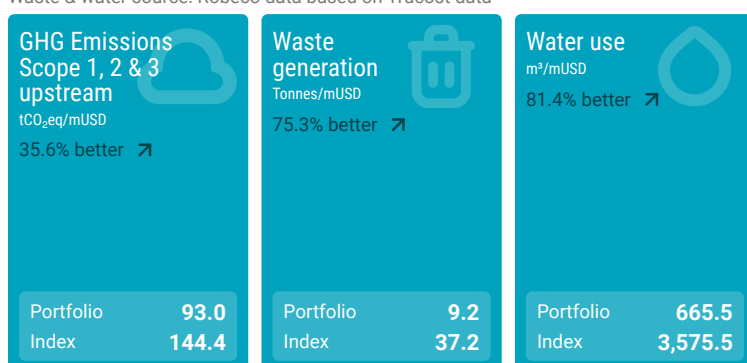

Reference

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Only holdings mapped as corporates are included in the figures.

3. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

4. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg.
