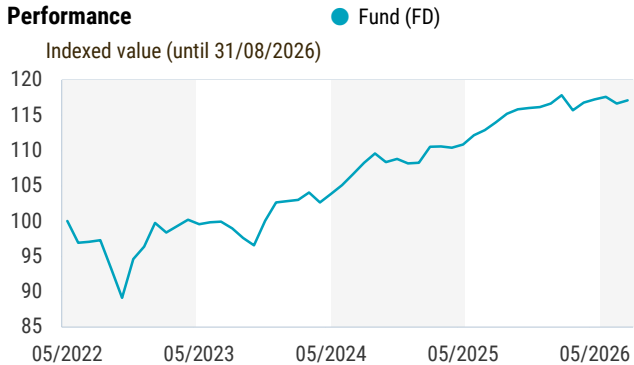

This is achieved by investing in entities that have credible emission reduction targets, entities that provide solutions to enable climate change mitigation and bonds to finance sustainability transformation or refinancing, in part or in full, new and/or existing projects with an environmental and/or social objective. The selection of these bonds is based on fundamental analysis. The fund's objective is to provide long-term capital growth.

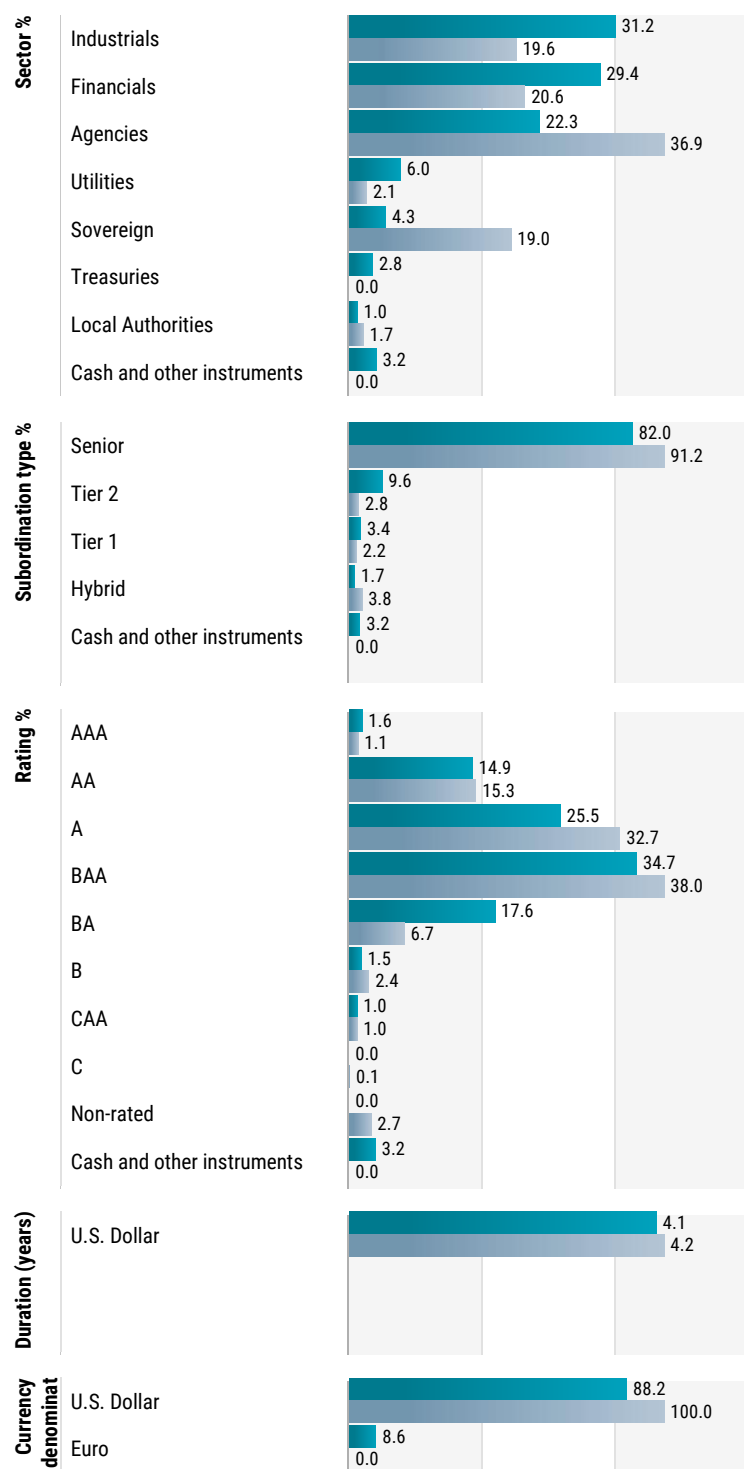

Performance commentary

Based on transaction prices, the fund's return was 0.39%.

Underweights in Indonesia and the Philippines detracted from performance, while overweights in India contributed. On a sector level, overweights in utilities contributed to performance while overweights in banks detracted from performance. At the issuer level, overweights in Sorik Marapi Geothermal and Bank Negara Indonesia contributed positively, while underweights in bonds of the Republics of Indonesia and the Philippines detracted from relative performance.

Market development

August's returns in Asia hard currency fixed income markets were supported mainly by spread tightening, alongside a modest treasury return. The 5-year US Treasury yield rose 9 bps and the 10-year 1 bps, while the Asia credit spread tightened 4 bps to 83 bps. EM corporate high yield returned 1.08% and continued to outperform investment grade (0.33%), reflecting continued compression in lower-rated credits. US Treasury rate volatility defined the macro backdrop. The 30-year Treasury yield briefly reached 5.31%, its highest level since mid-2007 driven by elevated fiscal concerns and record US IG issuance. Near month-end, Federal Reserve Chair Warsh delivered a hawkish speech at Jackson Hole. Despite this, Asia credit spreads proved resilient. Indian banks accelerated offshore fundraising, after the RBI introduced special FX swap facilities to encourage FCNR(B) deposits and foreign-currency borrowing. Relatively contained Asia net supply continued to provide a supportive technical backdrop.

Expectation of fund manager

We expect Asian credit returns to remain primarily carry-driven, but with a wider range of outcomes as interest rates rather than spreads set the tone. With Asian IG spreads close to historic tights, there is limited cushion against a further rates shock, and Fed policy uncertainty should keep duration the dominant swing factor. Spreads are therefore likely to remain range-bound, with a bias toward episodic widening rather than sustained tightening. Technicals may turn less supportive: supply in both DM and Asia typically accelerates sharply in September, and with US IG issuance running at record pace, associated rate volatility is likely to remain elevated around Fed policy uncertainty. Renewed Middle East escalation remains the clearest spread risk, with higher-beta issuers most exposed. Fundamentals start from a solid base, supported by moderate leverage, stable cash flows and contained default expectations. We continue to favor BBB-BB credit over lower-rated high yield (where dispersion is likely to remain high), prefer financials (where capital and asset quality remain strong), and remain cautious on cyclical exposure to growth, energy costs or margin pressure.

Top 10 largest holdings

Our top largest absolute positions include NBN, MTR Corp and CAS Holding.

Sector allocation

In our portfolio management, we not only factor in weights, but also spreads and durations (DTS). On that basis, the largest underweights are in sovereigns. These issuers have experienced significant spread tightening and fiscal risks are on the rise. Largest overweights are in banking, utilities, and communications. We have underweight risk position in Indonesia, the Philippines and Malaysia, driven by tight valuations. The property sector is underweighted, and we only have selective exposure to the sector as issuers remain exposed to idiosyncratic risks, especially in Mainland China and Hong Kong.

Currency denomination allocation

Our exposure by currency of denomination may be driven by relative value between the markets on an aggregate level but is more typically the result of sector themes and issuer selection. All non-base currency exposure is hedged back to the benchmark by default.

Duration allocation

We steer the fund's duration within a bandwidth of 0.25 years versus the reference index.

Rating allocation

Our positioning across the different rating buckets is the result of beta positioning, sector themes, and issuer selection.

Subordination allocation

In the allocation to the capital structure, we favor the bonds with solid risk-adjusted performance potential while taking into account the beta, sector themes, and the credit cycle. We prefer shorter-dated senior bonds. Within subordinated bonds, we favor Tier-2 over Tier-1 bonds.

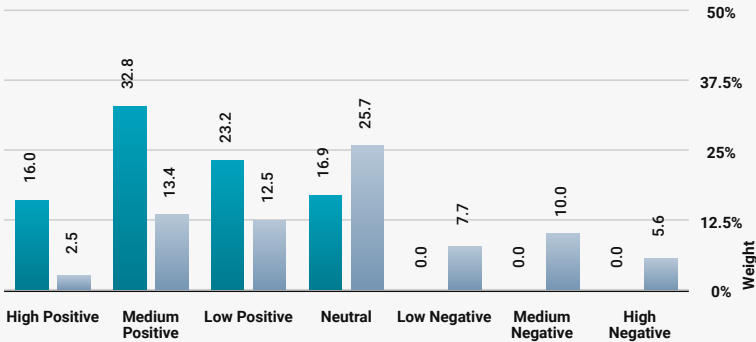

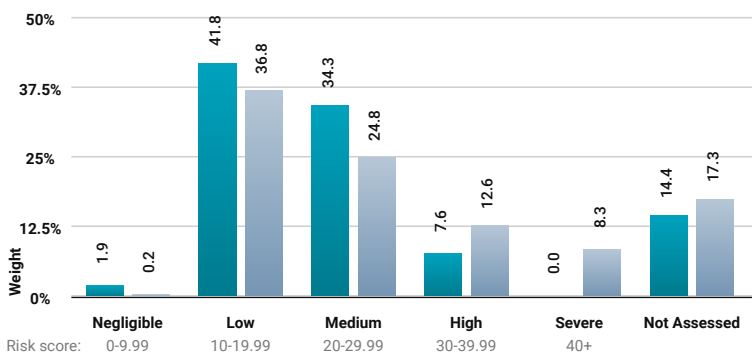

ESG Labeled Bonds ³

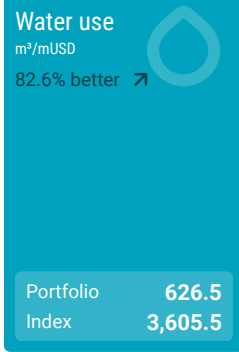
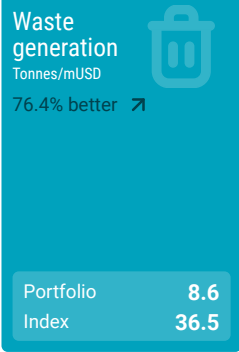
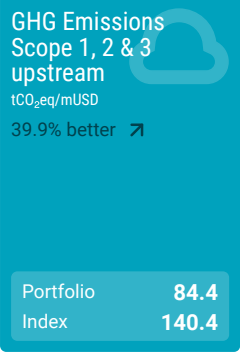

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Only holdings mapped as corporates are included in the figures.

3. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

4. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
