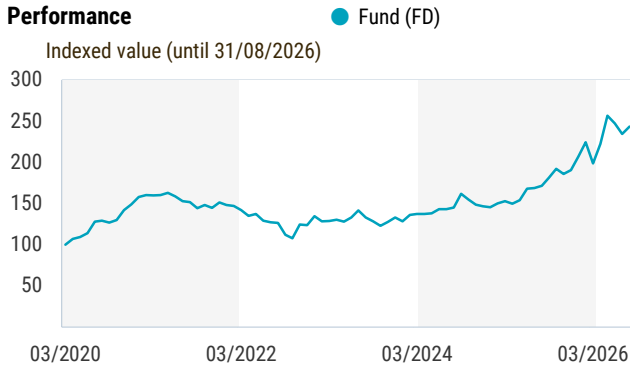

Robeco Sustainable Asian Stars Equities is an actively managed fund that invests in stocks of the most attractive companies in Asia. The selection of these stocks is based on fundamental analysis. The fund's objective is to achieve a better return than the index. The fund selects investments based on a combination of top-down country analysis and bottom-up stock ideas. The reference to "Stars" in the name of the fund refers to an approach whereby only the most attractive companies (in terms of actual and/or potential capital gains and/or generation of income and/or growth) are selected. The fund aims at selecting stocks with relatively low environmental footprints compared to stocks with high environmental footprints.

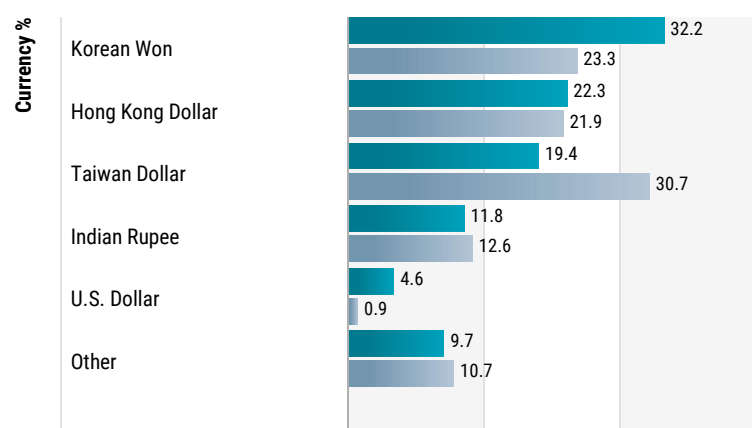
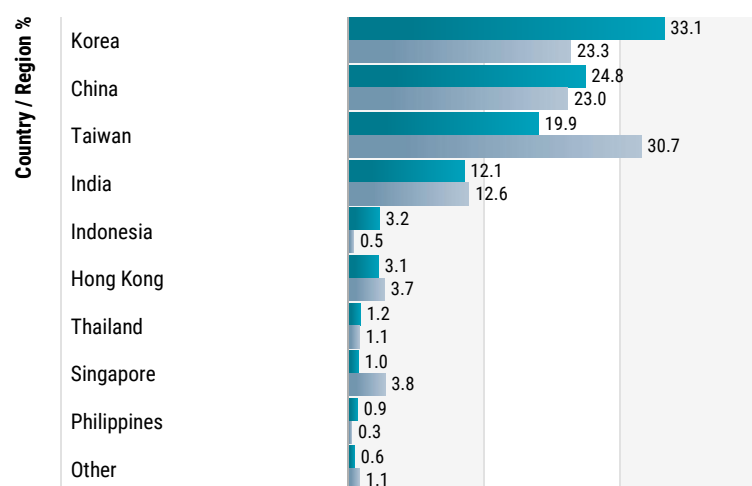
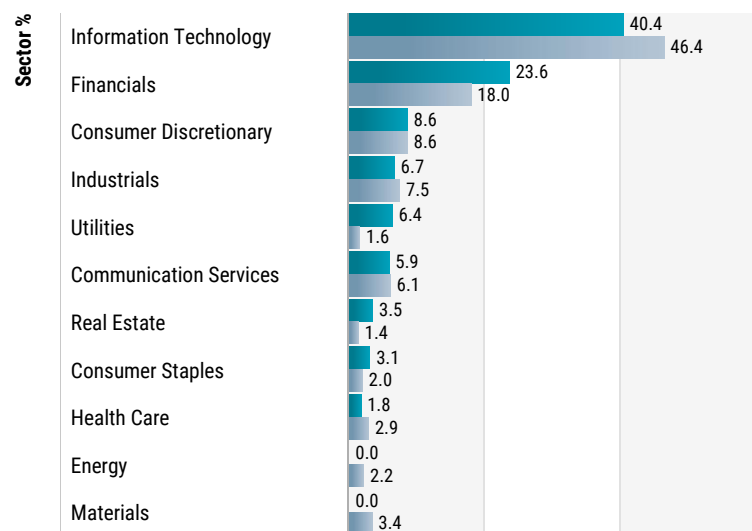

Performance commentary

Based on transaction prices, the fund's return was 3.75%.

In August, Robeco Sustainable Asian Stars underperformed versus the index. Indonesia was the main positive contributor, but China and Taiwan detracted. In terms of sectors, stock selection was positive in IT but detracted in industrials and financials.

Market development

Asian markets recovered 3.3% in August, following July's slump. While the AI theme received some endorsement from earnings by large players (e.g., NVIDIA), markets grew increasingly focused on bond yields over the month, as global bond yields soared to decades highs. The 10-year JGB yield reached 3% – a 30-year high. The combination of US government interventions related to JPY and US Treasuries, together with the Fed's stance on inflation, drove moves across the US Treasury yield curve, the US dollar, and commodities. Materials (+9.9%) was therefore the best-performing sector in the region last month, supported by a surge in both gold and copper prices. While less strong than materials, IT (+4.8%) also contributed positively to Asia's performance, with tech hardware outperforming semiconductors.

Expectation of fund manager

Absolute and relative valuations remain compelling, earnings revisions are still supportive, and the region continues to offer differentiated structural growth opportunities. However, the combination of a sharp rebound, elevated energy prices and narrowing market leadership reinforces the importance of vigilance – closely monitoring earnings delivery, managing concentration risk, and diversifying sources of alpha within portfolio construction. We focus on bottom-up stock picking and on companies with a good sustainability profile, solid cash flow generation, trading at a good price and having positive momentum.

Top 10 largest holdings

We like sustainable companies with solid cash flow generation, trading at a good price, having positive momentum and a low environmental footprint. We like the technology enablers in Asia that can help enhance energy efficiency and realize exciting applications such as autonomous driving, Internet of Things and artificial intelligence. SK hynix, TSMC and KT Corp are the best exposures in our view. We like banks in countries where we can expect structural growth through financial inclusion as well as strong fintech capabilities. ICICI Bank, Bank Rakyat and Huatai Securities are examples of that. Asian companies have a strong presence in the smart mobility supply chain globally; Hyundai Mobis and Chroma ATE are great exposures with re-rating potential. Healthy living is a long-term theme for the growing middle class in Asia. Tencent and Alibaba are such exposures. Companies involved in renewable energy with good value and positive earnings revision such as China Datang Renewables and Nari Technology are also large holdings in our portfolio.

Sector allocation

The Asia Pacific investment backdrop remains constructive but nuanced heading into September. The AI-driven capex cycle continues to anchor the technology and semiconductor thematic, with US hyperscaler capital expenditure guidance now approaching USD 758 billion for 2026 – a powerful and sustained demand signal for South Korea, Taiwan and the broader Asia Pacific supply chain. Asia sits at the center of this investment wave, with the region capturing an outsized share of the picks-and-shovels spending on semiconductor wafer fabrication, advanced packaging, power electronics and data center infrastructure.

Country / Region allocation

Our portfolio's country exposure arises from a bottom-up approach to stock selection. China, South Korea, and India hold significant weight in our investments. China offers a wealth of companies in clean energy, electric vehicles, and technology, making it a pivotal theme in our portfolio. The country is actively transitioning its policy to support growth, so we concentrate on sustainable beneficiaries while avoiding areas prone to policy intervention. South Korea's corporate governance reform agenda has gained market recognition. We anticipate more concrete actions will unfold in the coming months, though earnings cyclicality will be a litmus test for shareholder return improvement in South Korea. India and Indonesia showcase numerous long-term growth themes such as financial inclusion and energy transition. We target robust companies capable of delivering positive earnings revisions at reasonable valuations. Additionally, we favor Vietnam due to its positive long-term earnings growth prospects combined with low valuations, although tariff uncertainties could lead to slower growth in the near term.

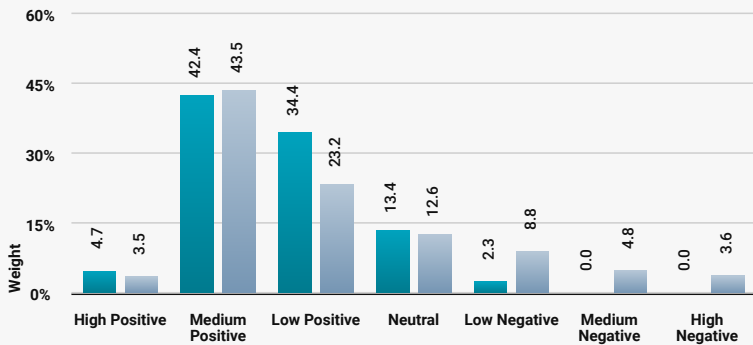

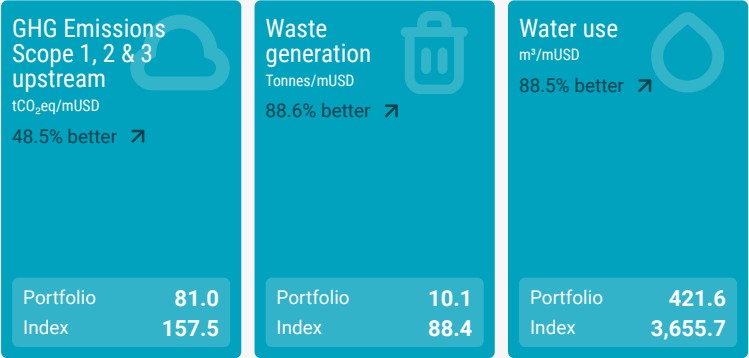
SDG Impact Alignment ¹

Environmental Footprint ²

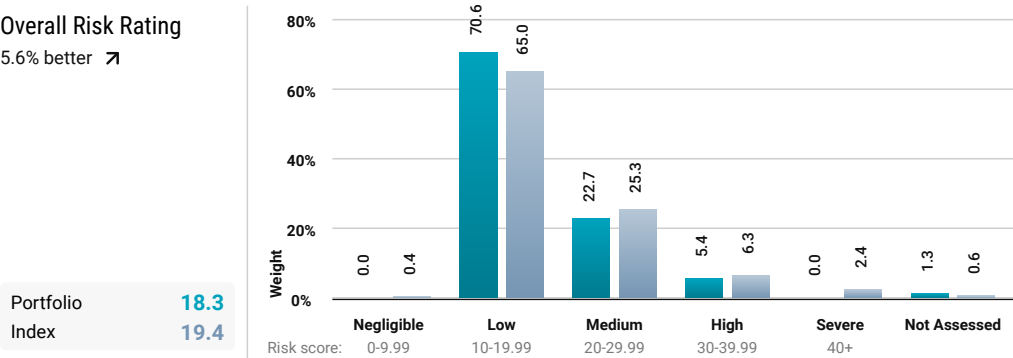

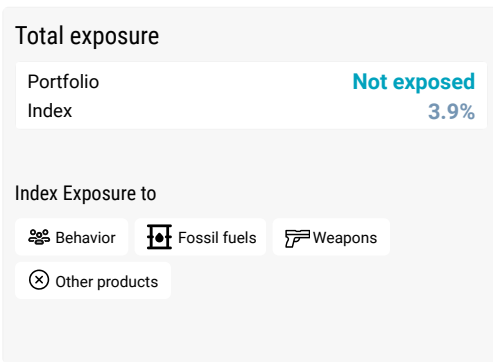

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Fiscal product treatment
