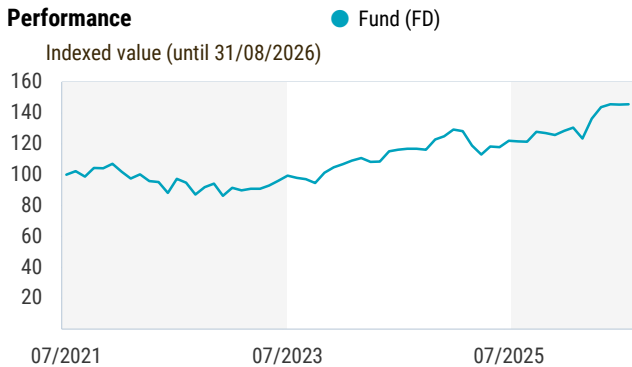

Robeco Global Engagement Equities is an actively managed fund that invests in a concentrated selection of global stocks. Stock selection is based on fundamental analysis to invest in companies based on their contribution to the United Nations Sustainable Development Goals (UN SDGs). The fund actively engages with the invested companies and initiates a dialogue to motivate these companies to improve their fulfilment of the UN SDGs over three to five years. The portfolio is built on the basis of an eligible investment universe and an internally developed SDG framework for mapping and measuring SDG contributions (information can be obtained via the website www.robeco.com/si). The fund also aims to achieve a better return than the index.

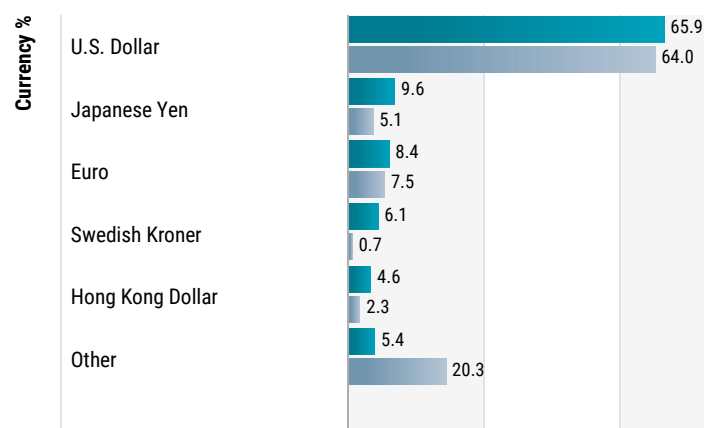
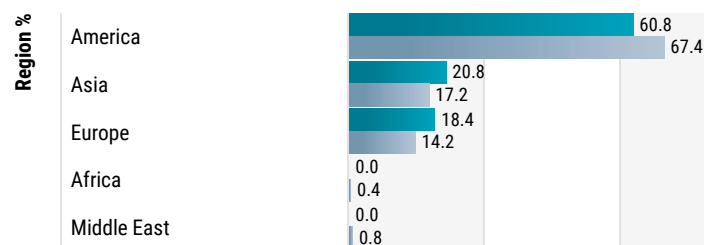
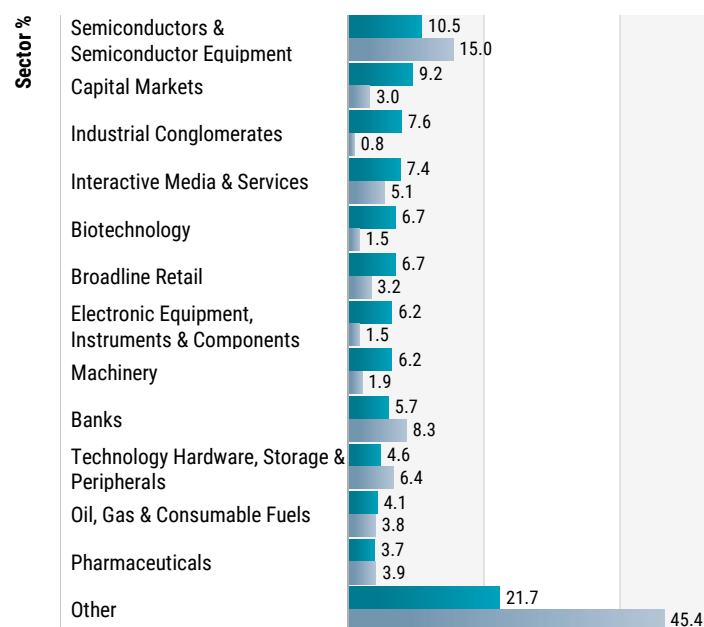

Performance commentary

Based on transaction prices, the fund's return was 0.09%.

The portfolio had a challenging month and underperformed versus its benchmark. Financials contributed positively, with Deutsche Börse benefiting from its sensitivity to energy prices. Industrials also performed well, as Sandvik strengthened following further order wins and rebounded from a weaker July. Information technology was the largest detractor. Strong quarterly results needed to be accompanied by impressive guidance to reassure markets. NVIDIA's closely watched results supported the stock but didn't prompt a broader rally among AI names. Broadcom was the portfolio's largest technology detractor, reacting negatively to news that Marvell had reached an agreement with Google to expand its TPU ecosystem. Broadcom is due to report results in early September.

Market development

August was shaped by geopolitical turbulence. The US-Iran war escalated, while stringent economic sanctions increased uncertainty over energy supply and pushed oil above USD 90 by month-end. Trade tensions resurfaced following the collapse of the US-Canada trade deal and renewed threats of additional tariffs on China. Despite this challenging backdrop, a positive earnings season supported equities, and markets moved higher before coming under pressure toward the end of the period. Concerns about new AI-related debt issuance and increasingly hawkish central banks pushed bond yields higher and equities lower. Against this backdrop, value cyclical made a comeback, while longer-duration assets came under pressure.

Expectation of fund manager

AI will remain the market engine, supported by enormous capital-expenditure plans and rising earnings. However, the AI complex is increasingly debt-funded and circular, contributing to higher bond yields. The bond market is therefore a key swing factor. Earnings growth provides an airbag, but growth at this pace risks reviving inflation. With the narrative shifting from rate cuts toward possible hikes, rising yields could create headwinds for expensive growth stocks and cap valuations. Risks include a longer and harsher US-Iran conflict and another oil price spike. The sharp drawdown in many AI leaders also opens the door to broader market participation. Management therefore foresees a comeback in portfolio diversification and quality, including free-cash-flow yield as a valuation safety net.

Top 10 largest holdings

The top ten active positions are Sumitomo Mitsui Financial Group, Advanced Micro Devices, Hitachi, Banco BTG Pactual, Novartis, SK Square, AbbVie, Sandvik, Jabil and Broadcom. Sumitomo Mitsui's diversified business mix supports resilient earnings and multiple opportunities for long-term growth. AMD is well positioned to gain market share and benefit from secular AI and cloud-infrastructure growth. Hitachi's exposure to electrification, grid investment and mission-critical infrastructure positions it to benefit from long-term structural growth trends.

Sector allocation

We do not aim to have large deviations on a sector level. There are sectors where the SDG scores tend to be higher (such as in healthcare, for instance). In those sectors, it may be harder to find candidates for the fund. We are underweight in utilities, which tend not to fit the philosophy of the fund (high ROIC/FCF).

Regional allocation

We have an overweight in Europe and in emerging markets, and are underweight in North America. The regional deviations are largely the effect of bottom-up stock picking.

Currency allocation

We aim to have our performance attribution come from bottom-up stock picking and less so from sector allocation or country allocation.

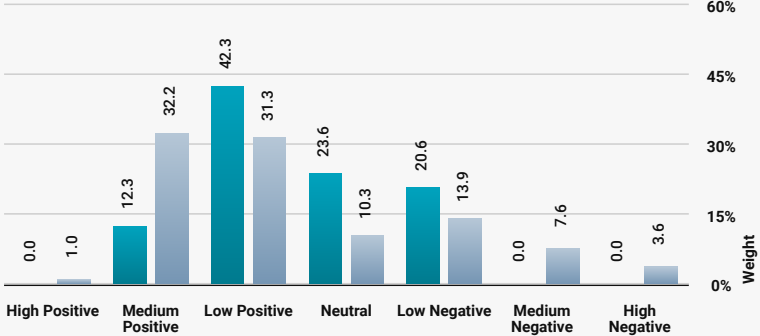

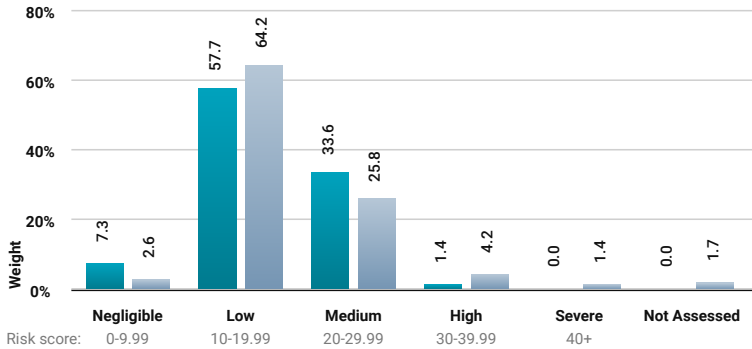

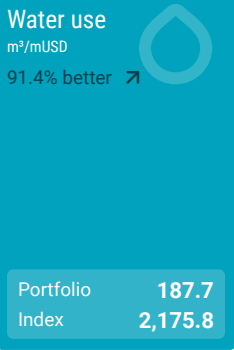

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. 4. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated into the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes.
