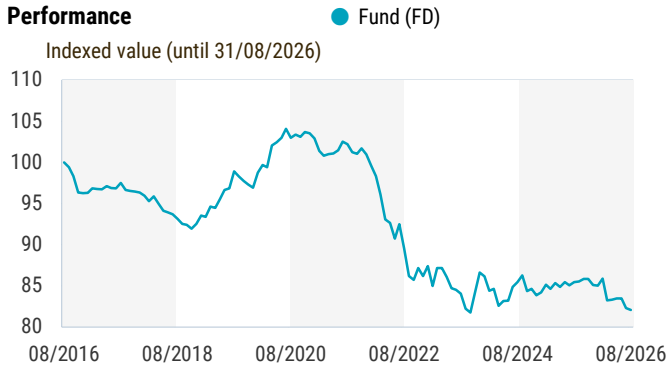

The selection of these bonds is based on fundamental analysis. The fund's objective is to provide long term capital growth. The fund will pursue an active duration policy with the objective to limit draw downs when bond yields rise and enhance returns when bond yields fall.

Performance commentary

Based on transaction prices, the fund's return was -0.26%.

The fund posted a negative return in August, slightly underperforming versus the benchmark. Duration positioning added to performance over the month, particularly the fund's underweight in Japanese government bonds, as yields rose amid stronger inflation expectations and increased expectations of further Bank of Japan rate hikes. Spread positioning in Eurozone countries contributed positively, while the fund's underweight allocation to MBS securities detracted as the sector benefited from tighter spreads amid improving technical conditions.

Market development

Government bond returns were mixed in August. 10-year US Treasury yields rose modestly by 2 basis points to 4.75%, while German Bund yields increased by 12 basis points to 3.32%. Bond markets remained focused on developments in the US-Iran conflict and their implications for oil prices. In the Eurozone, economic growth appeared somewhat stronger than expected, supported by upside surprises in German PMI data and improving consumer confidence. In the US, signs emerged that the labor market strength was fading, as July payrolls turned negative. Treasury secretary Scott Bessent announced a government bond debt buyback program, as according to him long-dated bond yields did not reflect fundamentals. Although yields did decline after the announcement, this lasted only for a few days. Toward the end of the month, Fed Chair Warsh delivered a hawkish speech at Jackson Hole, emphasizing resilient US growth and persistent inflationary pressures.

Expectation of fund manager

Monetary policy has been shifting toward tightening, as central banks respond to higher energy prices and the associated inflationary risks. For the Fed, we expect the September meeting to be a close call in favor of a hike, with important inflation and labor market data still to be released. Depending on oil prices and how long the Strait of Hormuz will effectively remain closed, an additional hike seems plausible before year-end. We expect the ECB to raise rates again by 25 basis points in September. Thereafter, rate hikes will be highly dependent on energy prices, and whether second round price effects from higher gas prices, which have remained absent thus far, will lead to a prolonged period of higher inflation. Within European sovereign markets, we continue to expect a wider dispersion of country spreads. French government bonds remain vulnerable to fiscal and political concerns ahead of the 2027 presidential election, while Spain is supported by stronger growth fundamentals and a more favorable fiscal outlook.

Sector allocation

The fund's allocation to SSA bonds remains above that of the benchmark, and the team has kept the positioning roughly stable over the month. Within the SSA allocation, we continue to have a clear preference for agencies and supranational bonds over local authority issuers. In particular, we continue to see value in long-dated EU issuance. Corporate bond exposure remains above index levels with the overweight concentrated in financial bonds and industrials, while exposure in utilities is below the index exposure. The fund has a 24% allocation to green, social and sustainable bonds, predominantly consisting of government-related issuers.

Duration allocation

The duration of the fund ended the period below the index level. We reduced duration over the month as elevated oil prices, amid heightened US-Iran tensions, reinforced concerns around inflation. The fund remains overweight in Europe, Australia, and the US, while being underweight duration in China, Japan, Sweden, New Zealand, and Canada.

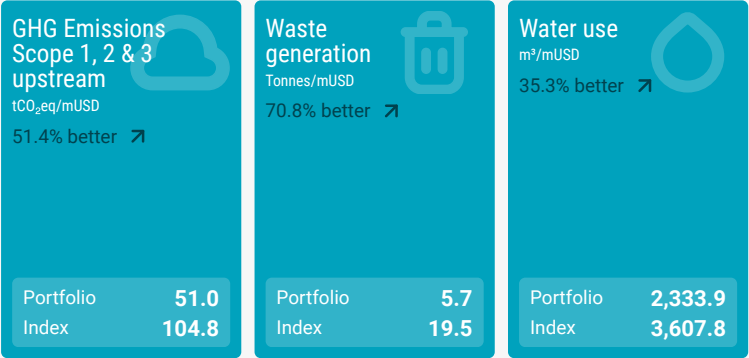

Environmental Footprint ²

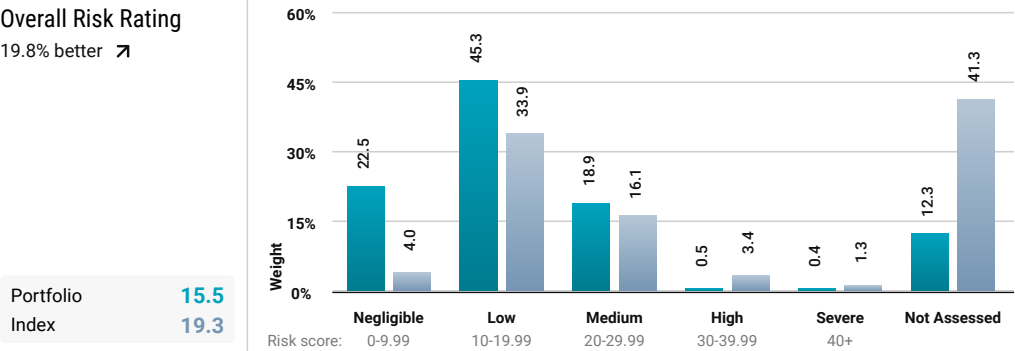

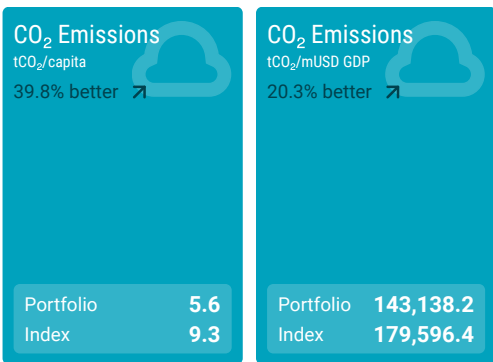

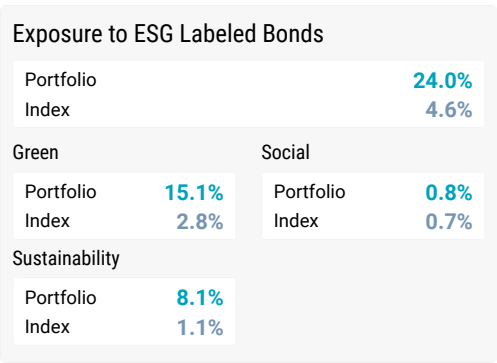

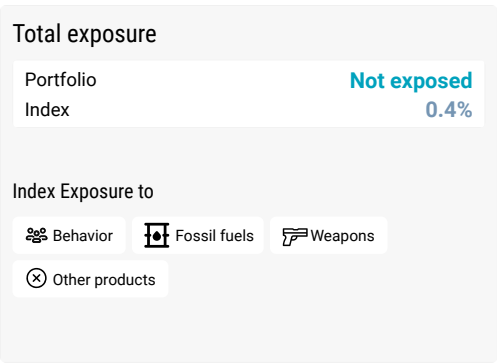
ESG Labeled Bonds ⁵

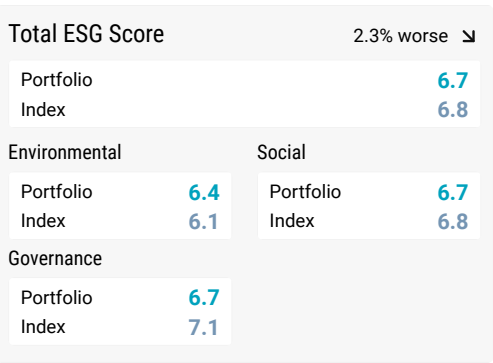

Reference

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

3. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Only holdings mapped as corporates are included in the figures.

4. Environmental Intensity

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Only holdings mapped as sovereign bonds are included in the figures.

5. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

6. Exclusions

7. Country Sustainability Ranking

The visual displays the portfolio's scores following Robeco's Country Sustainability Ranking methodology. These are calculated using the portfolio components' weights and respective country's scores. The scores includes considerations of more than 50 separate indicators, each capturing a unique sustainability feature across environmental, social and governance dimensions at the country level. Only holdings mapped as sovereign bonds are included in the figures.

8. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

The fund aims to deliver an attractive total return, also on a risk-adjusted basis. The fund targets an ex-ante total return volatility within the range of 2 to 6% and can adjust the duration of the portfolio between 0 and 10 years. The leverage exposure of derivatives on a fund level is restricted as described in the prospectus.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.01% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

Investors who are not subject to (exempt from) Dutch corporate-income tax (e.g. pension funds) are not taxed on the achieved result.
