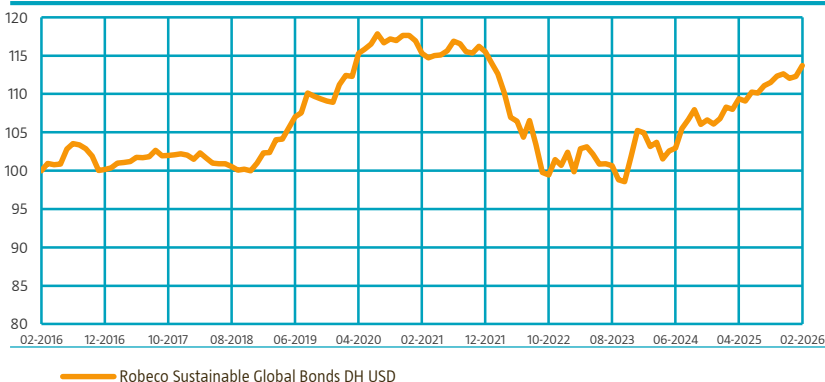

Performance

Based on transaction prices, the fund's return was 1.26%.

The fund posted a positive return in February, while slightly underperforming versus the index. The overweight duration position was the main contributor to returns. As yields rallied significantly over the month, the fund's duration overweight was gradually reduced in the later weeks. Curve positioning detracted from performance, as stronger data and reduced expectations for near-term Fed cuts pushed short-term US yields higher and the curve flattened. Additionally, European country spread positioning weighed on performance, as spreads widened from the lows, especially in the last few days of the month.

Market development

Government bond returns were positive over February. 10-year US Treasuries ended the month 30 basis points lower at 3.94%, while the German Bund rallied by 20 basis points to 2.64%. In the UK, Gilts also rallied by 29 basis points to 4.23%. US Treasuries performed well over February, as US labor market data disappointed at the beginning of the month. US job openings surprised to the downside and unemployment claims were somewhat higher than expected. The US Supreme Court struck down the Trump administration's IEEPA tariffs. In response, the US president invoked a 10% global tariff rate under a different law. In Europe, the February ECB meeting showed that the central bank is not in a rush to change rates, with president Lagarde downplaying the importance of the recent strength in the euro. Toward the end of the month, yields globally continued to move lower in response to a possible US attack on Iran. European periphery spreads were mostly unchanged over the month.

Expectation of fund manager

Despite the neutral near-term guidance from the Fed, we continue to expect at least two additional 25 bps cuts this year. This outlook is premised on renewed signs of labor market cooling and a more dovish FOMC composition. May will likely be the first meeting chaired by Kevin Warsh. We then expect the Fed's easing bias to become more pronounced. For the ECB, we expect them to either keep rates unchanged in our base case for the upcoming quarters or potentially cut policy rates in response to an external shock. Peripheral bond spreads over Germany can continue to converge in a broader risk-friendly market environment. While the build-up of US military assets in the Middle East drove the bid in duration over past weeks, any further escalation could disrupt global oil supplies, particularly if tanker traffic through the Strait of Hormuz is impeded. This could potentially have the reversed effect, with bond yields selling off instead.

The fund aims to deliver an attractive total return, also on a risk-adjusted basis. The fund targets an ex-ante total return volatility within the range of 2 to 6% and can adjust the duration of the portfolio between 0 and 10 years. The leverage exposure of derivatives on a fund level is restricted as described in the prospectus.

Dividend policy

All income earned is accumulated and not distributed as dividend. Therefore the total return is reflected in the share price development.

Changes

This share class shows performance information prior to its launch date. On the launch date of this share class, the fund absorbed Robeco Global Total Return Bond Fund. Performance prior to the launch date has been simulated on the basis of the past performance of the absorbed fund that had similar investment policy and applied comparable charges.

Sector allocation

The fund's allocation to SSA bonds remains above that of the benchmark, and the team has added to the positioning over the month as we sought to reduce our underweight in French agencies. Within the SSA allocation, we continue to have a clear preference for agencies and supranational bonds over local authority issuers. In particular, we see value in long-dated EU issuance. Corporate bond exposure remains above index levels with the overweight concentrated in financial bonds, while exposure in utilities and industrials is below the index exposure. The overall credit beta of the portfolio has increased to two since last month, while the credit beta ended the month around 1.87, mainly due to increased allocation to emerging market hard currency bonds. The fund has a 25% allocation to green, social and sustainable bonds, predominantly consisting of government-related issuers.

Duration allocation

The duration of the fund ended the period slightly above the index level. The fund remains overweight in Europe, Australia, Sweden and the UK and underweight duration in China, Japan, New Zealand, and Canada. The fund is also positioned for a further normalization (steepening) of curves in the UK, Europe, and the US. In Japan, we added to our curve-flattened positions in anticipation of more BoJ hikes getting priced in. During the month, the fund added to long duration positioning in Hungarian rates, as recent polling has shown strong support for the opposition and we believe that a regime change in Hungary would result in a substantial rally in local currency bonds from this point.

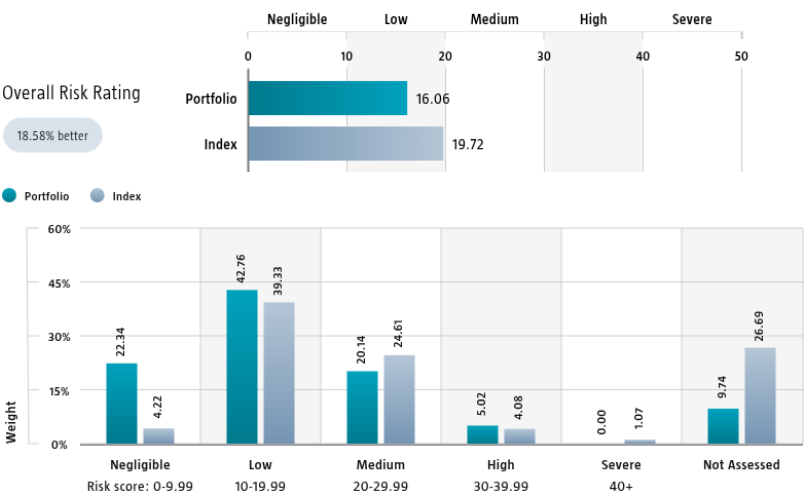

Sustainability

The fund incorporates sustainability in the investment process via exclusions, negative screening, ESG integration, limits on investments in companies and countries based on ESG performance as well as engagement and a minimum allocation to ESG-labeled bonds. The fund invests a minimum of 20% in green, social, sustainable and/or sustainability-linked bonds. For credits, the fund does not invest in companies that are in breach of international norms and applies the activity-based exclusions of Article 12 of the EU regulation on Climate Transition Benchmarks, EU Paris-aligned Benchmarks and sustainability-related disclosures for benchmarks through exclusions as per Robeco’s exclusion policy. ESG factors are integrated in the bottom-up security analysis to assess the impact on the issuer’s fundamental credit quality. In the credit selection the fund limits exposure to issuers with an elevated sustainability risk profile. Where issuers are flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement. The fund’s investments consist of a minimum of 30% of corporate and government related bonds, including the EU, that have a SDG rating of 1 or higher and the average corporate SDG rating is better than the average corporate SDG of the General Market Index. The Corporate carbon footprint is better than the weighted average footprint of the General Market Index. For government and government-related bonds, the fund complies with Robeco’s exclusion policy for countries, excludes the 15% worst ranked countries following the World Governance Indicator ‘Control of Corruption’, and ensures investments have a minimum score of 4.5 on the Robeco Country Sustainability Ranking, and the weighted average score is better than the weighted average score of the benchmark. The Fund’s weighted government carbon footprint is better than the weighted footprint of the General Market Index.

Sustainalytics ESG Risk Rating

The Portfolio Sustainalytics ESG Risk Rating chart displays the portfolio’s ESG Risk Rating. This is calculated by multiplying each portfolio component’s Sustainalytics ESG Risk Rating by its respective portfolio weight. The Distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics’ five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Environmental Intensity - Government bond allocation

Environmental intensity expresses a portfolio’s aggregate environmental efficiency. The portfolio’s aggregate carbon intensity is based on the related country emissions. We divide each country’s carbon emissions, measured in tCO₂, by the population size or gross domestic product to obtain the country’s carbon intensity. The portfolio’s aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component’s intensity figure with its respective position weight. Index intensities are provided alongside the portfolio intensities, highlighting the portfolio’s relative carbon intensity. Only holdings mapped as sovereign bonds are included in the figures.

tCO₂/capita

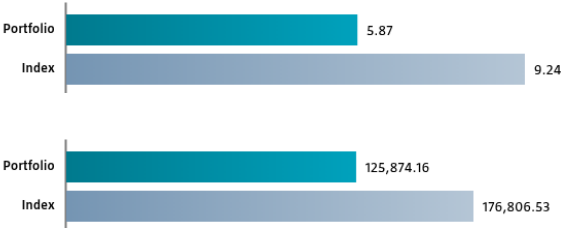

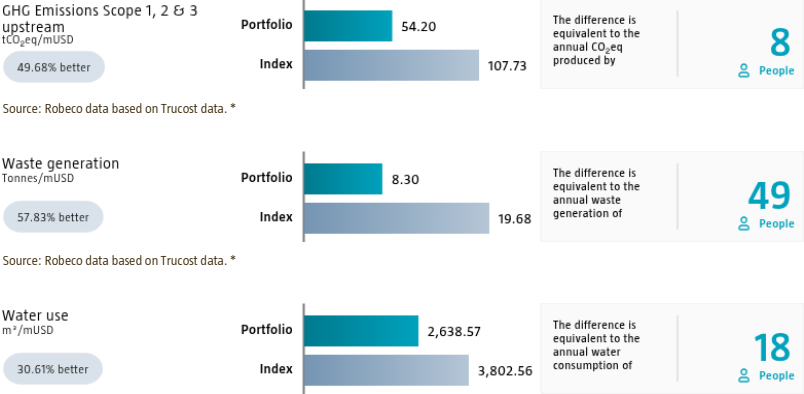

Environmental Footprint - Credit allocation

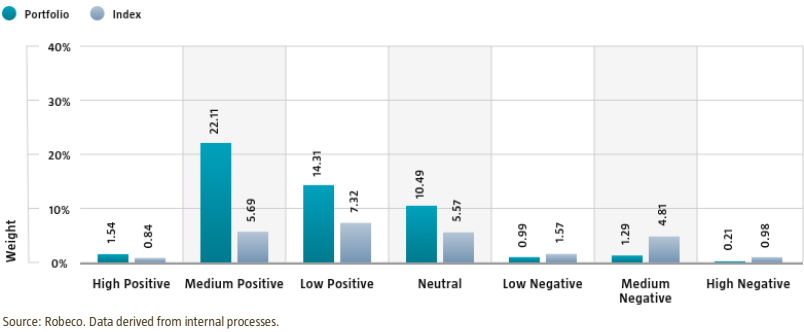
Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

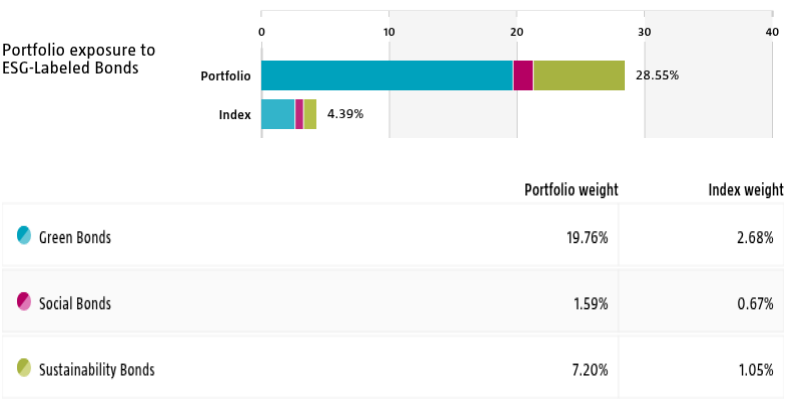
SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. This results in a 7-step scale from -3 to +3. 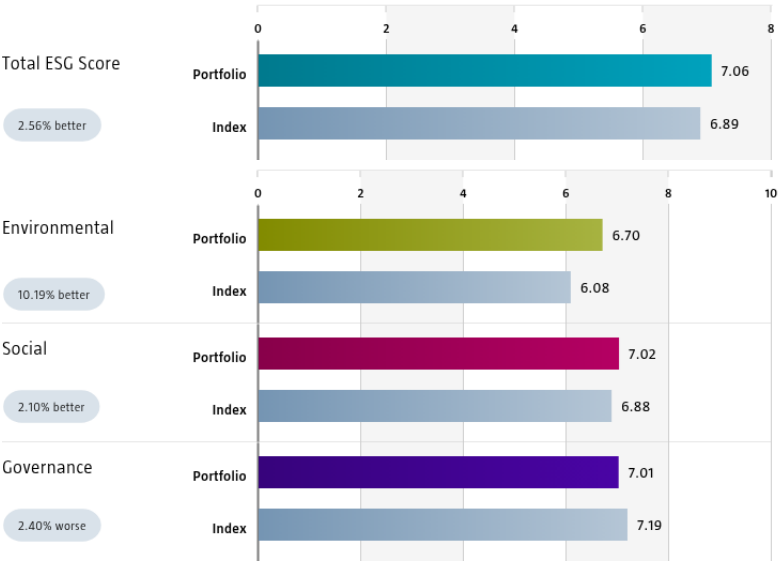
ESG Labeled Bonds

The ESG-labeled bond chart displays the portfolio's exposure to ESG-labeled bonds. Specifically, green bonds, social bonds, sustainability bonds, and sustainability-linked bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.



Country Sustainability Ranking

Engagement

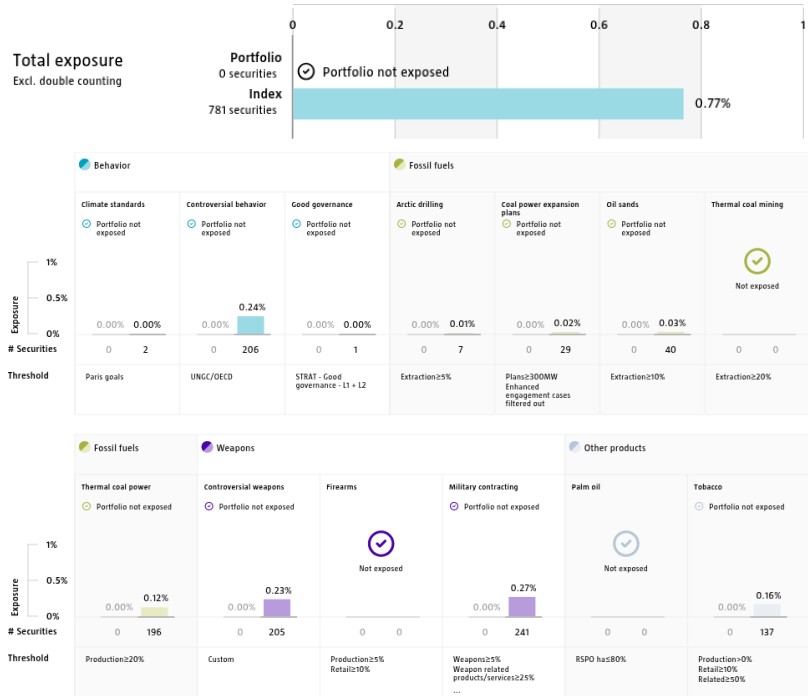
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The fund is a well-diversified global bond portfolio, which aims to achieve attractive returns by means of a top-down asset-allocation policy. The fund will pursue an active duration policy with the objective to limit draw downs when bond yields rise and enhance returns when bond yields fall. The fund promotes E&S (i.e. Environmental and Social) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation, integrates sustainability risks in the investment process and applies Robeco's Good Governance policy. The fund applies sustainability indicators, including but not limited to, normative, activity-based and region-based exclusions.

Key risks

Prior to joining Robeco in 2013, Stephan was employed by F&C Investments as a Portfolio Manager Fixed Income and worked in similar functions at Allianz Global Investors and A&O Services prior to that. Stephan started his career in the Investment Industry in 2003. He holds a Bachelor's in Financial Management, a Master's in Investment Management from VU University Amsterdam and is Certified European Financial Analyst (CEFA) Charterholder. Lauren Mariano is a portfolio manager and member of the Global Macro team. Prior to joining Robeco in 2024, she worked at Manulife as an analyst and as a fixed income portfolio management associate with a focus on sovereigns, currencies and macro-economic analysis. She started her career in the industry in 2017 at Manulife. She holds a Bachelor's in Finance from Bentley University and is a CFA® Charterholder.

The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation.
