# Robeco Sustainable Global Bonds ZH EUR

## Performance commentary

Based on transaction prices, the fund's return was 0.23%.

The fund posted a positive return in June. Duration strategies detracted from performance over the month, given the rise in US rates in response to the continued geopolitical uncertainty. EM local currency bonds boosted performance. The market-friendly outcome of the elections in Colombia and the subsequent rally in government bonds, as well as the continued positive momentum in Hungarian bonds contributed positively to performance. Spread positioning in Eurozone countries contributed positively, mainly due to resumed tightening of spreads in BBB-rated Greece and Bulgaria. The fund's underweight allocation to MBS detracted from performance in June vs the benchmark.

## Market development

Government bond returns were positive in June. 10-year US Treasury yields rose 3 basis points to 4.47%. The US yield curve flattened significantly, as 2-year US Treasury yields increased by 17 basis points, while the 30-year US Treasury yield declined by 2 basis points. German Bund yields declined 8 basis points to 2.86%, and the curve also flattened, albeit to a lesser extent. Throughout the month, oil prices trended lower as the US and Iran agreed on a memorandum of understanding and oil exports began to recover through the Strait of Hormuz. In the US, monthly labor market data showed a strong uptick in hiring, suggesting that the recent trend of labor market softening may be reversing. The June FOMC meeting, the first under Fed Chair Kevin Warsh, struck a hawkish tone, as the statement was significantly shortened and forward guidance was removed. In Europe, the ECB increased its deposit facility rate by 25 basis points to 2.25%, in line with market expectations. Preliminary June CPI releases across the Eurozone generally came in below consensus forecasts.

## Expectation of fund manager

In the US, the shift from markets pricing in rate cuts to anticipating a potential rate hike has led to a significant repricing of front-end yields, triggering notable moves across global government bond yield curves. For the Fed, we believe a rate hike can still be avoided, provided inflation continues to trend favorably in the near term. For the ECB, the risk of an additional 25 basis point rate hike in September remains, although this outcome is far from certain. Inflation appears to be easing somewhat faster than previously expected, largely supported by the recent decline in energy prices. Whether further tightening will be necessary will depend to a large extent on how energy markets evolve in the coming months. Looking ahead, monetary policy is increasingly likely to act as a headwind to economic growth. Within European sovereign spreads, we expect further divergence across countries. French government bond spreads are likely to remain under widening pressure, as investor focus shifts toward upcoming presidential elections and fiscal developments. By contrast, Spain continues to benefit from a more favorable economic backdrop, supporting its relative performance.

## Sector allocation

The fund's allocation to SSA bonds remains above that of the benchmark, and the team has kept the positioning roughly stable over the month, only incrementally increasing the overweight in EU bonds in the 10-year+ segment through participation in new issuance. Within the SSA allocation, we continue to have a clear preference for agencies and supranational bonds over local authority issuers. In particular, we continue to see value in long-dated EU issuance. Corporate bond exposure remains above index levels with the overweight concentrated in financial bonds and industrials, while exposure in utilities is below the index exposure. The fund has a 25% allocation to green, social and sustainable bonds, predominantly consisting of government-related issuers.

## Duration allocation

The duration of the fund ended the period above the index level. The fund remains overweight in Europe, Australia, and the US, while being underweight duration in China, Japan, New Zealand, and Canada. In June, we found valuations more attractive to position for normalization (steepening) in curves and reduced the flattening biases previously held in EUR and US curves, given the steady decline in oil prices seen throughout June. During the month, the fund added to long-duration positioning in Colombia, following the first round of voting, where the more market-friendly candidate won.

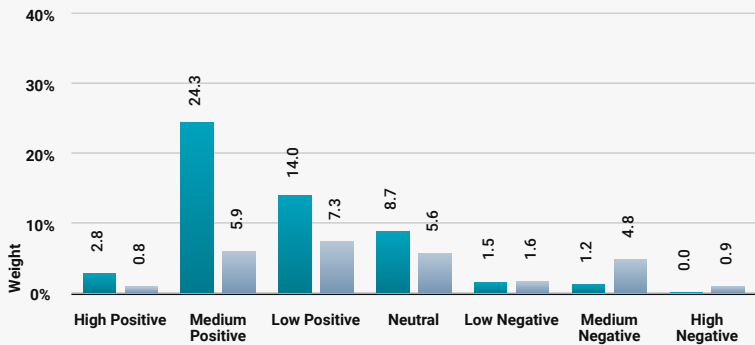

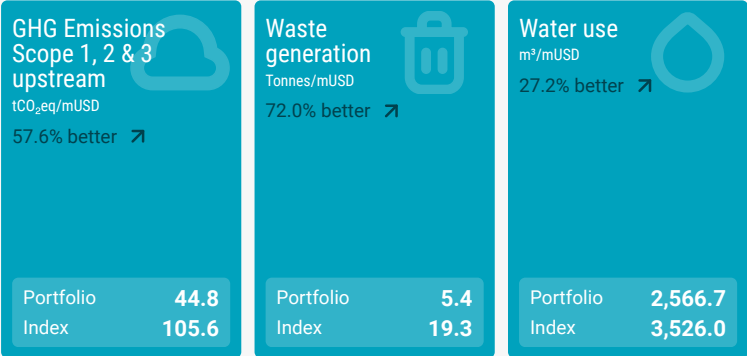
SDG Impact Alignment <sup>1</sup>

Environmental Footprint <sup>2</sup>

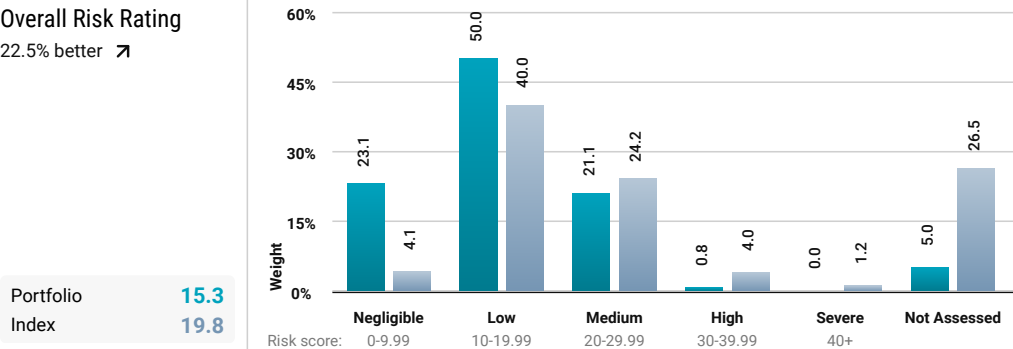

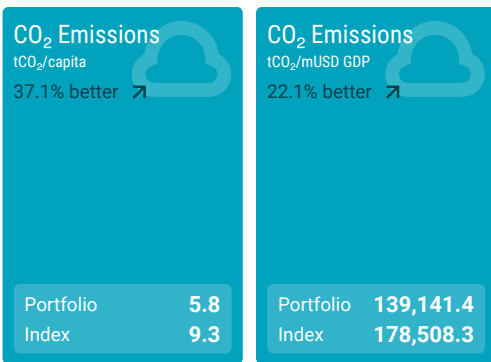

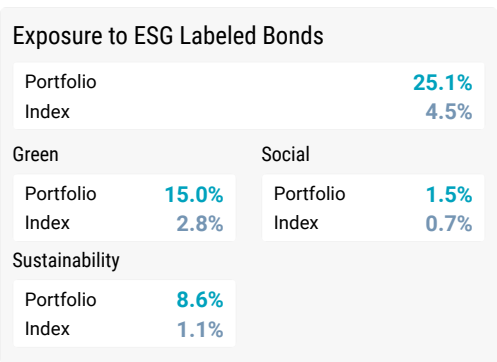

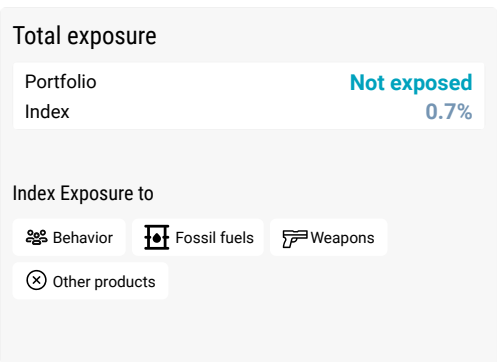

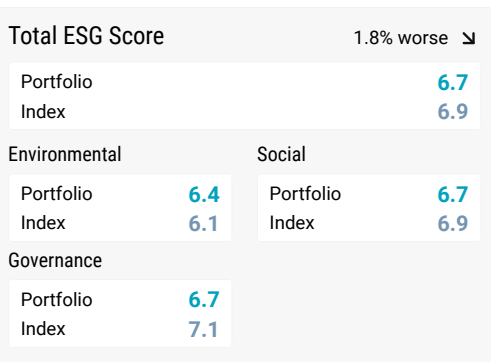

## Reference

### 1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

### 2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

### 3. Sustainalytics ESG Risk Rating

The chart displays the portfolio's Sustainalytics ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Only holdings mapped as corporates are included in the figures.

### 4. Environmental Intensity

Environmental intensity expresses a portfolio's aggregate environmental efficiency. The portfolio's aggregate carbon intensity is based on the related country emissions. We divide each country's carbon emissions, measured in tCO<sub>2</sub>, by the population size or gross domestic product to obtain the country's carbon intensity. The portfolio's aggregate intensity figures are calculated as a weighted average by multiplying each assessed portfolio component's intensity figure with its respective position weight. Only holdings mapped as sovereign bonds are included in the figures.

### 5. ESG Labeled Bonds

The visual displays the portfolio's exposure to ESG-labeled bonds. This is calculated as a sum of weights for those bonds in the portfolio that have one of above mentioned labels. Index exposure figures are provided alongside the portfolio exposure figures, highlighting the difference with the index.

### 6. Exclusions

### 7. Country Sustainability Ranking

The visual displays the portfolio's scores following Robeco's Country Sustainability Ranking methodology. These are calculated using the portfolio components' weights and respective country's scores. The scores includes considerations of more than 50 separate indicators, each capturing a unique sustainability feature across environmental, social and governance dimensions at the country level. Only holdings mapped as sovereign bonds are included in the figures.

### 8. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

## Risk management

The fund aims to deliver an attractive total return, also on a risk-adjusted basis. The fund targets an ex-ante total return volatility within the range of 2 to 6% and can adjust the duration of the portfolio between 0 and 10 years. The leverage exposure of derivatives on a fund level is restricted as described in the prospectus.

## Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.01% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

## Dividend policy

All income earned is accumulated and not distributed as dividend. Therefore the total return is reflected in the share price development.
