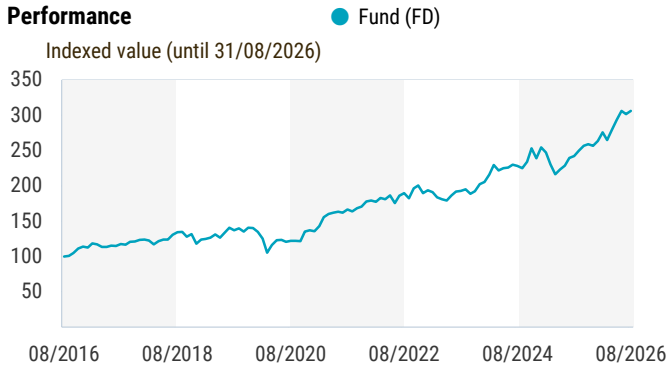

Fiscal product treatment

Fiscal treatment of investor
