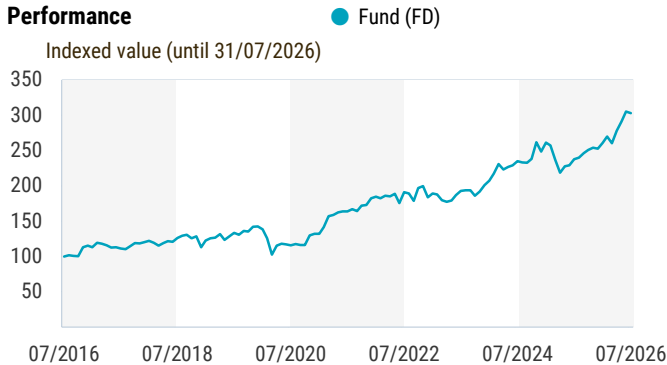

Performance commentary

Based on transaction prices, the fund's return was -0.79%.

Robeco BP US Large Cap Equities underperformed versus the Russell 1000 Value Index in July. Overall detractor in the fund largely came down to stock selection in information technology, which accounted for approximately 95% of the difference in relative performance over the month. Applied Materials and Micron Technology were the two largest individual detractors from relative return; both are equipment and memory names that were among the most exposed to the profit-taking. Besides, both stocks were dropped from the Russell value indices in the June rebalance. Industrials was another weak area from a stock selection perspective. C. H. Robinson was the largest detractor falling over 21% due to a trucking accident lawsuit. On a positive note, stock section added value across healthcare, financials, consumer discretionary and energy. From a sector allocation standpoint, the fund's overweight exposure to materials and industrials had the largest negative impact.

Market development

US equities delivered mixed results in July, with the S&P 500 modestly higher as renewed AI concerns, higher oil prices and rising bond yields outweighed strong late-month technology earnings. Market volatility prompted a rotation away from expensive growth stocks, helping value outperform growth, led by energy and financials.

Expectation of fund manager

Three themes are shaping markets: the AI trade, the Iran conflict and uncertainty under Fed Chair Kevin Warsh. July's AI weakness appears to be a reassessment rather than a structural reversal, with investors focused on returns from hyperscalers' capital spending. Oil remains sensitive to developments in Iran and could fall if tensions ease. Inflation data and Warsh's Jackson Hole speech will be key to the interest rate outlook. We remain constructive over the long term while alert to downside risks and opportunities created by market pullbacks. As always, we remain focused on selecting companies from the bottom-up that reflect the Boston Partners' three circle characteristics – attractive valuations, solid business fundamentals, and identifiable catalysts.

Top 10 largest holdings

Microsoft, Diamondback Energy and Gilead Sciences enter the top ten, replacing NXP Semiconductors, Dell Technologies and Micron Technology.

Sector allocation

Activity during the month saw two new positions added and four liquidations. New holdings were added in financials and industrials, while liquidations came from communication services, financials, industrials and materials, one in each sector.
