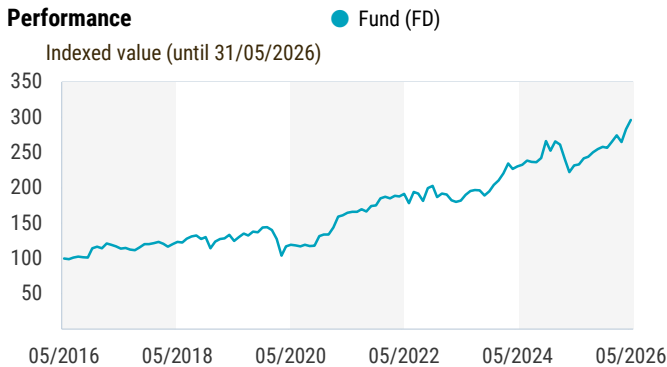

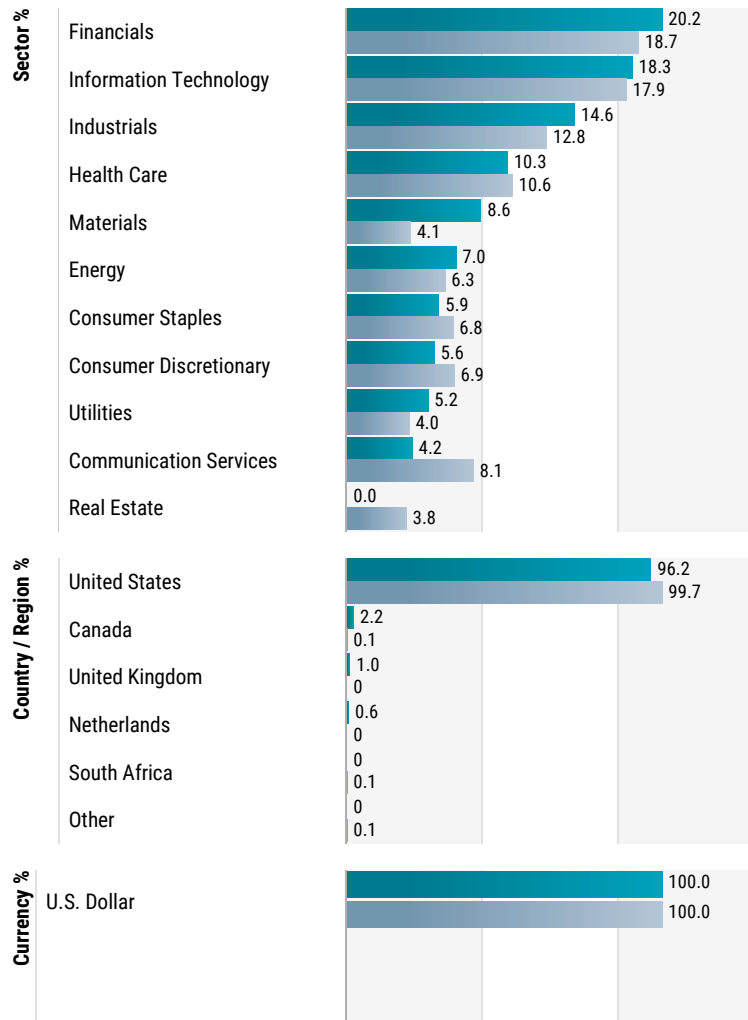

Fiscal treatment of investor
