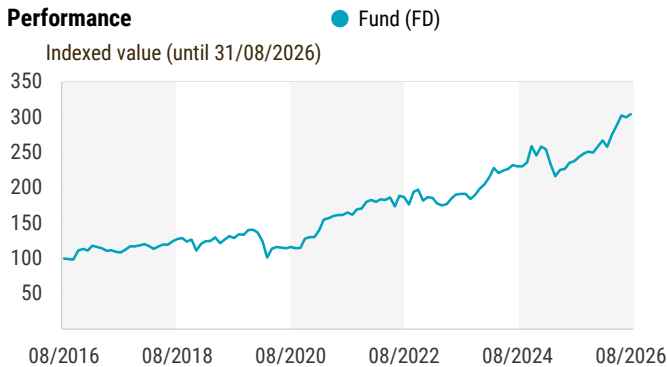

Performance commentary

Based on transaction prices, the fund's return was 1.38%.

Robeco BP US Large Cap Equities outperformed the Russell 1000 Value Index in August, as both stock selection and sector allocation contributed to performance. Focusing on stock selection, financials and energy added the most value. In financials, Appollo Global Management shares rose over 9% driven by record second-quarter fee earnings, high-profile AI infrastructure financing announcements, and major strategic portfolio exits. Not owning Berkshire Hathaway also aided relative performance. Within energy, the fund's holdings rose by more than 10%, compared with a 6.9% gain for the index sector. SLB, ConocoPhillips and Marathon Petroleum all performed strongly supported by elevated energy prices, geopolitical supply disruptions, and strong refining margins. Sector allocation contributed positively to relative performance, supported by the fund's underweight exposures to real estate and consumer discretionary and overweight exposures to materials and energy. Conversely, underweight exposure to information technology and overweight exposure to utilities detracted.

Market development

US equities advanced in August, with value stocks benefiting from strength in sectors such as energy, while resilient corporate earnings and continued enthusiasm around artificial intelligence supported broader investor sentiment. Market leadership broadened during the month, although performance varied meaningfully across sectors, with industrials, utilities and real estate lagging. Despite periodic volatility and rising treasury yields, the underlying economic backdrop remained supportive and helped equities finish the month in positive territory.

Expectation of fund manager

The outlook for US equities remains cautiously constructive. Strong corporate earnings, resilient economic activity and the broadening adoption of artificial intelligence should continue to support the market. With further multiple expansion likely to be constrained, returns should increasingly depend on earnings delivery and broader participation across sectors, creating a potentially favorable environment for disciplined stock selection and value-oriented opportunities. As always, we remain focused on selecting companies from the bottom-up that reflect the Boston Partners' three circle characteristics – attractive valuations, solid business fundamentals, and identifiable catalysts.

Top 10 largest holdings

Micron Technology and Kinross Gold enter the top ten, replacing Applied Materials and CRH Plc.

Sector allocation

Activity during the month was minimal, as the fund closed two positions with no new additions. The liquidated positions came in consumer staples and consumer discretionary, one from each sector.
