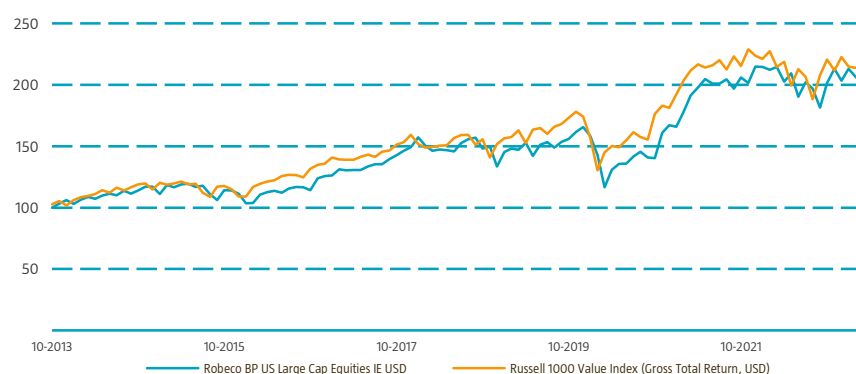

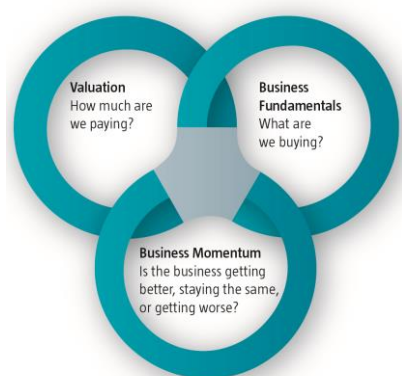
Performance at 31/03/2023

Meeting all the three-circle criteria

A key advantage of this fund is that each company in the portfolio must exhibit each of these 'three-circle' characteristics; it is not sufficient for a company to meet one of the criteria but not the others. Subsequently, companies fall in or out of consideration over normal business cycles.
