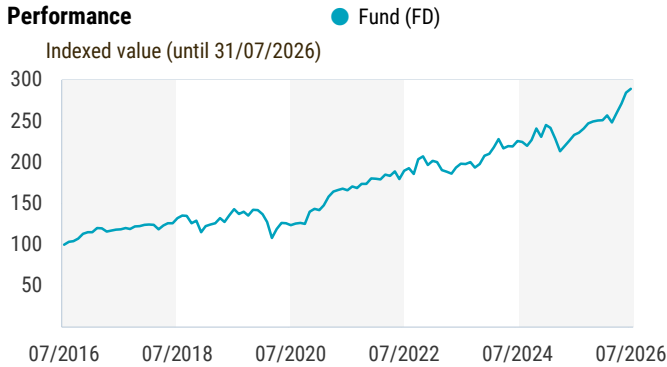

Fiscal product treatment
