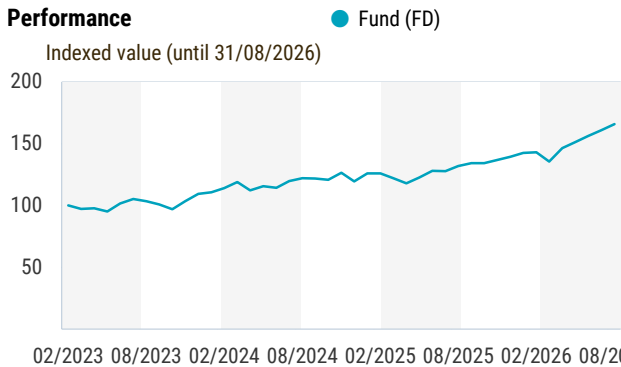

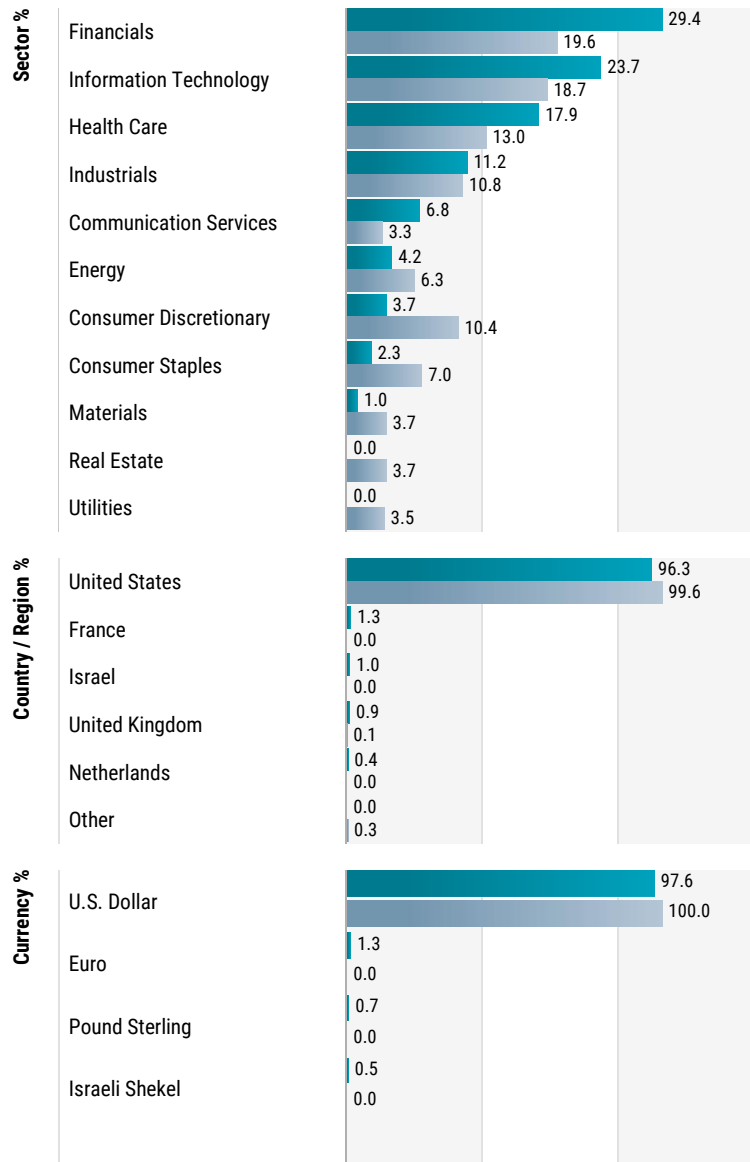

Fiscal product treatment
