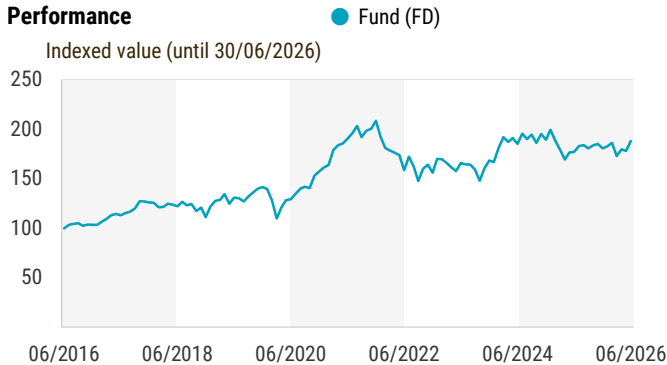

Robeco Sustainable Water is an actively managed fund that invests globally in companies that contribute to clean, safe and sustainable water supply. The selection of these stocks is based on fundamental analysis. The fund has sustainable investment as its objective, within the meaning of Article 9 of the Regulation (EU) 2019/2088 of 27 November 2019 on Sustainability-related disclosures in the financial sector. The strategy integrates sustainability criteria as part of the stock selection process and through a theme-specific sustainability assessment. The portfolio is built on the basis of an eligible investment universe that includes companies whose business models contribute to the thematic investment objectives. The assessment regarding relevant SDGs uses an internally developed framework, more information on which can be obtained at www.robeco.com/si.

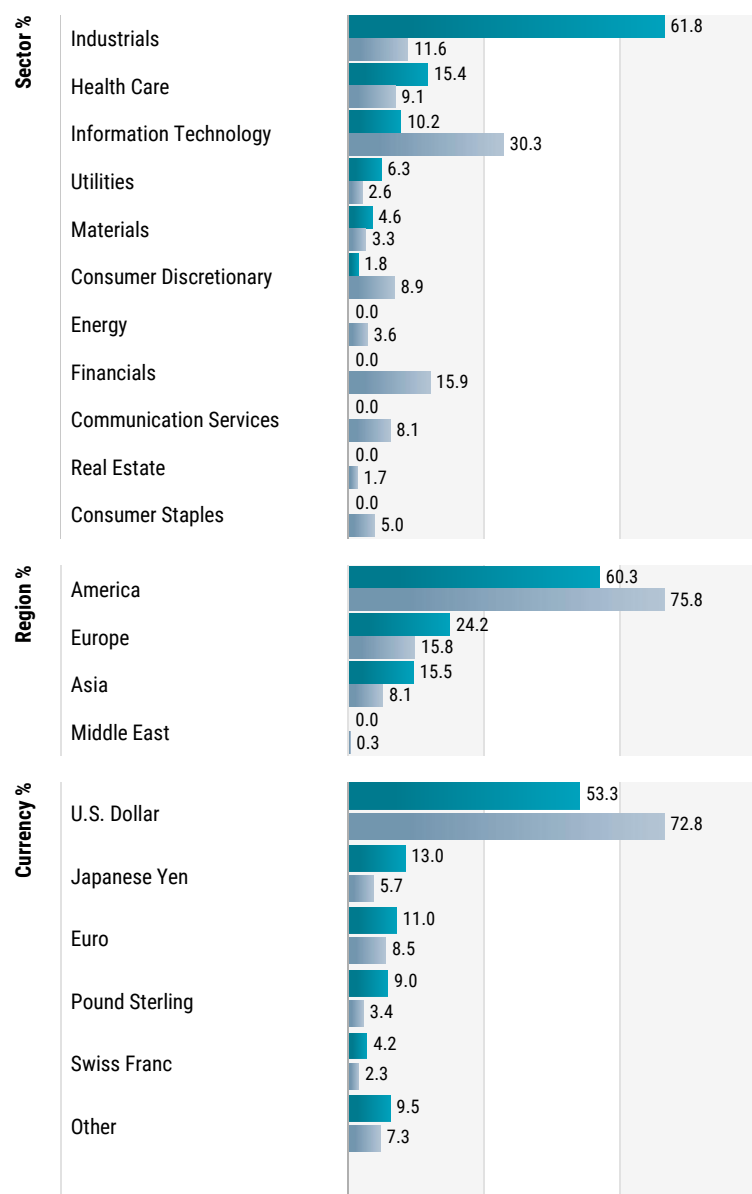

Performance commentary

Based on transaction prices, the fund's return was 5.67%.

The Robeco Sustainable Water Fund rebounded 4.6% in EUR terms in June, benefiting from a rotation away from AI-related stocks into more traditional and defensive businesses. The Water Quality cluster was a strong contributor, led by the Water Treatment subcluster, where established water companies such as Xylem, Veralto, and Ecolab performed well. The Water Analytics subcluster also recovered, supported by improving sentiment toward life science tools companies. The Water Infrastructure & Efficiency cluster, which remains the fund's largest allocation, was the strongest contributor to performance. Gains were led by the Engineering & Construction subcluster, followed by Infrastructure Equipment, as investors refocused on companies with solid fundamentals and attractive valuations. The Water & Waste Services cluster also delivered positive returns but was the smallest contributor to overall performance, reflecting its more defensive characteristics and lower sensitivity to the market's renewed appetite for cyclical sectors.

Market development

June was marked by significant market volatility. Strong US employment data early in the month pushed bond yields higher and reduced expectations for interest rate cuts, weighing on equities, particularly technology stocks. Sentiment improved mid-month following a ceasefire agreement between the US and Iran, helping ease geopolitical concerns. Investors also adjusted to a new communication approach from Federal Reserve Chair Kevin Warsh, which introduced greater policy uncertainty but had limited impact on broader equity markets. Technology shares remained volatile throughout the month, as investors reassessed AI-related spending and long-term returns. Semiconductor stocks experienced periods of sharp selling, although strong results from Micron briefly revived optimism. Concerns over AI monetization, rising investment costs, and increasing competition, including from lower-cost Chinese models, continued to drive fluctuations in the sector.

Expectation of fund manager

We are disciplined in our fundamental research and valuation methodology. Overall, the fund remains overweight in Water Analytics and Water Treatment, reflecting attractive valuations and solid growth prospects. Within Water Infrastructure & Efficiency, the fund is overweight in Infrastructure Equipment, while the other three clusters are broadly in line with the internal benchmark. In Water & Waste Services, the fund is underweight in both Waste Services and Water Utilities. US and UK water utilities remain underweight due to relatively high valuations, particularly given elevated treasury yields in both markets.

Top 10 largest holdings

The top ten positions are usually between 30-40% of the net asset value. The current top-five holdings are Agilent Technologies, Xylem, Veralto, Kurita Water Industries, and Idex.

Sector allocation

The strategy invests in the water value chain. Most companies are allocated to the GICS sectors of industrials, utilities and healthcare.

Regional allocation

The investment universe of the fund has a high exposure to the United States and Europe, especially the UK. In Asia, the exposure is mainly in Japan and some in China. Recently, we also added the Philippines and Taiwan to the portfolio.

Currency allocation

The fund has diversified currency exposures according to the underlying equity investments. It usually has a high weight in USD, GBP, EUR, JPY and CHF.

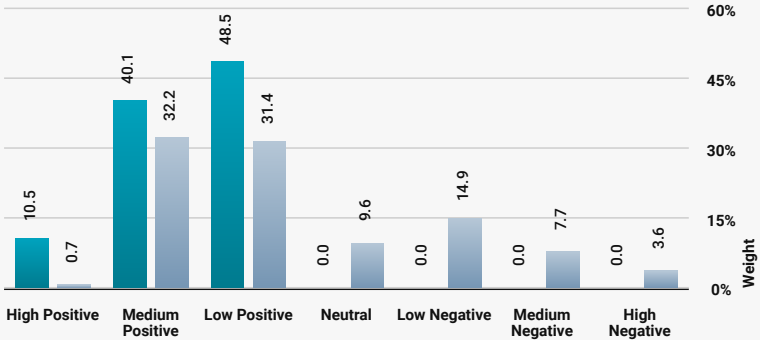

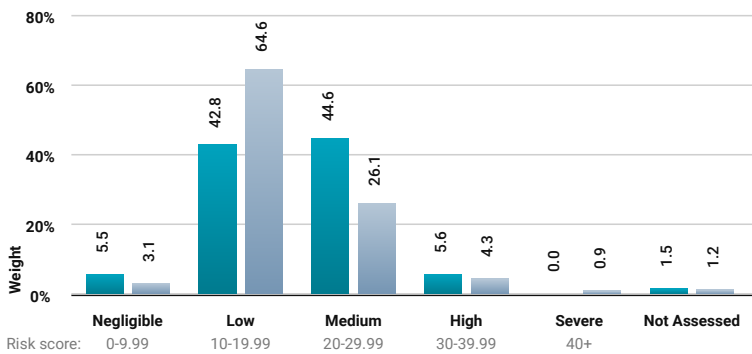

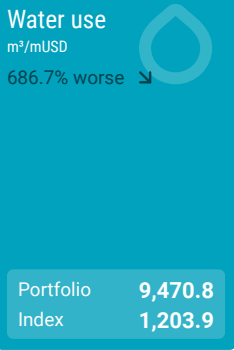

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Sustainability ESG Risk Rating

The chart displays the portfolio's Sustainability ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainability ESG Risk Rating by its respective portfolio weight. The distribution across Sustainability ESG Risk levels chart shows the portfolio allocations broken into Sustainability's five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated into the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes. Each year investors pay income tax on the value of their net assets as at 1 January if and inasmuch as such net assets exceed the investor's tax-free allowance.
