The fund's objective is also to achieve a better return than the Benchmark. The strategy integrates sustainability criteria as part of the stock selection process and through a theme-specific sustainability assessment. The portfolio is built on the basis of an eligible investment universe that includes companies whose business models contribute to the thematic investment objectives. 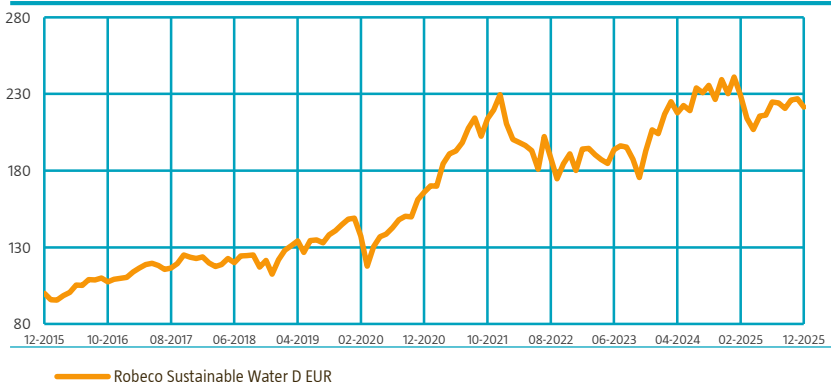

Performance

Based on transaction prices, the fund's return was -2.33%.

The Water Analytics subcluster underperformed versus the universe. Most companies in Water Analytics had a good rebound in recent months and investors took some profits in December. Most of the Engineering & Construction companies underperformed, which is probably still linked to the uncertainty about US politics and the funding of projects. One of the exceptions was the Swedish plumbing and electric installer Bravida, which rebounded in December benefiting from expected stabilization in most Nordic regions. Industrial Applications-related companies such as Dover, IMI and Weir outperformed. The Utilities cluster outperformed the designated investment universe.

Market development

December was marked by volatility, as optimism over potential further Federal Reserve rate cuts and strong corporate earnings clashed with concerns about geopolitics and the sustainability of the AI boom. Most AI-related companies still announce good updates and results, as the USA is still building up its AI infrastructure and data centers. But there are fears related to the return profile of all these investments going forward. Namibia's water utility NamWater announced that it signed a joint venture agreement with Swakop Uranium, a subsidiary of China General Nuclear Power Group (CGN), to construct one of the largest seawater desalination plants in Namibia. The new plant shall supply the population and the mining operation of Swakop.

Expectation of fund manager

We are disciplined in our fundamental research and valuation methodology. Overall, the fund is still overweight in water analytics, due to its relative valuation. In Water Infrastructure & Efficiency, we are overweight in infrastructure-related investments while industrial application is still underweighted. Plumbing & Household Appliance is underweighted too. In Utilities, we have a small position in a Brazilian water utility. US water utilities are underweighted, due to relatively high valuations.

Top 10 largest positions

The top ten positions are usually between 30-40% of the net asset value. The top-five holdings are Agilent Technologies, Xylem, Avantor, Kurita Water Industries, Tetra Tech.

Sustainability

The fund's sustainable investment objective is to help mitigate the global challenges related to scarcity, quality, and allocation of water. Water and sustainability considerations are incorporated in the investment process by the means of a target universe definition, exclusions, ESG integration, and voting. The fund only invests in companies that have a significant thematic fit as per Robeco's thematic universe methodology. Through screening on both Robeco's internally developed SDG Framework and Robeco's exclusion policy, the fund does not invest in issuers that have a negative impact on the SDGs, are in breach of international norms or where products have been deemed controversial. Financially material ESG factors are integrated in the bottom-up fundamental investment analysis to assess existing and potential ESG risks and opportunities. The integration of ESG factors in the investment analysis does not have a sustainability indicator. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

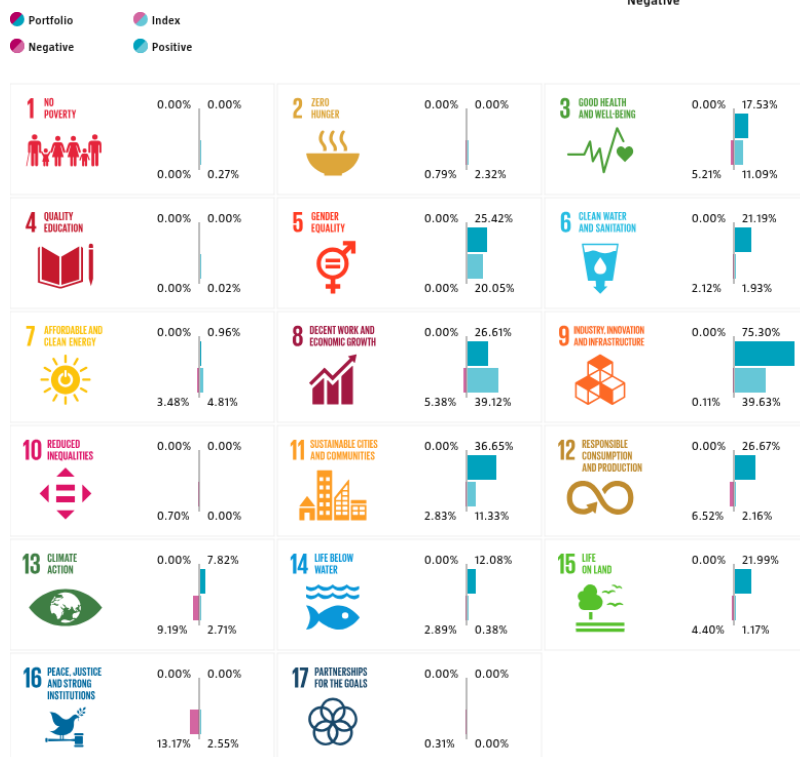
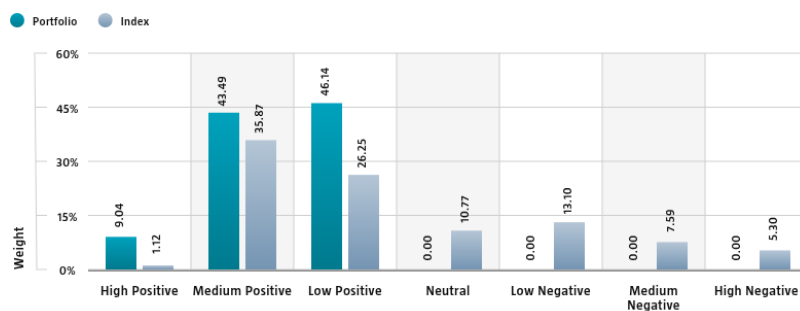

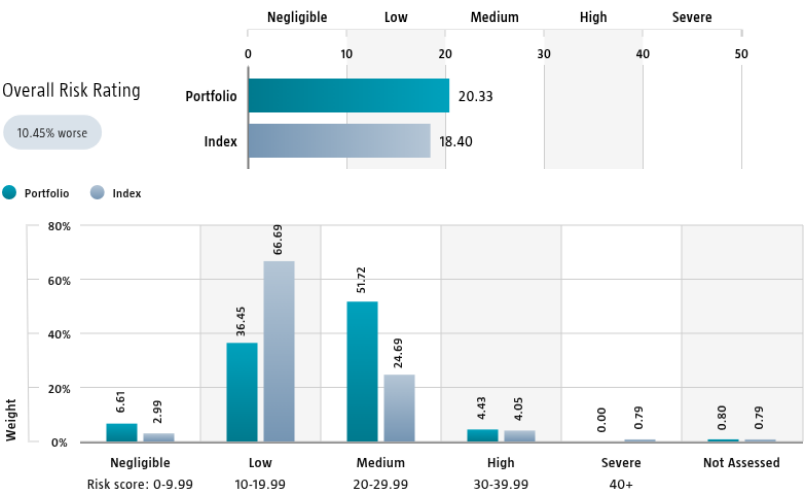

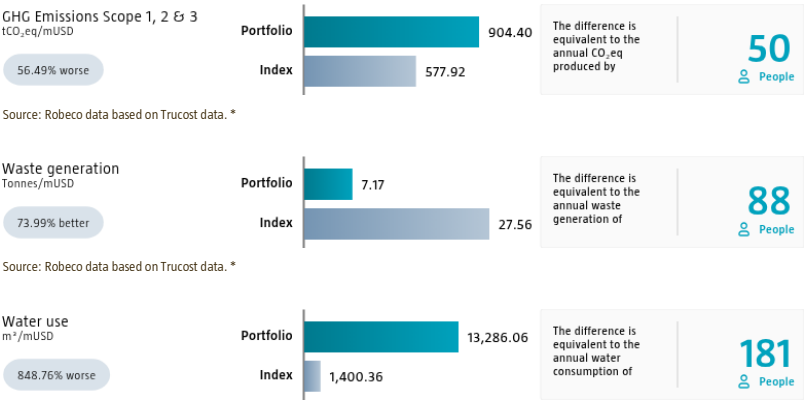

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. 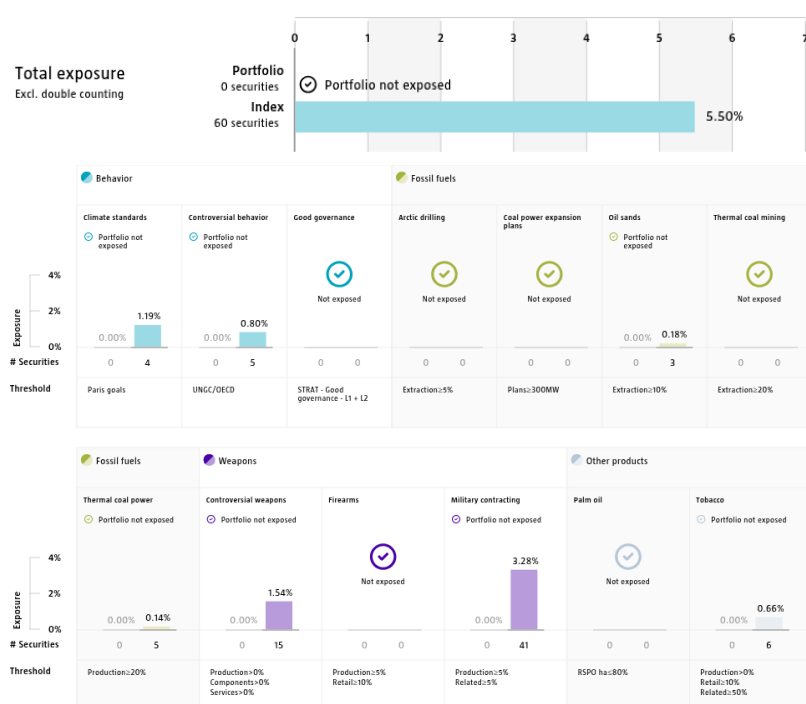

The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Dieter Küffer is Portfolio Manager of the Robeco Sustainable Water strategy and member of the Thematic Investing team. He has managed the strategy since inception in 2001, the year he joined Robeco. In the past, he has also managed several other thematic strategies at Robeco. Prior to joining, he led a team responsible for the management of actively managed equity mandates on behalf of Swiss institutional clients at UBS Asset Management in Zurich. He began his career as an investment counsel in the Private Banking Division of UBS in 1986. Dieter Küffer holds a federal diploma as a Swiss-Certified Banking Expert and is a CFA® Charterholder. Amy Wanner-Thavornsuk is Co-Portfolio Manager of the Robeco Sustainable Water strategy and member of the Thematic Investing team. Prior to joining in 2019, she worked for 9 years at JPMorgan Assets Management in London, including her role as a senior fundamental analyst covering emerging market equities. She has been in the Financial Industry for 20 years with previous work experience in investment banking and consulting. She started her career as an auditor at PWC in Bangkok back in 2003. Amy holds a Bachelor of Science in Finance & Accounting from the Chulalongkorn University in Thailand and an MBA from the Bayes Business School, UK. She is a CFA® Charterholder.
