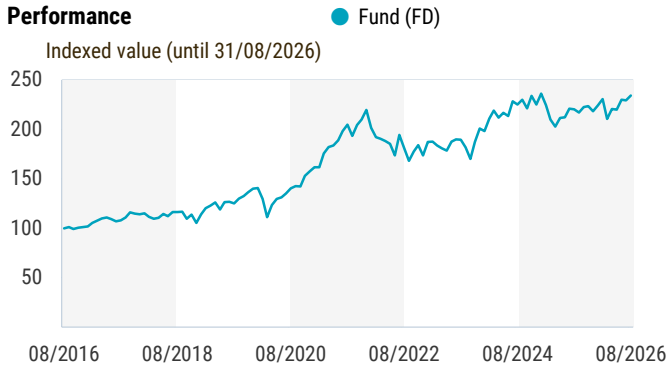

About the fund

Robeco Sustainable Water is an actively managed fund that invests globally in companies that contribute to clean, safe and sustainable water supply. The selection of these stocks is based on fundamental analysis. The fund has sustainable investment as its objective, within the meaning of Article 9 of the Regulation (EU) 2019/2088 of 27 November 2019 on Sustainability-related disclosures in the financial sector. The strategy integrates sustainability criteria as part of the stock selection process and through a theme-specific sustainability assessment. The portfolio is built on the basis of an eligible investment universe that includes companies whose business models contribute to the thematic investment objectives. The assessment regarding relevant SDGs uses an internally developed framework, more information on which can be obtained at www.robeco.com/si.

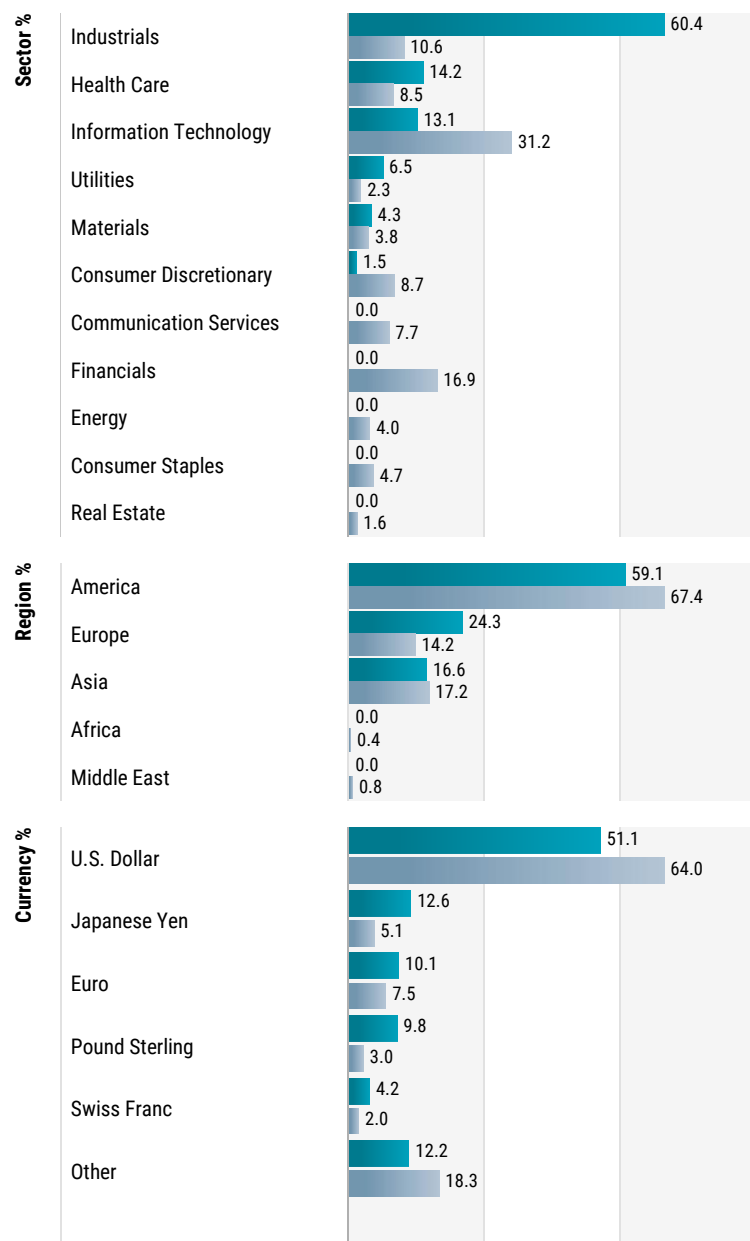
On the launch date, 29 October 2020, the fund absorbed Multipartner SICAV - Robeco Sustainable Water Fund. Performance prior to the launch date has been simulated on the basis of the past performance of the absorbed fund that had similar investment policy and applied higher or comparable charges. With effect from 16 July 2026, the benchmark has been changed from MSCI World Index to MSCI All Country World Index.

Performance commentary

Based on transaction prices, the fund's return was 2.04%.

The portfolio outperformed both the global and custom benchmarks, driven primarily by strong stock selection, while asset allocation and currency effects were modest detractors. Water Infrastructure & Efficiency was the strongest contributor, led by Industrial Applications, supported by demand for data center cooling solutions and solid operational execution. Traditional engineering and consulting firms also contributed positively. Water Quality added to performance, driven by Water Analytics which benefited from improving demand and sentiment. Water & Waste Services lagged, reflecting weakness in Brazilian utilities and waste management companies and some profit-taking in Veolia. Despite short-term weakness, the sector remains attractive for its defensive characteristics and long-term exposure to water security and environmental services.

Market development

Global equity markets stabilized in August following July's volatility, supported by a recovery in technology stocks and renewed confidence in AI-related investment. The Nasdaq outperformed, while broader market gains were more modest. Meanwhile, higher oil prices, elevated geopolitical tensions, additional US tariffs, and a more hawkish Federal Reserve contributed to rising bond yields and continued market uncertainty. Water-related challenges remained firmly in focus as drought conditions intensified across Europe, disrupting various industries. These developments reinforced the urgent need for investment in water infrastructure, water reuse, storage, and treatment solutions. Continued investment in data centers and AI infrastructure is increasing the need for water treatment, recycling, monitoring, and cooling solutions, creating an attractive long-term growth opportunity for parts of the water sector.

Expectation of fund manager

We are disciplined in our fundamental research and valuation methodology. Overall, the fund remains overweight in Water Analytics and Water Treatment, reflecting attractive valuations and solid growth prospects. Within Water Infrastructure & Efficiency, the portfolio is underweight in Plumbing & Household Appliances, while the remaining subclusters are broadly aligned with our internal benchmark. In Water & Waste Services, the fund is underweight in both Waste Services and Water Utilities. US and UK water utilities remain underweight due to relatively high valuations, particularly given elevated treasury yields in both markets.

Top 10 largest holdings

The top ten positions are usually between 30-40% of the net asset value. The current top-five holdings are Agilent Technologies, Xylem, Veralto, Kurita Water Industries, and Tetra Tech.

Sector allocation

The strategy invests in the water value chain. Most companies are allocated to the GICS sectors of industrials, utilities and healthcare.

Regional allocation

The investment universe of the fund has a high exposure to the United States and Europe, especially the UK. In Asia, the exposure is mainly in Japan and some in China. This year, we also added the Philippines and Taiwan to the portfolio.

Currency allocation

The fund has diversified currency exposures according to the underlying equity investments. It usually has a high weight in USD, GBP, EUR, JPY and CHF.

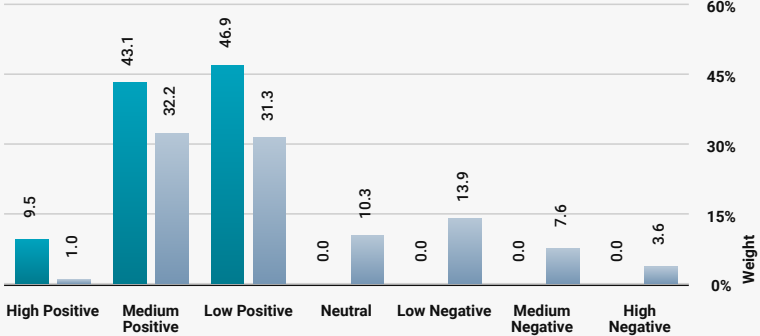

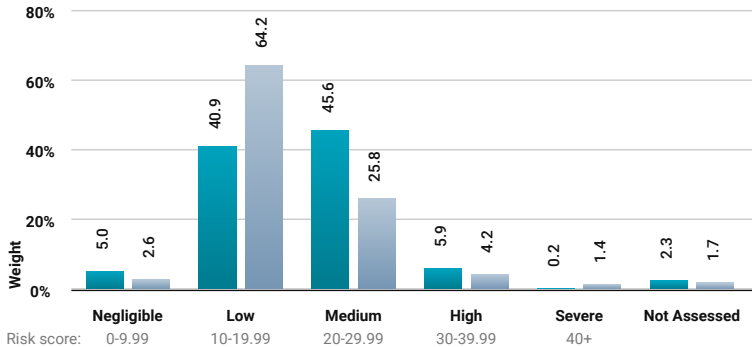

The fund applies sustainability indicators, including but not limited to, normative, activity-based and region-based exclusions, and proxy voting.

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Sustainability ESG Risk Rating

The chart displays the portfolio's Sustainability ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainability ESG Risk Rating by its respective portfolio weight. The distribution across Sustainability ESG Risk levels chart shows the portfolio allocations broken into Sustainability's five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. 4. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated into the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in Luxembourg and is subject to the Luxembourg tax laws and regulations. The fund is not liable to pay any corporation, income, dividend or capital gains tax in Luxembourg. The fund is subject to an annual subscription tax ('tax d'abonnement') in Luxembourg, which amounts to 0.05% of the net asset value of the fund. This tax is included in the net asset value of the fund. The fund can in principle use the Luxembourg treaty network to partially recover any withholding tax on its income.

Fiscal treatment of investor

The fiscal consequences of investing in this fund depend on the investor's personal situation. For private investors in the Netherlands real interest and dividend income or capital gains received on their investments are not relevant for tax purposes. Each year investors pay income tax on the value of their net assets as at 1 January if and inasmuch as such net assets exceed the investor's tax-free allowance.
