The selection of these stocks is based on fundamental analysis. The fund has sustainable investment as its objective, within the meaning of Article 9 of the Regulation (EU) 2019/2088 of 27 November 2019 on Sustainability-related disclosures in the financial sector. The fund's objective is also to achieve a better return than the Benchmark. The strategy integrates sustainability criteria as part of the stock selection process and through a theme-specific sustainability assessment. The portfolio is built on the basis of an eligible investment universe that includes companies whose business models contribute to the thematic investment objectives. 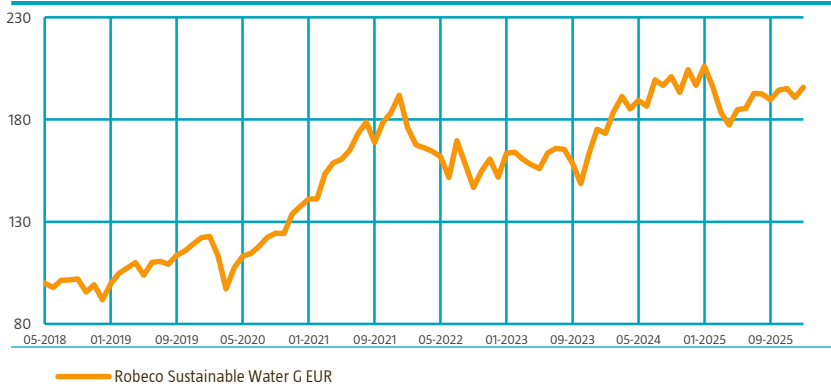

Performance

Based on transaction prices, the fund's return was 2.68%.

The fund outperformed the MSCI World Index in January with a +2.9% return versus +0.9%. Strength came mainly from strong stock selection in water-related industrials, while the strategy's underweight in information technology also helped. Within Water Quality, Water Analytics lagged after cautious outlooks from Thermo Fisher Scientific and Danaher. Water Treatment performed well, with Kurita, CECO and Sunresin supported by rising demand in semiconductor, industrial and pharmaceutical applications. In Water Infrastructure & Efficiency, Industrial Applications and Engineering & Construction outperformed, while Infrastructure Equipment was weaker. Badger Meter and Roper saw softer orders, whereas IDEX rebounded. Across Water & Waste Services, Water Utilities outperformed on sector rotation, while Waste Services lagged, with hazardous waste operators stronger than solid waste companies.

Market development

Equity markets were volatile in January. In the US, political pressure on the Federal Reserve increased. With Chair Powell's term ending soon, the administration signaled Kevin Warsh as his likely successor. His firm stance on inflation supported a stronger US dollar, weaker gold prices and a modest equity rebound. Geopolitical risks also weighed on sentiment. Peace talks between Ukraine and Russia made little progress. The US launched a military strike in Venezuela, a move with significant global implications. Tensions in the Middle East also intensified. Across markets, AI remained a key driver. Major technology companies continued to announce large, often debt-financed, investment plans. These raised concerns about future returns while also straining supply chains, including electricity grids, water resources and key hardware components. In the UK, the Cunliffe report proposed replacing the current water regulators with a single body focused on public health, the environment, affordability and long-term planning. Meanwhile, São Paulo faces critically low reservoirs, and global cities increasingly require major investment in water supply, recycling and infrastructure.

Expectation of fund manager

We are disciplined in our fundamental research and valuation methodology. Overall, the fund is still overweight in water analytics, due to its relative valuation. In Water Infrastructure & Efficiency, we are overweight in infrastructure-related investments while industrial application is still underweighted. Plumbing & Household Appliance is underweighted too. In utilities, we have a small position in a Brazilian water utility. US water utilities are underweighted, due to relatively high valuations.

Top 10 largest positions

The top ten positions are usually between 30-40% of the net asset value. The top-five holdings are Agilent Technologies, Xylem, Kurita Water Industries, IDEX and Tetra Tech.

Sustainability

The fund's sustainable investment objective is to help mitigate the global challenges related to scarcity, quality, and allocation of water. Water and sustainability considerations are incorporated in the investment process by the means of a target universe definition, exclusions, ESG integration, and voting. The fund only invests in companies that have a significant thematic fit as per Robeco's thematic universe methodology. Through screening on both Robeco's internally developed SDG Framework and Robeco's exclusion policy, the fund does not invest in issuers that have a negative impact on the SDGs, are in breach of international norms or where products have been deemed controversial. Financially material ESG factors are integrated in the bottom-up fundamental investment analysis to assess existing and potential ESG risks and opportunities. The integration of ESG factors in the investment analysis does not have a sustainability indicator. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to exclusion. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

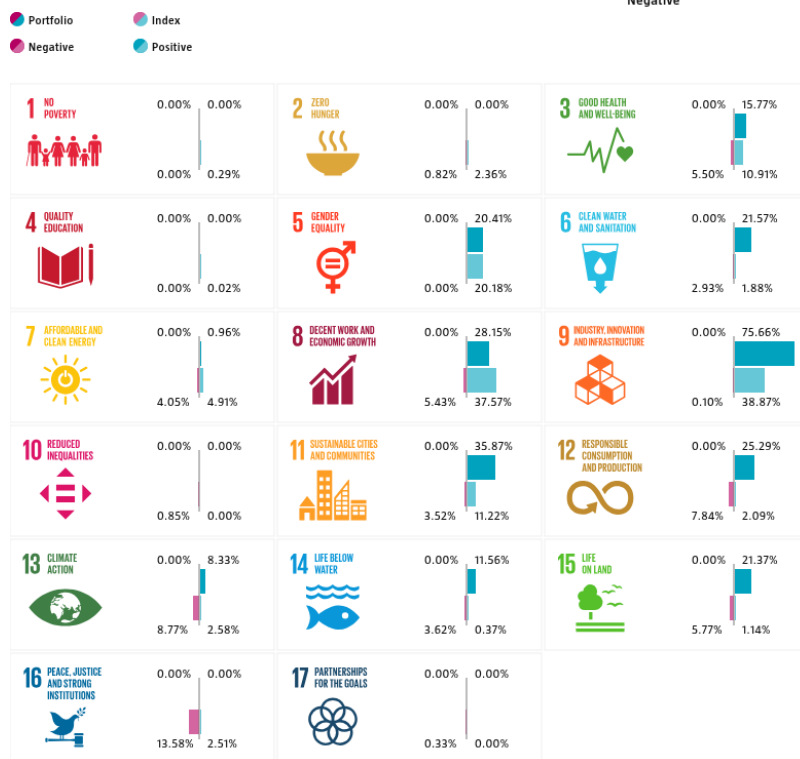
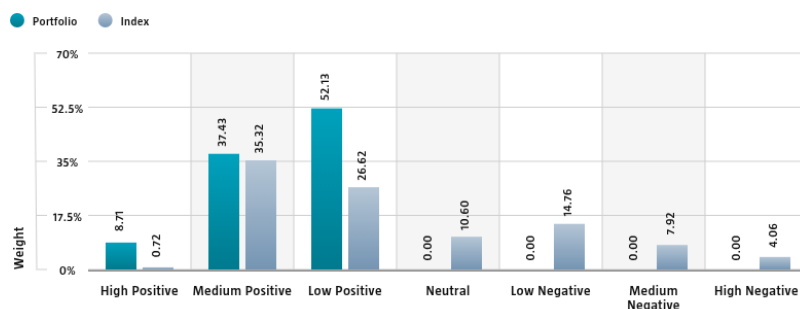

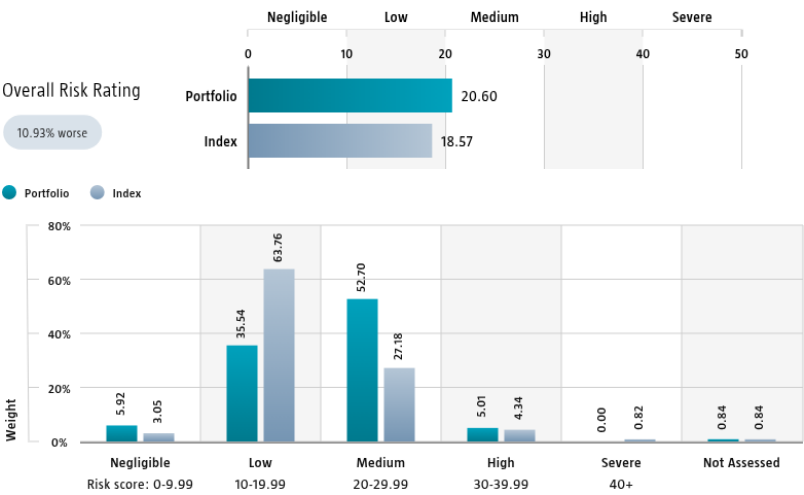

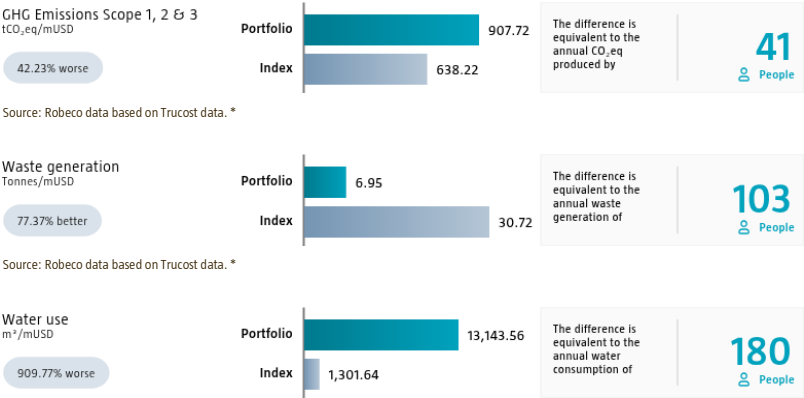

Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. Engagement

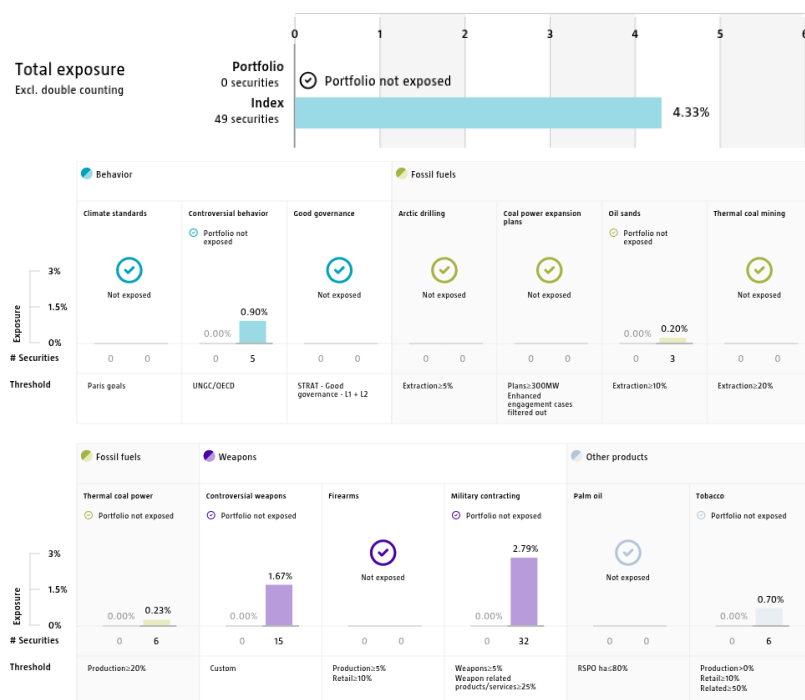

The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Fund manager's CV

Dieter Küffer is Portfolio Manager of the Robeco Sustainable Water strategy and member of the Thematic Investing team. He has managed the strategy since inception in 2001, the year he joined Robeco. In the past, he has also managed several other thematic strategies at Robeco. Prior to joining, he led a team responsible for the management of actively managed equity mandates on behalf of Swiss institutional clients at UBS Asset Management in Zurich. He began his career as an investment counsel in the Private Banking Division of UBS in 1986. Dieter Küffer holds a federal diploma as a Swiss-Certified Banking Expert and is a CFA® Charterholder. Amy Wanner-Thavornsuk is Co-Portfolio Manager of the Robeco Sustainable Water strategy and member of the Thematic Investing team. Prior to joining in 2019, she worked for 9 years at JPMorgan Assets Management in London, including her role as a senior fundamental analyst covering emerging market equities. She has been in the Financial Industry for 20 years with previous work experience in investment banking and consulting. She started her career as an auditor at PWC in Bangkok back in 2003. Amy holds a Bachelor of Science in Finance & Accounting from the Chulalongkorn University in Thailand and an MBA from the Bayes Business School, UK. She is a CFA® Charterholder.
