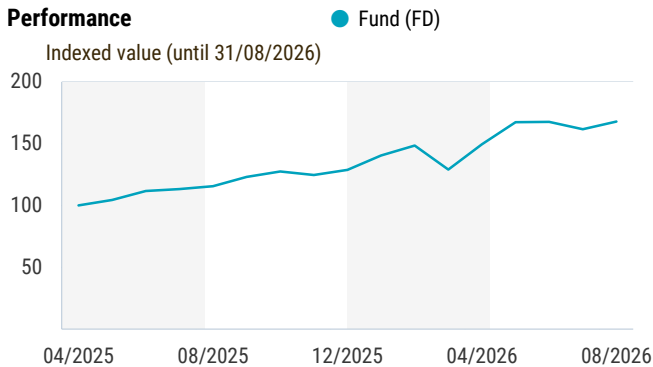

Robeco 3D EM Equity UCITS ETF is an actively managed Sub-fund that invests in stocks of companies in emerging markets and will apply the Manager's "3D" investment strategy, which seeks to consider risk, return and sustainability in the Sub-fund's portfolio. The Sub-fund's portfolio will be optimised using a quantitative process to target returns in excess of the Benchmark, sustainability characteristics better than the Benchmark and to manage risk compared to the Benchmark. The three dimensions of risk, return and sustainability are considered together in the Manager's proprietary quantitative stock-ranking model.

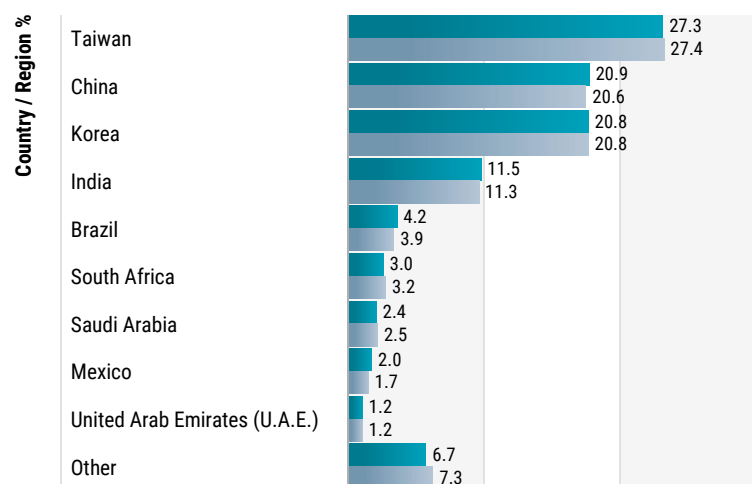
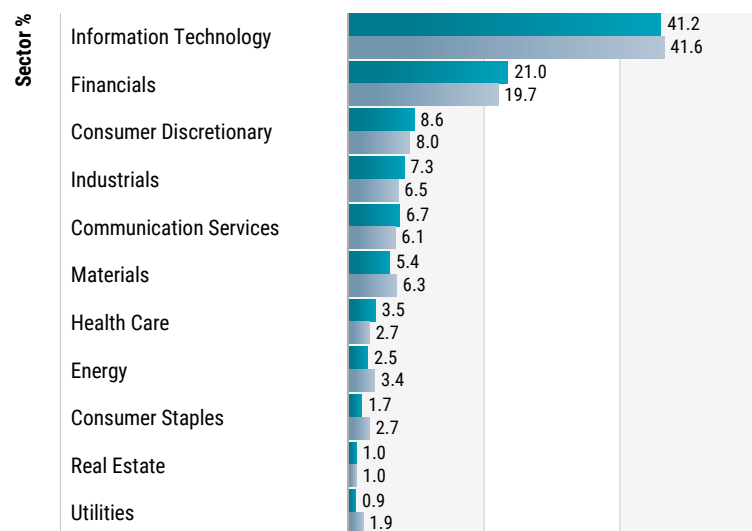

Performance commentary

Based on transaction prices, the fund's return was 3.75%.

The 3D Emerging Equity UCITS ETF aims to consistently outperform the MSCI Emerging Markets Index over the long term by taking many small overweight and underweight positions, resulting in low tracking error. The portfolio holds around 400 emerging market stocks, overweighting those with attractive valuations, strong profitability, solid momentum, and recent positive analyst revisions. Using our integrated multi-factor stock selection model, we expect consistent outperformance. The fund also seeks a better sustainability profile than the benchmark, in line with Article 8 of the SFDR. It integrates sustainability into the investment process by applying the Robeco Level 2 exclusion list, excluding stocks with an SDG score of -3, targeting a 5% better ESG risk rating (Sustainalytics), and aiming for 20% better carbon, waste, and water footprints than the index.

Top 10 largest holdings

The top ten positions are primarily the result of the fact that these companies have a large weight in the index.

Sector allocation

The fund aims to keep sector positions neutral to the index level. In terms of limits, +/- 0.3% over/underweights for countries and +/- 1% for sectors are allowed versus the MSCI Emerging Markets Index.

Country / Region allocation

The fund aims to keep country positions neutral to the index level. In terms of limits, +/- 0.3% over/underweights for countries and +/- 1% for sectors are allowed versus the MSCI Emerging Markets Index.

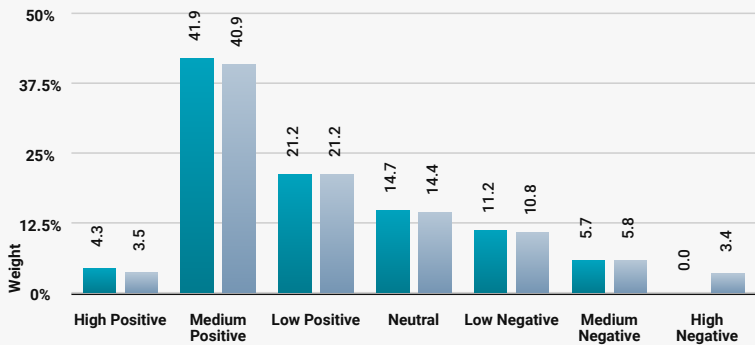

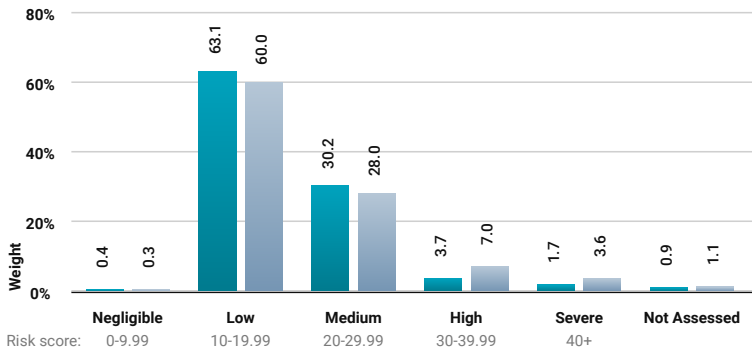

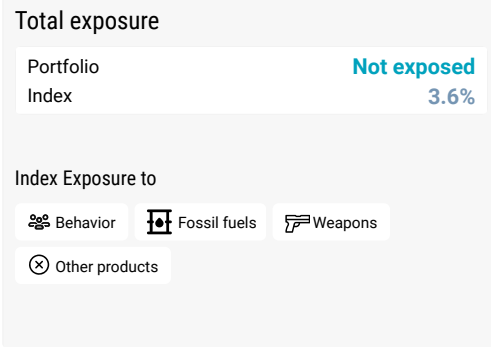

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 3. Sustainability ESG Risk Rating

5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.
