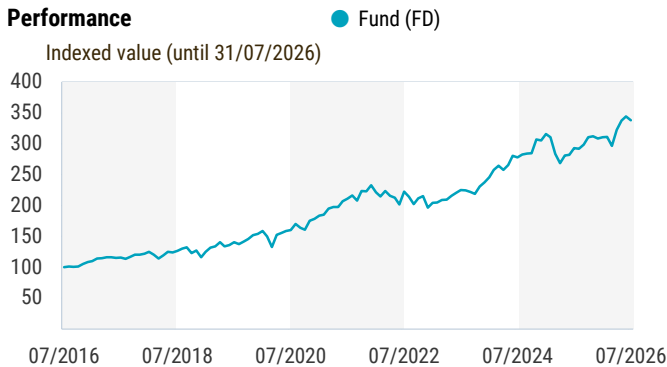

Stock selection focuses on the shares of medium and large companies with the greatest growth potential. The Fund aims to provide long term capital growth while at the same time aiming for a better sustainability profile compared to the MSCI World Index.

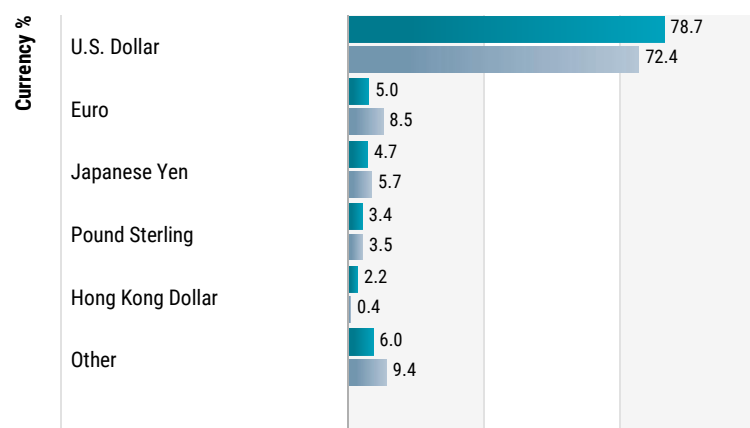
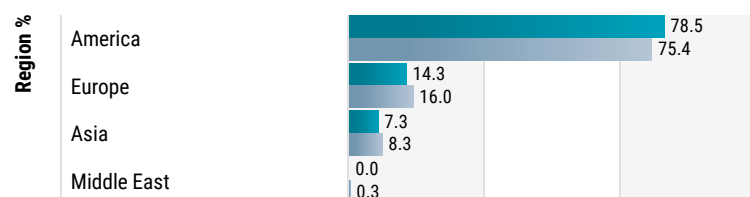
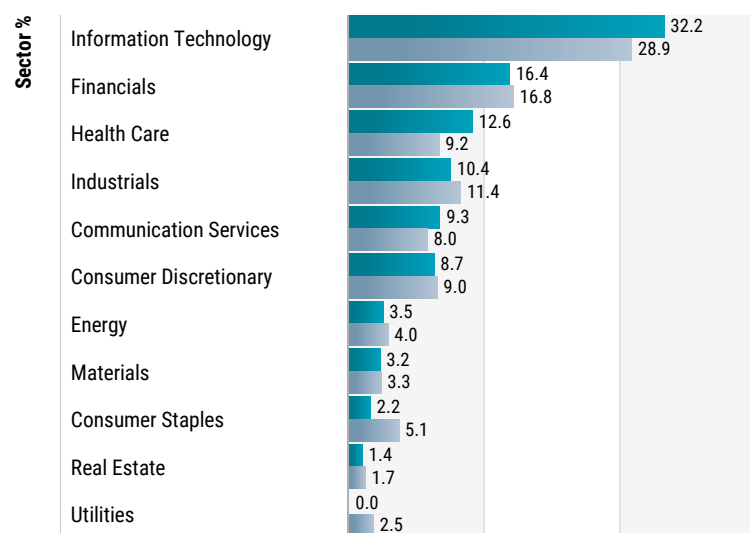

Performance commentary

Based on transaction prices, the fund's return was -1.86%.

The portfolio had a tough month in July, underperforming versus the benchmark by around 1.7%. This was mainly attributed to a sharp market rotation out of the technology sector into other sectors that had been lagging year-to-date. Hence, information technology was the main drag during the month, while our positioning in consumer discretionary showed a good relative performance that provided some offset. Besides information technology, industrials and healthcare also detracted from performance during the month. The best performer in July was Microsoft, which outperformed the broader market following a strong fiscal 2026Q4 earnings report that demonstrated accelerating Azure growth, growing AI monetization and continued enterprise adoption of Copilot. Tesla underperformed after reporting weaker-than-expected Q2 earnings, with automotive margins, operating profits and free cash flow all falling short of investor expectations despite record vehicle deliveries. Investors also became increasingly concerned that rising AI, Robotaxi and Optimus-related investments are pressuring near-term profitability.

Market development

The winning corners of the market took several hits during July, marking a rollercoaster month that somehow still ended with a shy smile (-0.1% in EUR, +0.5% in USD). After a blockbuster first half of the year, with indices riding the semiconductor boom, July prompted a nagging question: had the AI party gotten ahead of itself? Sharp wobbles across AI names, with chip stocks at the epicenter, were eventually stabilized after a wave of strong earnings results. As the large hyperscalers flagged combined capital spending for 2026 that will likely close in on the USD 800 billion mark, and with 2027 set to easily surpass the USD 1 trillion mark, investors were reassured that the AI infrastructure buildout is not slowing. There are two clouds that could spoil the party. Firstly, rising bond yields – with the 10-year US Treasury hitting its highest point since early 2025 – are signaling that the Fed needs to hike sooner rather than later. And secondly, a flare-up in geopolitics – again. Renewed spats around the Strait of Hormuz pushed crude oil prices back toward the USD 90 level.

Expectation of fund manager

In July, we have seen that lagging pockets of the market, including financials, healthcare and consumer, are staging a comeback as earnings revisions are improving. In general, earnings will need to do more of the heavy lifting going forward. So far, that is indeed the case, with earnings growth currently running at the strongest pace in four years, keeping overall equities afloat. A large swing factor remains the Fed. With the narrative flipping this year from rate cuts to potential hikes, as inflation concerns remain and bond yields are turning up, this could mean headwinds for pricey growth stocks and could cap how far valuations might stretch. The risk list also includes a longer and harsher continuation of the US-Iran conflict, increasing the likelihood of another oil price spike. The sharp drawdown in July of many AI darlings, mainly driven by technical factors rather than fundamentals, also meant the door for a broader market participation is again firmly open. Hence, staying diversified across size, style and geographies, rather than betting the farm on the AI basket alone, looks the most sensible way to ride a market that can still climb from here.

Top 10 largest holdings

Our top active position is Alphabet, a global technology leader whose core franchises in digital advertising, search, cloud computing and artificial intelligence serve billions of users worldwide. Alphabet is regarded as a vertically integrated AI leader because it controls the full AI stack, from proprietary AI research (DeepMind and Gemini) and custom TPU infrastructure, to cloud services and consumer products such as Search, YouTube, Android and Workspace, enabling it to develop, deploy and monetize AI at scale. The largest equipment rental company in North America, United Rentals, is our second-biggest active weight. The company provides construction, industrial and specialty equipment and services to customers across a wide range of end markets. Cheniere rounds off our top-three of active positions; it is the leading US producer and exporter of liquefied natural gas (LNG), operating large-scale LNG infrastructure that supplies global energy markets.

Sector allocation

The portfolio is overweight in sectors that have a high return on invested capital, such as communication services, information technology, consumer discretionary and healthcare. Currently, the fund is underweight in industrials, materials, utilities and consumer staples.

Regional allocation

We have relatively neutral regional weights. We have moved slightly lower in weight in Europe, as we see political turmoil in France and the UK, leading to potentially higher credit rates. We have added to our US weight but remain underweight North America. We have a neutral position in Asia-Pacific, with a slight underweight of Japan and an overweight position in Emerging Asia.

Currency allocation

The fund pursues a moderately active currency allocation policy. We hedge most of our currencies back to the benchmark.

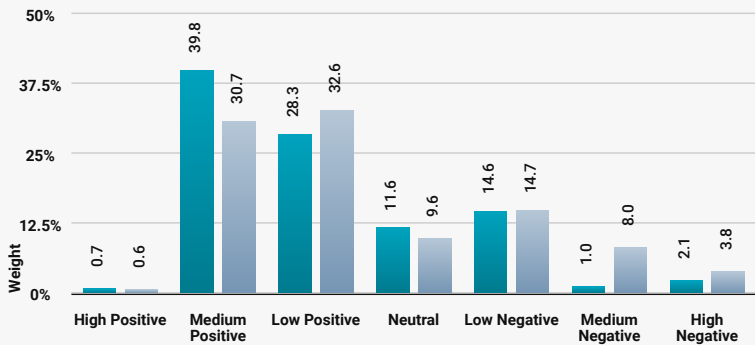

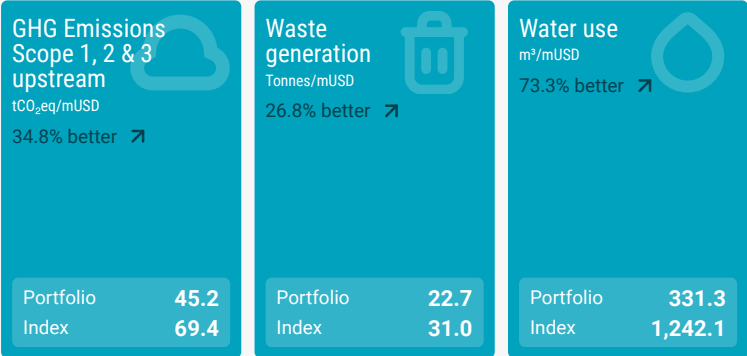
SDG Impact Alignment ¹

Environmental Footprint ²

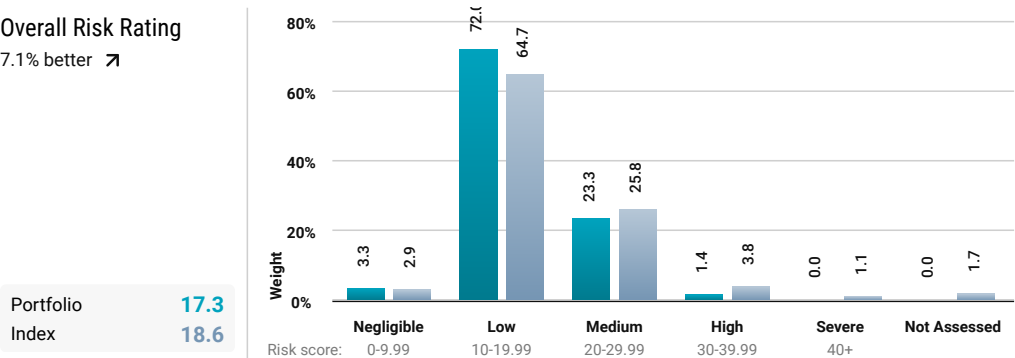

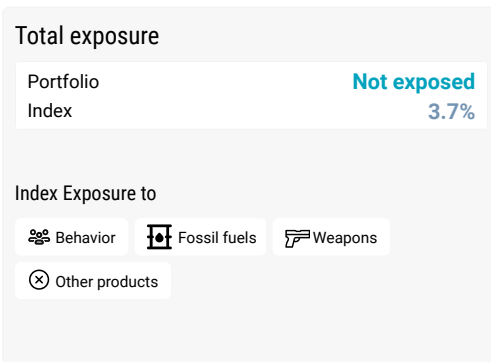

1. SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. Only holdings mapped as corporates are included in the figures.

2. Environmental Footprint

Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. The equivalent factors that are used for comparison between the portfolio and index (where applicable) represent European averages and are based on third-party sources combined with own estimates. 3. Sustainalytics ESG Risk Rating

5. Engagement

Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

Risk management

Risk management is fully integrated in the investment process to ensure that positions always meet predefined guidelines.

Fiscal product treatment

The fund is established in the Netherlands. The fund is managed as a 'naamloze vennootschap' (public limited company). The fund has the status of 'fiscal investment institution' in the sense of article 28 of the Dutch Corporate-Income Tax Act 1969, and, as such, is taxed at a corporate-income tax rate of 0%. The fund is obliged to pay out the realized current income in the form of dividend within 8 months after the end of the financial year. From 1 January 2007 the fund withholds Dutch dividend tax at a rate of 15% from these dividend payments. The fund can in principle use the Dutch treaty network to partially recover any withholding tax on its income.

Dividend policy

In principle the fund distributes dividend on an annual basis. The fund's policy aims at realizing as the maximum possible capital growth within the pre-set risk limits. A high dividend return is therefore not a separate objective.
