Underlying portfolio yield represents the average of the daily annualised yield over the preceding one-year period, calculated as daily net investment income (interest and dividend income net of the Total Expense Ratio) divided by daily total net assets. Sales charges and net realised gains are excluded.

Average Payout yield since Inception

For a share class incepted for less than 1 year, the cumulation of payout yields since inception.

For a share class incepted for more than 1 year, the average of annualized payout yields of up to 5 years.

Average Distribution Since Inception (per annum)

For a share class incepted for less than 1 year, the cumulation of distribution rates in local currency since inception.

For a share class incepted for more than 1 year, the average of annualized distribution rates per share in local currency up to 5 years.
