

## NON BANK BUSINESS DAYS 2018 □ UPDATE OCTOBER

This document provides an overview of Non-Bank Business Day 2018 for Dutch and Luxembourg funds.

The fund board elects a day as a Non-Bank Business Day if one or more stock exchanges and regulated markets where a (sub-)fund principally invests are closed or insufficient trading and liquidity is expected.

By electing a Non-Bank Business Day the (sub-)fund and therefore investors will be protected for (unintended) performance impact due to subscriptions or redemptions in the (sub-)fund.

The actual day which will be elected as a Non-Bank Business Day depends on the valuation of the market by the (sub-fund).

Two examples to illustrate:

- On 15 January the US Markets are closed due to Martin Luther King Day. Therefore Robeco QI US Conservative Equities will have a Non-Bank Business Day on 16 January.
- On 16 February the Chinese markets are closed due to Chinese new year. Therefore Robeco Chinese Equities will have a Non-Bank Business Day on 16 February.

Note that:

- Only non trading days falling on a weekday are mentioned;
- Reference is made to (Sub)funds, this reference is applicable for all classes of Shares of the applicable sub-fund.

In this update the following changes are reflected:

- Addition of (market green, which means that the funds are closed for trade execution)
  - o 30 November 2018 and 2 December 2018, all Funds closed expect for fund with Northern Trust as Depositary
- Re-open of (market red, which means that the funds are open for trade execution):
  - o Robeco QI Chinese A-share Conservative Equities on 12 November 2018
  - o Various Equity funds on 13 November 2018
