Dear Investor,

We are writing to you as shareholder in one or more duration hedged and/or inflation hedged share classes of the sub-funds of Robeco Capital Growth Funds as indicated in Annex I (the "Share Classes"). The board of directors of Robeco Capital Growth Funds (the "Board") has, on the grounds as mentioned below, decided to close the Share Classes for further subscriptions as of 30 July 2018.

The decision of the Board is a result of an Opinion issued by European Securities and Markets Authority on 30 January 2017 on Share Classes of UCITS (ESMA 34-43-296) which Opinion was adopted by the *Commission de Surveillance du Secteur Financier*, stating that "*hedging arrangements at share class level [with the exception of currency risk hedging] are not compatible with the requirement for a fund to have a common investment objective*" and should no longer be allowed.

The last cut-off time and date for subscriptions in the Share Classes will be 15:00 CET on 26 July 2018.

Existing investments in the Share Classes do not have to be redeemed and the Share Classes will not be liquidated. Please note that the Board always may liquidate a share class if the assets would fall below the minimum value to manage the assets effectively.

Redemptions in the Share Classes remain possible and are free of charge. Please be aware that your bank or stockbroker can levy a charge.

The prospectus, the Key Investor Documentation, the articles of association and the annual and semi-annual reports of the Company are available free of charge at the registered office of the Company and at the representative of the Company in Switzerland, Robeco Switzerland AG, Josefstrasse 218, 8005 Zürich, and at www.robeco.com/luxembourg.

The paying agent of the Company in Switzerland is UBS Switzerland A.G., Bahnhofstrasse 45, 8001 Zürich.
