Last month's performance

AI financing angst, labor market fears and doubts over Fed rate cuts drove high intra-month volatility in November, from large initial drawdowns to a comeback reversal, keeping global equity markets flattish overall (-0.3% in EUR; +0.3% in USD). The big picture remained somewhat unchanged, but below the surface some cracks are showing due to AI heavyweights faltering, crypto pressure, shifting retail sentiment, and credit-cycle jitters, which are all testing market animal spirits. Despite several concerns mounting, corporate earnings remained strong as tariff impacts are either delayed or watered down altogether, and Big Tech investments across its vast value chain see order books extend higher-for-longer. Elsewhere, Japan underperformed as Japan-China tensions bubbled over Taiwan-related comments from new Prime Minister Takaichi, potentially leading to retaliatory economic measures

from China. Profit-taking in the AI trade resulted in broader weakness in the EM space, notably in China, Taiwan and Korea. Europe, on the other hand, held firm as the periphery did well as banks outperformed, but also on silent hopes of a US-brokered peace plan in Ukraine.

In November, the portfolio had a flat absolute return, yet outperforming the benchmark. Sector-wise, our positioning in Healthcare and Communication Services helped performance best. The sectors Industrials and Consumer Staples, however, struggled most.

In terms of stock selection, Eli Lilly contributed most, driven by the announced GLP-1 pricing and patient access agreements between the Trump Administration and key pharma players. This outcome is good news for Eli Lilly, in particular, as it will expand Medicare coverage for GLP-1 beyond type-2 diabetes into the broader obesity population, where lower price is traded for much higher volumes in the years ahead.

Alphabet also contributed strongly to performance as investors reacted very positively to its newly released Gemini 3 AI model, which has been trained on Google's own AI chips (called TPUs). In addition, it turns out Meta Platforms is in talks to buy these TPU chips from Alphabet. Gemini 3 impressed users and refocused attention on TPU as an alternative to Nvidia for running certain AI workloads. Altogether this has brought Alphabet back to the center of the AI trade.

Finally, AstraZeneca also contributed nicely to performance after it posted a strong set of results. Accelerating growth in its key oncology franchises supports the thesis that the path to USD 80 billion in sales by 2030 is achievable. Moreover, management seems confident this also helps achieve its 'mid-30s' margin by then, even though much of that also depends on the success of its pipeline and leverage from its sales force investments.

On the flipside, we saw Arista Networks detracting from performance as its reported numbers and guidance fell slightly short of elevated expectations. Also, Arista's recent spike in deferred revenues can be explained by the scale and complexity of its new products. Given its presence in the network 'spine', it simply takes longer to qualify an entire system as compared to a network switch that only sits at lower levels of the network. Fundamentally, however, the growth thesis of Arista stays very much intact.

Salesforce continued to lag, even though there is ample pipeline interest in its Agentforce and Data Cloud AI products. The company's Dreamforce event provided insights as to how it will monetize AI in the coming years. However, at this stage, investors await further evidence of commercialization and better contract renewal rates before turning more constructive.

Finally, ride-sharing platform Uber lagged in November as investors showed concerns about its plans to invest in a fleet of autonomous vehicles (AV), potentially diluting the asset-light model that has long appealed to them. However, these investments, made together with partners, will only represent a gradual ramp and are intended to accelerate AV deployment. The impact on Uber's free cash flow generation will remain limited.

Our top active position is US pharma giant Eli Lilly. The company enjoys one of the strongest product pipelines in pharma, while at the same time having low risk to patent expirations. Its leading franchises in areas such as anti-obesity (GLP-1), neurology and oncology enables it to have strong growth potential for years to come. Our second largest position is Thermo Fisher which is a US life sciences toolmaker with arguably the best operating track record in the healthcare tool space. We believe the medical tool sector is past the worst and sees most of its end-markets accelerating from here. AstraZeneca PLC, a prominent UK-based biopharmaceutical company focused on the discovery and development of prescription medicines across therapeutic areas such as oncology, cardiovascular, and respiratory diseases completes our top 3 active positions.

Portfolio Changes

In November, we exited our stake in home-improvement company Lowe's. As mortgage rates remain too high to see any meaningful move up in housing turnover, this does not bode well for Lowe's DIY business. We decided to reallocate proceeds into McKesson, a dominant US pharma distributor, seeing healthy growth across its higher-margin oncology and biopharma services business. McKesson is also relatively insulated from political interference and trade-related impacts. Furthermore, during the month, we trimmed positions in Cheniere Energy and AutoZone on weakening momentum and lack of catalysts, whereas we also took some profits in year-to-date high fliers including Applied Materials, Nvidia and Broadcom.

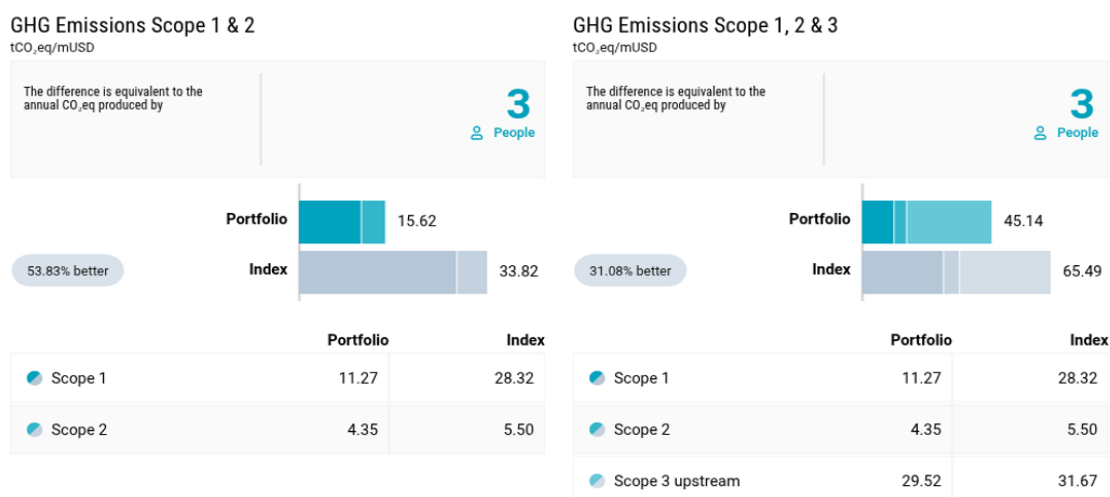
We have high exposures in sectors with high ROIC and FCF generation, and low exposure to very capital-intensive and low-ROIC businesses.

Sustainable investing

The fund aims for a better sustainability profile compared to the benchmark by promoting certain ESG (environmental, social and corporate governance) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation, and by integrating ESG and sustainability risks into the investment process.

Sustainability guides our entire investment approach and ESG is an important part of our investment process, as it improves our understanding of companies' risk/reward profiles. The sustainability criteria and company scores for these criteria are important input factors for our analysis of potential investments. Companies with a high score are more likely to be included in the portfolio. The graph below shows the results for the environmental impact of our portfolio compared to the index. It shows that our holdings have a lower environmental impact in all of the categories.

Carbon footprint expresses the total greenhouse gas (GHG) emission consumption per invested amount for the portfolio. We calculate each company's carbon footprint by dividing the company's total GHG emissions by its enterprise value including cash (EVIC). A company's total GHG emissions can be broken into Scope 1, 2, and 3. Scope 1 represents the direct emissions created by the company's activities. Scope 2 represents the indirect emissions from the production of the electricity or heat used, and Scope 3 represents the indirect emissions from creating products and services (upstream activities) and indirect emissions from the use of the company's products and services (downstream activities). The portfolio's aggregate carbon footprint is calculated as a weighted average by multiplying each assessed portfolio component's carbon footprint figure with its respective position weight. Only holdings mapped as corporates are included in the figures.

If the index is selected, its aggregate carbon footprint is shown besides that of the portfolio, including an indication of the relative performance. A portfolio that have a lower carbon footprint than the index are less resource intensive per invested amount since less carbon intensive performing companies use fewer resources per invested amount.

Outlook

As of late, the AI story has been increasingly questioned, in particular because of all the circular financing going on. However, we don't see conclusive evidence yet that the AI 'bubble' itself has peaked. Though a very strong earnings set from Nvidia did not re-ignite animal spirits, it's too early to start fading a capex cycle which is still moving at breakneck speed. Investors, though, do feel more cautious about Tech, meaning the door for a market broadening has re-opened again. So far, many 2026 forecasts paint rosy pictures for the year to come, again thanks to AI and expected rate cuts. Admittedly, this is becoming a consensus trade too, making it likely more worthwhile to start looking at some of the beaten-down areas. We saw this already paying off in the healthcare sector, where sentiment quickly turned for the positive recently. In a similar vein, lower rates and tax refunds could provide the necessary support to an ailing US consumer, too, providing an interesting setup for the staples and consumer discretionary pockets of the market. In general, when looking at equity basket performance year-to-date, a form of fundamental vacuum has occurred, resulting in unhealthy market dynamics from time to time. This makes the case for a revival of diversification and Quality all the stronger as we move into the new year.
