

Global equities soar to new highs amid strong fundamentals

- Financials and Materials sectors drive market performance
- AI enthusiasm supports broad-based equity gains despite tech pullbacks
- Defensive portfolio with stable stocks at attractive valuation and yield levels

In December 2025, the Global Conservative Equities strategy recorded a return of -0.43%, underperforming the MSCI AC World Index, which declined by -0.15%. This resulted in a negative excess return of -0.28%.

1. Market developments

Global equity markets closed a strong year on an equally strong note, with all major indices reaching fresh all-time highs during the month. Resilient US macroeconomic data, encouraging signs of easing inflation, and a renewed wave of AI enthusiasm—following a brief pause in November—provided broad-based support for equities. The two strongest non-technology sectors of 2025, Financials and Materials, led the pack in December. Financial stocks such as JPMorgan, Visa, and Mastercard delivered solid gains, while Materials names including BHP Group and Newmont also posted robust returns. The "Magnificent Seven" played a more subdued role this time: Nvidia gained 5%, while Alphabet fell 2%, Amazon slipped 1%, and Apple declined 3%. Broadcom dropped 14% after an exceptional year-to-date rally, as investors grew more cautious about its AI-related order backlog.



2. Performance attribution

Last month, our portfolio underperformed the benchmark. The primary contributor to performance was income, while sentiment had a neutral impact. Low-risk was the main detractor, affecting the overall return.

Over the past 12 months, the strategy also showed an overall underperformance. Income and sentiment were both positive contributors, highlighting the strengths of these factors. However, low-risk acted as a significant detractor during this period.

3. Positioning

Robeco QI Global Conservative Equities from an investable universe of around 4,500 stocks, buying securities with low-risk characteristics, such as low volatility, low market sensitivity, and low distress risk. Simultaneously, these low-risk stocks are characterized by attractive valuations, a high and stable dividend, positive price momentum, and favorable analyst revisions.

The fund is characterized by a portfolio of low-risk stocks, offering high and stable dividends and a price-to-earnings ratio lower than the market. A comparison of various characteristics of the portfolio versus those of its benchmark – the MSCI All Country World Index – shows a consistent picture, where the strategy remains well-positioned towards the model factors.

Given these characteristics, we firmly believe the strategy is well-positioned to continue harvesting the model factor premiums in All Country.

Table 6 below shows the current main over- and underweights as a result of our bottom-up stock-selection process.

The portfolio's largest overweight positions were GE Aerospace at 1.34% and Walmart at 1.32%. Conversely, the most underweighted securities included NVIDIA with an active weight of -4.77% and Broadcom at -1.77%.
