

Emerging markets face volatility amid AI stock reversal

- Korea's market experiences sharp declines but rebounds quickly
- Robeco 3D Enhanced Indexing well positioned across its five main factors
- Targeting a long-term information ratio of 0.6

In July 2026, the fund experienced a decline of 3.4%, underperforming the MSCI Emerging Markets Index, which fell by 3.1%. This resulted in an excess return of -0.4% for the month.

1. Market developments

The sharp reversal in AI-related stocks weighed heavily on emerging markets after a record-breaking second quarter for the EM tech sector. Once again, Korea was at the center of the volatility, with the market plunging 33% before recovering roughly half those losses in a single day just before month-end. Index heavyweight SK hynix epitomized the turmoil, losing half its market value during the month before rebounding 26% on the final trading day. By month-end, the Korean market was down 17% in July, although it remains up 81% year to date.

Elsewhere, several trends reversed as this year's laggards, China and Indonesia, emerged as July's strongest-performing markets. Chinese equities were lifted by a sharp rebound in platform stocks such as Alibaba (+26%), Meituan (+35%) and JD.com (+28%), as investors rotated out of AI hardware names into beaten-down internet

stocks. Alibaba also benefited from expectations that it will gain from the growing adoption of Moonshot AI's high-performing, low-cost models.

As market leadership shifted, the momentum factor struggled. That said, the MSCI EM Momentum Index is currently a poor proxy for the factor itself, given its extraordinary concentration in technology (72%) and Korea (48%). High-dividend and value stocks significantly outperformed the broader market during the volatile month.

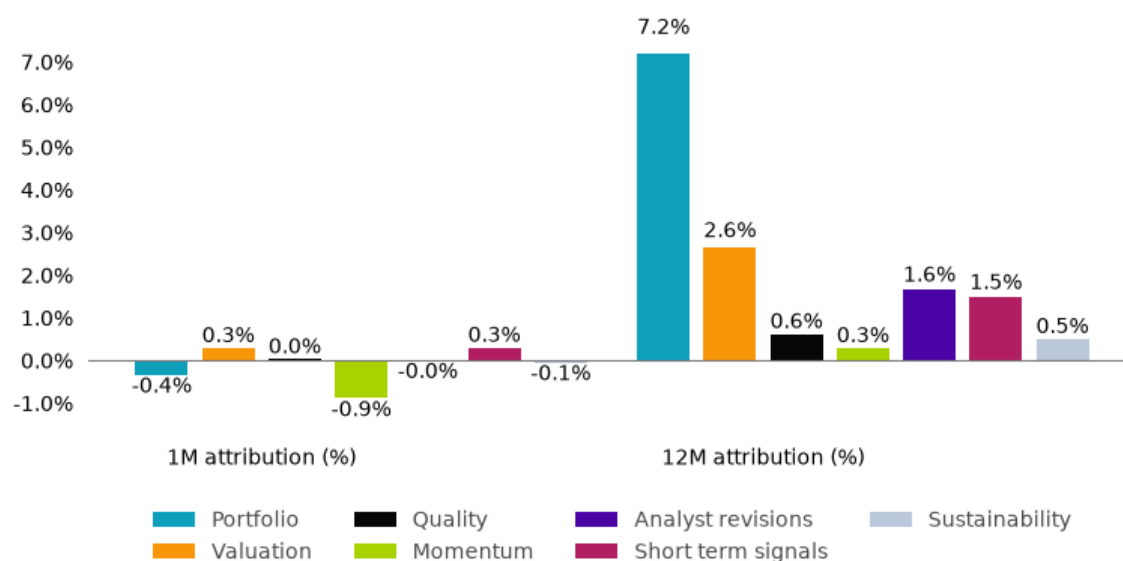

2. Performance attribution

Last month, our portfolio experienced a slight underperformance relative to the benchmark. Momentum was the primary detractor from the fund's relative performance, while short-term signals and valuation contributed positively. Quality, analyst revisions, and sustainability remained neutral.

Over the past 12 months, the strategy has demonstrated solid outperformance. Valuation led the contributions, followed by analyst revisions, short-term signals, quality, sustainability, and momentum, all of which positively impacted the fund's relative performance. This consistent performance across multiple factors highlights the strength of our strategy in navigating the market.

3. Positioning

Stock selection is the main driver of the Enhanced Indexing model. All position deviations from the benchmark are based in the relative attractiveness of these stocks from a multi-factor perspective as compared to their regional/sector peers. The resulting portfolio is well-diversified with small deviations on sector and country levels, as shown in the figure below.

The fund remains well-positioned towards the model factors. A comparison of various characteristics of the portfolio versus those of its benchmark – the MSCI Emerging Markets Index – shows a consistent picture: the portfolio offers a lower valuation and better quality, momentum and revisions.

To illustrate, the current P/E of the fund is 16.0 compared to 17.9 for the MSCI Emerging Markets Index. In terms of quality, the portfolio has a net buyback yield of 0.3%, which is higher than the benchmark's 0.1%. From a momentum perspective, the portfolio's 12-minus-1 month momentum stands at 179.4%, slightly better than the MSCI Emerging Markets Index at 173.6%. Additionally, the portfolio's earnings revisions ratio is 73.7%, compared to 65.7% for the benchmark.

Given these characteristics, we firmly believe the strategy is well-positioned to continue harvesting the model factor premiums.

Table 5 below shows the current main over- and underweights as a result of our bottom-up stock-selection process.

The portfolio's largest overweight positions were in SK Square at 0.78% and Advanced Micro Fabrication Equipment Inc China at 0.44%. Conversely, the most underweighted securities included Taiwan Semiconductor Manufacturing with an active weight of -5.49% and SK hynix at -0.50%.

Robeco 3D EM Equity UCITS ETF invests in, on average, 400 Emerging markets stocks by applying a quantitative investment strategy. The strategy aims to balance risk, return and sustainability in the Sub-fund's portfolio. The Sub-fund's portfolio will be optimised using a quantitative process to target returns in excess of the Benchmark, sustainability characteristics better than the Benchmark, whilst managing risk compared to the Benchmark. The three dimensions of risk, return and sustainability are considered together in the Manager's proprietary portfolio optimization algorithm. The model consists of multiple long-term factors, comprising the valuation factor (measures such as low price to fundamentals), quality factor (that prefer firms with a profitable operating business and a prudent investment policy), momentum and analyst revisions factors. We also include short-term signals factor, based on the following four themes: price reversals, stock flows, short-term sentiment, and ML/NLP signals. This model produces a quantitative ranking considering all of the stocks within the investable universe. The portfolio is rebalanced every month.
