## Last month's performance

The Robeco Afrika fund posted a flat return in June, outperforming its reference index (-0.79%). Developed markets gained 1.5% while emerging markets returned 0.8% over the same period, both measured in EUR terms. African equity markets delivered a mixed picture during the month, with a wide dispersion of nearly 19 percentage points between the best and worst performing focus countries. Tunisia led the way with a strong 13.7% return, followed by Kenya (+12.6%), Mauritius (+8.4%) and Ghana (+8.3%), the latter supported by a meaningful 5.8% appreciation

of the Ghanaian cedi against the euro. Egypt gained 4.9%. Zambia advanced 3.6%, Botswana gained 1.5% and Senegal edged up 0.2%. On the negative side, Morocco declined 2.4%, South Africa lost 4.7% and Nigeria was the weakest performer with a 5.3% loss.

### Africa news flow

#### South Africa: GDP and current account surplus beat expectations

South Africa's GDP growth accelerated from 0.8% in Q4 to 1.9% in Q1, beating the consensus expectation of 1.7%. Growth was driven by higher exports and generally strong agricultural output growth. Positive was also that the current account surplus rose from 0.6% of GDP in Q4 to 2.5% in Q1 and that was better than expected. Monthly indicators were mixed. Mining production surged in April by 8.2% year-on-year, more than the consensus estimate. However, retail sales (+1.3%) and manufacturing production (-2.9%) disappointed in April. Vehicles sales in May rose 12.8%. Inflation rose from 4.0% in April to 4.5% in May. That was less than most economists had projected and together with some decline of the oil price that could mean no further rate hike is needed.

#### Solid GDP readings across the continent and sharp increase of Nigeria current account surplus

Recent GDP releases delivered broadly positive surprises across focus markets. Zambia's economy accelerated sharply to 7.7% year-on-year from 1.6%, while Ghana grew 6.4%, up from 5.8%, prompting the World Bank to upgrade its 2026 growth forecast to 4.8%. Morocco expanded 4.6% versus 4.1% prior. Egypt and the IMF reached a staff-level agreement, paving the way for approximately USD1.6bn in new financing. Mauritius posted economic growth of 2.0%, moderating from 3.1%, and Senegal grew 1.2% quarter-on-quarter, slowing from 3.1%. Nigeria's external accounts improved markedly, with the trade surplus expanding and the current account surplus increasing from USD1.4bn in Q4 to USD5.0bn in Q1 due to higher crude oil export receipts and lower refined oil products imports as the Dangote oil refinery ramped up production.

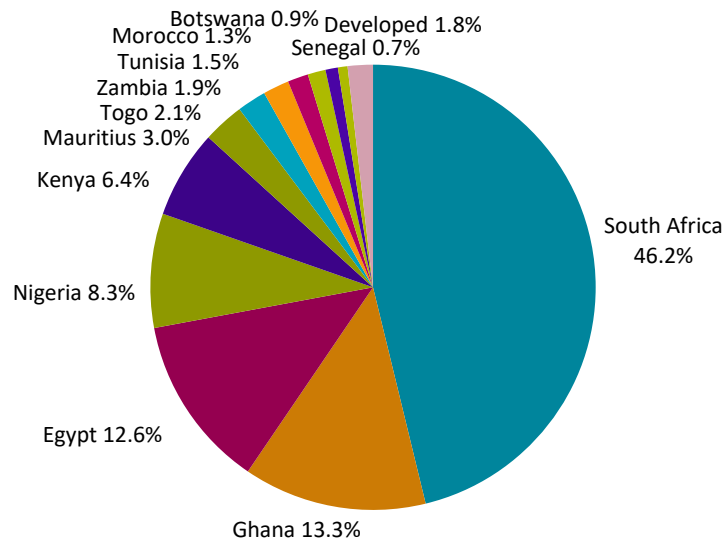
#### Inflation picture mixed

Inflation dynamics remained mixed. Nigeria's inflation edged up to 15.9% in May from 15.7%. In Ghana inflation rose from 3.4% to 3.7% in May, but that was better than expected. Mauritius saw an uptick to 4.3% from 3.6%. In most other markets inflation was flat or came down. Zambia's inflation dipped marginally from 6.6% to 6.5%. Egypt continued its gradual disinflation, with urban inflation easing to 14.6% from 14.9%, while core inflation held steady at 13.8%. Kenya's inflation moderated to 6.4% in June from 6.7%, potentially giving the Central Bank room to consider cutting its interest rate later this year. On the benign end, Morocco's inflation fell to 1.2% from 1.7%, and Senegal remained well anchored at just 1.3%.

### Portfolio changes

During the month of June we had to make some cash for the annual dividend payment. We did that through selling off the position in copper producer Ivanhoe Mines (as the outlook had slightly deteriorated and valuation had become a bit less attractive) and reducing positions in CAL Bank Ghana (ensure position does not get too big), Commercial International Bank Egypt (pro rata selling to maintain Egypt weight stable), Montage Gold (taking profits) and a wide range of South African companies. When we had inflow, we bought a new position in South African hospital operator Netcare (strong earnings revisions and reasonable valuation) and added to Equity Group (cheap Kenyan bank).

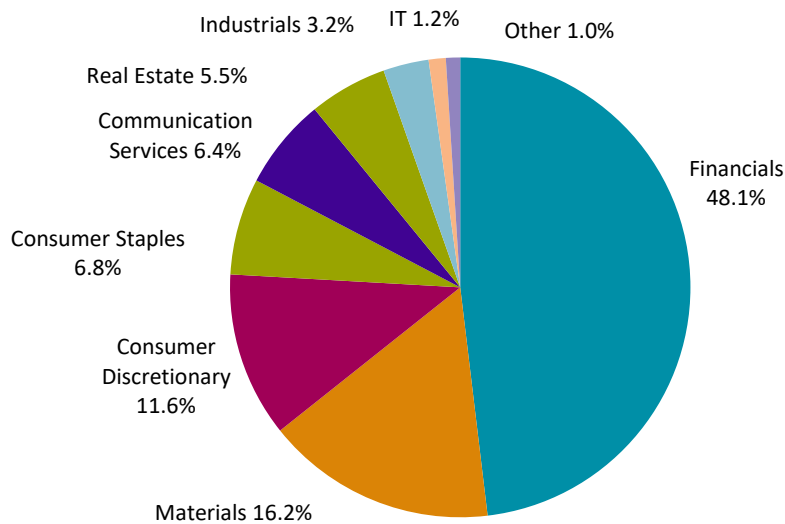
**Country allocation**

- It has around EUR 45 million in assets under management for retail, wholesale and institutional clients.
- Domiciled in the Netherlands, the fund became UCITS-compliant on 28 December 2012.
- Morningstar has awarded the fund four stars for the G-share and four stars for the E-share.

### Investment philosophy and process

We use a two-step process:

- Country allocation: to take advantage of differences in economic, political and social variables between countries.
- Stock selection.

In our stock selection process, we identify mispriced sound business models using the following tools/factors:

- A quantitative screening tool that indicates on which stocks we should focus our research efforts.
- Fundamental strength (market positioning, competitive edge, focus on shareholder value and corporate governance).
- Valuation analysis using a discounted cash flow model for normal companies and an excess cash-based equity model for banks.

ESG factors are included in the decision-making at both macro and company level. At macro level, factors such as transparency, strengthening of democratic institutions, political stability and protection of shareholders are assessed and considered in the positioning of a country in the portfolio. In stock selection, ESG information is integrated in the company analysis and can affect the valuation of a company.
