

Credit resilient amid ongoing Gulf tensions

- Credit markets remained stable despite rates and geopolitical uncertainty
- Outlook remains constructive thanks to strong fundamentals
- Focus on credit selection while targeting a beta close to the index

Credit markets delivered positive excess returns in May, supported by strong demand and well-absorbed primary issuance, while spreads tightened modestly. Despite higher volatility in rates and geopolitical tensions in the Gulf, spread volatility remained low. Credit remained relatively resilient, with stable technicals and continued investor appetite, even as concerns around persistent inflation in the US led to some pressure in global rates markets.

Market Developments

In May, headlines were dominated by developments surrounding the conflict in the Gulf. Early in the month, there were signs of potential progress, with reports suggesting that the US and Iran were close to reaching an agreement. However, by mid-month, the likelihood of escalation increased, as both sides were reportedly involved in attacks. While this led to volatility in rates and oil markets, the impact on credit spreads was more limited, with spread volatility remaining low.

US CPI data came in higher than expected, raising concerns that inflation may prove more persistent, which triggered a sell-off in global rates markets. In the US, 30-year yields rose to approximately 5.20% intra-month. Meanwhile, US five-year yields increased by 14 bps to 4.14%, while German five-year yields declined by 11 bps to 2.64%. Despite these developments, credit markets remained relatively stable in May and delivered positive excess returns. Demand for credit stayed strong, and primary issuance was well absorbed.

Portfolio positioning

The fund is allowed to invest in currencies other than euros, with approximately 7% invested in bonds issued in pound sterling and US dollars, while all foreign currency exposures are hedged.

The fund does not follow an active rating strategy, and the current rating allocation is the result of bottom-up bond selection; it can invest in high yield up to 20%, with current exposure at around 14%.

The fund primarily invests in financials, with excess cash potentially allocated to German government bonds; government-owned banks such as Belfius Bank, Permanent TSB and ASN Bank are classified under agencies, while the exposure to industrials relates to Tier 2 bonds issued by Renault Bank.

The largest part of the portfolio is invested in Tier 2 debt, with about three quarters issued by banks and the remainder by insurance companies; the categories hybrid and subordinated mainly contain subordinated debt issued by insurance companies, Tier 1 exposure primarily relates to bank cocos, and the allocation to senior bonds mainly consists of German Bunds, alongside senior bank bonds issued by institutions such as Triodos Bank and Banca Transilvania.

Performance

The fund generated a positive total return in May. Government bond yields ended the month largely lower, while credit spreads tightened. Spread performance was a positive 31 bps, reflecting a tightening of average index spreads to 116 bps, down from 121 bps the previous month.

The portfolio outperformed the index by 3 bps. The portfolio was overweight beta during the period, which contributed positively to performance through market beta. Issuer selection detracted from performance. Key positive contributors included overweight positions in Bankinter, Ageas and Banco Santander. Overweight positions in Banamex, Rabobank and Barclays detracted from performance.

Year-to-date, the index posted a positive credit return of 0.61% as credit spreads tightened. The euro-hedged total return was 0.98%, as underlying government bond yields decreased. The fund posted an outperformance of 20 bps (1.18% vs. 0.98%) over the current year. Issuer selection delivered a strong positive contribution and beta allocation contributed neutrally. Sector allocation delivered a small positive contribution, mainly due to the overweight in the banking sector and the underweight in the insurance sector. Currency allocation slightly detracted, primarily due to the overweight in USD-denominated paper. Country allocation contributed slightly positively, due to the overweight in Austria, while the overweight in EM detracted somewhat. Allocation to subordination groups detracted somewhat, due to the overweight in subordinated financials. Rating allocation delivered a positive contribution due to the overweight in BBs and the underweight in As..

Outlook

Credit spreads have reached cycle lows, while the financial sector continues to show solid fundamentals. Balance sheets have strengthened after years of deleveraging, and profitability has benefited from higher interest rates, effective cost control, and stable growth in fee income.

Looking ahead, we expect profitability to plateau at a higher level than seen between the global financial crisis and the Covid-19 period, as we do not expect central banks to return to zero interest rate environments, and banks have made meaningful progress in improving their underlying profitability. As a result, the resilience of banks to external shocks has improved. Demand for higher-yielding bonds remains strong, supported by investors seeking to lock in current yield levels.

We are becoming more selective in participating in new bond issues as spreads have tightened. We maintain a neutral beta positioning in the fund, as valuations appear somewhat demanding despite strong fundamentals, and we continue to focus on generating performance through credit selection in both primary and secondary markets.
