Market developments

The winning corners of the market took several hits during July, marking a rollercoaster month that somehow still ended with a shy smile (-0.5% in EUR). After a blockbuster first half of the year, with indices riding the semiconductor boom, July prompted a nagging question: had the AI party gotten ahead of itself? Sharp wobbles across AI names, with chip stocks at the epicenter, were eventually stabilized after a wave of strong earnings results. As the large hyperscalers flagged combined capital spending for 2026 that will likely close in on the USD 800 billion mark, and with 2027 set to easily surpass the USD 1 trillion mark, investors were reassured that the AI infrastructure buildout is not slowing. However, markets are clearly getting pickier, sending out the message that they want to see the returns, not just the vision. Two other clouds are hanging over the party, too. Firstly, rising bond yields, with the US 10-year Treasury yield hitting its highest point since early 2025, are signaling that the Fed needs to hike sooner rather than later. And secondly, a flare-up in geopolitics – again. Renewed spats around the

Strait of Hormuz pushed crude oil prices back toward the USD 90 level. Even so, consumer confidence is bouncing off a bottom, it seems. In short, July was a reminder that markets can turn on a dime – which argues for a comeback of a balanced, diversified portfolio strategy.

Last month's performance

In July 2026, the portfolio returned –1.81% versus –0.55% for the benchmark, resulting in an active return of –1.25%.

Intercontinental Exchange (ICE) was a top contributor, supported by company-specific catalysts tied to its exchange and market infrastructure franchise. Shares benefited from the announced agreement to acquire MarketAxess in a roughly \$6 billion transaction, expanding ICE's footprint in electronic fixed-income trading and data. Broader interest in new trading venues and products also reinforced the value of diversified market-structure platforms.

Micron Technology contributed positively as investors focused on the memory upcycle driven by AI infrastructure buildouts. Surging memory prices supported sentiment around tighter supply-demand conditions, while Micron's exposure to DRAM and high-bandwidth memory remains closely linked to data-center investment trends.

BYD was another meaningful contributor, aided by continued international expansion and localization. The company launched its first Brazilian-made plug-in hybrid flex-fuel model following investment in local production, highlighting its strategy of adapting products to regional requirements while building manufacturing hubs outside China.

Applied Materials was the largest detractor. Despite strength in semiconductors and AI-related capital spending, the stock lagged amid sharp dispersion across chip equipment, with investor focus on near-term order momentum and exposure to the strongest areas of wafer-fab spending weighing on relative performance.

Infineon Technologies also detracted. Although the company forecast strong revenue growth from booming AI demand, the stock lagged more direct data-center beneficiaries and remained sensitive to cyclical end-markets important to European semiconductors.

Solstice Advanced Materials weighed on returns despite earnings above expectations and exposure to AI infrastructure through cooling technologies, as positioning and valuation considerations outweighed supportive fundamentals.

Portfolio construction

The strategy selects global companies whose economic activities can actively mitigate climate change and its impacts. The focus is primarily on developed markets and our investment process is based on bottom-up stock selection. We choose stocks based on high potential free cash flow (FCF) generation, combined with a solid long-term track record for ROIC (return on invested capital). We integrate the most material ESG factors into our fundamental company analysis and we combine fundamental and valuation discipline with strict risk management. In order to optimize risk in a concentrated portfolio, we take positions in companies and scale them according to our conviction level and their contribution to the portfolio's total risk exposure. In other words, the highest-conviction names will be allocated the highest share of our risk budget. This optimizes risk control by taking into account the correlation of the holdings and helps avoid unintended biases in a concentrated portfolio.

Portfolio changes

In July, we bought Broadcom as a key beneficiary of growing AI infrastructure demand, with attractive exposure through its networking and custom semiconductor businesses. We also bought Veralto, whose leading water quality and resource efficiency solutions support more sustainable use of natural resources. We sold Quanta Services following strong share price performance and redeployed capital into opportunities offering a more attractive risk-return profile.

We choose to take a broad approach instead of building a narrow thematic portfolio. As we believe all sectors have a role to play in the transition to net zero, the strategy invests both in companies that facilitate the transition and companies that will need to transition themselves. The portfolio's largest overweights are in Energy (+1.4) and in Industrials and Health Care (each +1.1). The most significant underweights are in Consumer Staples (-2.6) and Information Technology (-1.2), with an additional notable underweight in Consumer Discretionary (-0.8).

Outlook

The engine for the coming period is still AI: capex plans are enormous while earnings keep climbing. But by now, the easy "everyone wins" phase is clearly fading. And leadership is likely to keep broadening beyond Big Tech alone. We've already seen lagging pockets of the market, including financials, healthcare and consumer, staging a comeback as earnings revisions are improving. In general, earnings will need to do more of the heavy lifting going forward. So far, that is indeed the case, with earnings growth currently running at the strongest pace in four years, keeping overall equities afloat. A large swing factor remains the Fed. With the narrative flipping this year from rate cuts to "maybe hikes", as inflation concerns remain and bond yields are turning up, this could mean headwinds for pricey growth stocks and could cap how far valuations might stretch. A tightening Fed does not necessarily mean an end to the bull market, but it can certainly contribute to it. The risk list also includes a longer and harsher continuation of the US-Iran conflict, increasing the likelihood of another oil price spike. The sharp drawdown in July of many AI darlings, mainly driven by technical factors rather than fundamentals, also meant the door for a broader market participation is again firmly open. Hence, staying diversified across size, style and geographies, rather than betting the farm on the AI basket alone, looks the most sensible way to ride a market that can still climb from here.
