

# Emerging markets index surges on semiconductor rally

- Semiconductor stocks drive significant outperformance in April
- Robeco QI EM Enhanced well positioned across its five main factors
- Stable information ratio of >0.8 since inception

In April 2026, the fund achieved a remarkable return of 12.8%, slightly outperforming the MSCI Emerging Markets Index, which posted a return of 12.7%. This resulted in a positive excess return of 0.1%, reflecting the fund's ability to capitalize on favorable market conditions.

## 1. Market developments

The MSCI Emerging Markets Index rose 14.7% in USD terms in April, outperforming the MSCI World Index (+9.6%), driven largely by a powerful rally in semiconductor and related stocks, which increasingly dominate index dynamics. SK Hynix surged 61%, overtaking Alibaba Group and Tencent in index weight to become the third-largest constituent after TSMC and Samsung. MediaTek gained 75% and is now the seventh-largest index holding, just behind Delta Electronics, which rose 57%. Taiwan (+26%) overtook China as the largest country weight in the index, while South Korea (+38%) saw its weight double from 9% to 18% over the past year.

## 2. Performance attribution

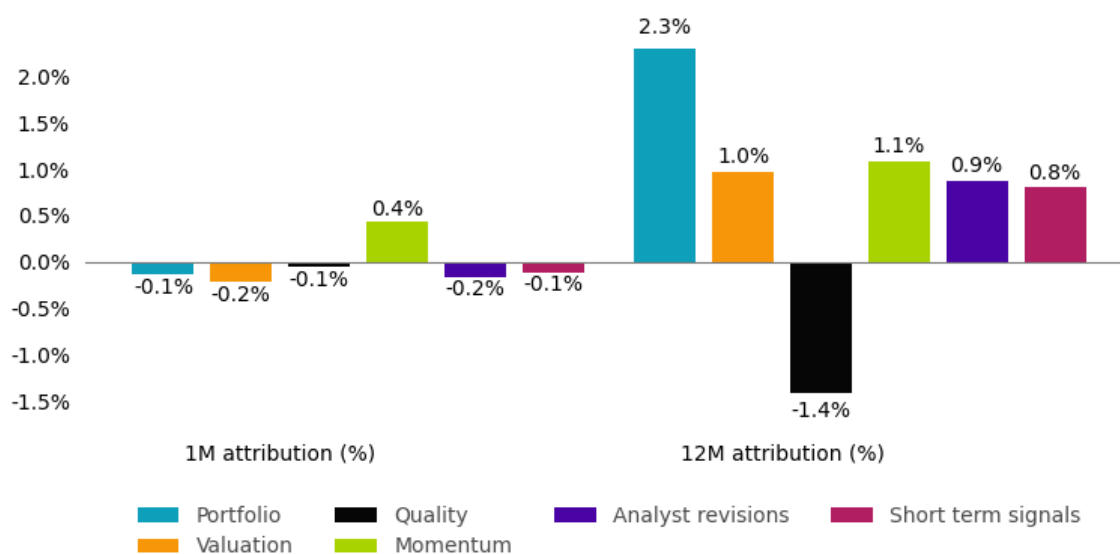
The strategy delivered modest outperformance relative to the MSCI EM index. Gains were supported by overweight positions in Korean and Taiwanese technology names, including Samsung Electro-Mechanics, SK Square, Global Unichip, MediaTek, Delta Electronics, ASPEED Technology and Accton Technology.

The AI-driven rally remained firmly in place throughout April, lifting a broad range of companies positioned as core AI players or key enablers across both markets.

However, performance was held back by overweight positions in Indian IT services names such as HCL Technologies and Infosys, as well as in pharmaceutical companies including Lupin Limited and Sun Pharmaceutical.

Momentum again emerged as the dominant positive factor, while both value and earnings revisions detracted.

Over the past 12 months, the strategy has delivered a positive relative return. Momentum again led the contributions, followed closely by valuation, analyst revisions, and short-term signals, all of which positively impacted performance. Quality, however, detracted from the overall returns during this period.

### 3. Positioning

Stock selection is the main driver of the Enhanced Indexing model. All position deviations from the benchmark are based in the relative attractiveness of these stocks from a multi-factor perspective as compared to their regional/sector peers. The resulting portfolio is well-diversified with small deviations on sector and country levels, as shown in the figure below.

The fund remains well-positioned towards the model factors. A comparison of various characteristics of the portfolio versus those of its benchmark – the MSCI Emerging Markets Index – shows a consistent picture: the portfolio offers a lower valuation and better quality, momentum and revisions.

To illustrate, the current P/E of the fund is 14.1 compared to 15.8 for the MSCI Emerging Markets Index. In terms of quality, the portfolio has a net buyback yield of 0.2%, while the benchmark shows a negative yield of -0.1%. From a momentum perspective, the portfolio's 12-minus-1 month momentum stands at 93.1%, which is higher than the MSCI Emerging Markets Index at 89.0%. Additionally, the portfolio's earnings revisions ratio is 66.5%, exceeding the benchmark's 58.3%.

Given these characteristics, we firmly believe the strategy is well-positioned to continue harvesting the model factor premiums in Emerging Markets.

Table 5 below shows the current main over- and underweights as a result of our bottom-up stock-selection process.

The portfolio's top overweight positions were ASE Technology at 0.23% and Delta Electronics at 0.22%. Conversely, the most underweighted securities included Taiwan Semiconductor Manufacturing at -3.7% and ICICI Bank at -0.31%.

### Robeco Emerging Markets Enhanced Index Equities strategy

Robeco QI Emerging Markets Enhanced Index Equities invests in, on average, 500 emerging markets stocks by applying a quantitative investment strategy. The strategy aims to maximize the excess return versus the benchmark and deliver a superior sustainability profile, within risk constraints. The investment process starts with a factor-based stock selection model. This model consists of multiple long-term factors, comprising the valuation factor (measures such as low price to fundamentals), quality factor (that prefer firms with a profitable operating business and a prudent investment policy), momentum and analyst revisions factors. We also include short-term signals factor, based on the following four themes: price reversals, stock flows, short-term sentiment, and ML/NLP signals. This model produces a quantitative ranking considering all of the stocks within the investable universe. In the second step, the Robeco proprietary portfolio construction algorithm aims to optimize the exposure to the predictive power of the model while adhering to high sustainability standards. The portfolio is rebalanced every month.
