

Volatility rises as AI rally pauses in global markets

- Health Care and Financials show resilience amid market turbulence
- Momentum factor outperforms while Growth stocks lag behind
- Defensive portfolio with stable stocks at attractive valuation and yield levels

In June 2026, the Global Developed Conservative Equities strategy delivered a return of 2.05%, outperforming the MSCI World Index, which returned 1.34%. This resulted in an excess return of 0.71%. The strategy's strong performance highlights its ability to capitalize on favorable market conditions while maintaining a conservative approach.

1. Market developments

Global equity markets turned more volatile in June after several relatively calm months, as the AI rally paused and renewed concerns emerged over the massive capital spending required to sustain it. The Bloomberg Magnificent Seven Index fell 8.8%, with Microsoft (-17%) posting its weakest monthly return since 2000 amid growing investor concerns about both its AI spending and the disruptive impact of AI itself. Outside technology, Health Care was the standout sector, helped by double-digit gains in Johnson & Johnson, Eli Lilly and AbbVie, while Financials also delivered solid returns as heavyweight JPMorgan rose 9%. Momentum was by far the strongest-performing factor during the month, whereas Growth lagged the broader market.

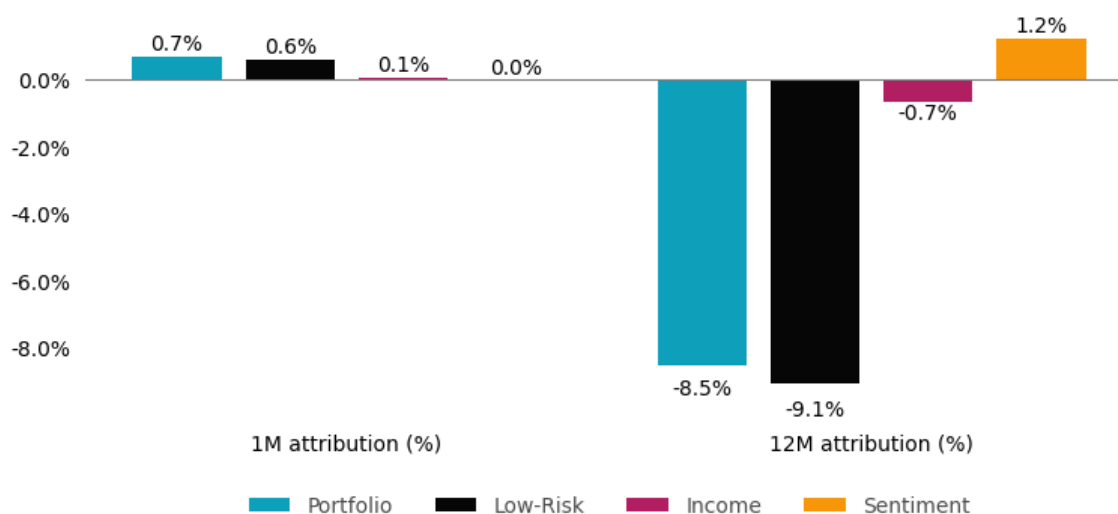

2. Performance attribution

Last month, our portfolio outperformed the benchmark, primarily driven by the positive contribution from low-risk. Income and sentiment had a neutral impact on the overall performance.

However, over the past 12 months, the portfolio experienced an overall underperformance. The largest detractor was low-risk, which significantly impacted the relative return. Sentiment contributed positively, while income acted as a detractor during this period.

3. Positioning

Robeco QI Global Developed Conservative Equities selects from an investable universe of around 4,500 developed market stocks, buying securities with low-risk characteristics, such as low volatility, low market sensitivity, and low distress risk. Simultaneously, these low-risk stocks are characterized by attractive valuations, a high and stable dividend, positive price momentum, and favorable analyst revisions.

The fund is characterized by a portfolio of low-risk stocks, offering high and stable dividends and a price-to-earnings ratio lower than the market. A comparison of various characteristics of the portfolio versus those of its benchmark – the MSCI World Index – shows a consistent picture, where the strategy remains well-positioned towards the model factors.

Given these characteristics, we firmly believe the strategy is well-positioned to continue harvesting the model factor premiums in Developed Markets.

Table 6 below shows the current main over- and underweights as a result of our bottom-up stock-selection process.

The portfolio's most significant overweight positions were AbbVie at 1.13% and TJX Companies at 1.11%. Conversely, the largest underweights included NVIDIA at -2.53% and Broadcom at -2.05%.
